(a) <u>Miss Ruth Carson</u> submitted a letter complaining that vehicular traffic uses her driveway at 391 North Ranelagh Avenue as a turnaround and thereby has created a nuisance to her. In her letter, Miss Carson described the situation in considerable detail and concluded by requesting that action be taken by Council to remedy the condition.

Miss Carson appeared and stated that she had noted an item on the Agenda this evening whereby Council proposes to construct Grosvenor Crescent to connect the northerly ends of Ranelagh Avenue and Grosvenor Avenue.

Miss Carson requested that one corner at the present northerly end of Ranelagh Avenue be widened so as to permit vehicular traffic to make reverse turns, although she added that she had no objection to extending Ranelagh Avenue to Grosvenor Avenue, as is being proposed under the aforementioned item on the Agenda since this would serve to eliminate the necessity for vehicular traffic to make reverse turns at the northerly end of her street.

(b) <u>Mr. Drysdale</u> appeared and thanked Council for the cooperation shown him over the past four years while he has been the Member of Parliament for Burnaby - Richmond. Mr. Drysdale reviewed some of the important events involving the Federal Government and this Municipality which have occurred during his term of office.

He also mentioned that he was in the United Kingdom a short time ago and that, before leaving, he had obtained a pamphlet from the Municipality of Richmond containing information respecting points of interest in that Municipality but that he had not been able to receive a similar type of pamphlet from this Municipality because none is available.

Mr. Drysdale suggested that a brochure should be produced for the purpose of publicizing Burnaby.

(11) Lane at rear of 4740 Rumble Street (Wiens).

The Manager submitted a report embodying a letter from the above noted person complaining of the condition of a lane at the rear of 4740 Rumble Street and also making reference to the traffic channelization arrangement at the Kingsway -Patterson - Grange intersection.

The Manager advised that the lane in question is only a 14 foot allowance and has never been constructed for the purpose of carrying vehicular traffic. He added that it was instead cleared during the course of sewer construction in 1960.

The Manager further reported that this lane and other similar ones are under scrutiny for proper construction and, if surveys confirm that the 14 foot width is sufficient, then consideration will be given to the construction of any such lane but if investigation indicates additional widening is necessary, then this matter will be explored.

With respect to the situation at the Kingsway - Patterson -Grange intersection, the Manager advised that the Municipal Clerk had previously provided Mr. Wiens with an explanation of the reasons for this work and had also made an offer to Mr. Wiens to discuss the geometry of the arrangement with officials of the Engineering Department.

The Manager advised that the explanatory letter which accompanied the formal Notice of Intention on the sidewalk project contained explicit instructions as to what is required in cases where a company owns property affected by the work and, since the three companies involved in the case at hand did not comply with these requirements, the signatures appearing on the petition should not be accepted.
