## JUNE 4, 1962

A Regular meeting of the Municipal Council was held in the Municipal Hall, 4545 East Grandview-Douglas Highway on Monday, June 4, 1962 at 7:30 p.m.

PRESENT:

Reeve Emmott in the Chair; Councillors Edwards, Harper, Hicks, Kalyk, MacSorley and Prittie

ABSENT:

Councillors Blair and Clark

Reverend P. Price led in Opening Prayer.

MOVED BY COUNCILLOR PRITTIE, SECONDED BY COUNCILLOR EDWARDS:

"That Councillor Clark be granted leave of absence from this meeting."

CARRIED UNANIMOUSLY

MOVED BY COUNCILLOR HARPER, SECONDED BY COUNCILLOR HICKS:

"That all of the below listed correspondence be received."

CARRIED UNANIMOUSLY

Terra Nova Development Ltd. submitted a letter conveying its appreciation to Council and Administrative Officials for the manner in which the proposed land reclamation project of the Company was handled.

Secretary, Building Inspectors Association of B. C., wrote expressing appreciation to Council for sponsoring a luncheon at the Seventh Annual Conference of the Association.

Provincial Civil Defence Co-Ordinator submitted a circular letter asking that Council indicate the number of delegates who will be attending the "Provincial Civil Defence Day" at Kamloops, B. C. on September 15, 1962 following the U.B.C.M. Convention.

It was suggested by Council that this matter be brought forward at some date closer to the deadline for filing the form indicating the number of delegates - August 10, 1962.

President, North Burnaby Little League (Eastern Division) wrote requesting permission to have players in the Little League placed at various shopping centres in North Burnaby on June 9th to sell decals for the League.

MOVED BY COUNCILLOR HICKS, SECONDED BY COUNCILLOR EDWARDS:

"That permission be granted to the North Burnaby Little League (Eastern Division) to conduct the Campaign described on the date mentioned in the area outlined."

#### MUNICIPAL MANAGER -- REPORT NO. 30, 1962.

#### (1) Application for Rest Home - Kozak (6411 Roberts Street).

The Manager submitted a report on an application by the above noted for a Welfare Institutions Licence to give personal care, room and board to aged persons at 6411 Roberts Street advising that the Planning Department has no objection to the use of the subject property for Rest Home purposes provided Health, Fire and Building regulations are complied with.

The Manager further advised that the Investigating Committee (Deputy Chief Building Inspector, Chief Sanitary Inspector, and Fire Prevention Officer) has reported that although the building complies with their respective regulations, they noted that two of the applicant's children are sleeping in the unfinished basement.

The Manager pointed out that the Committee was not recommending that the licence application be approved until such time as proper accommodation is provided for the family of the applicant.

MOVED BY COUNCILLOR PRITTIE, SECONDED BY COUNCILLOR KALYK:

"That this matter be tabled for a period of one week at which time a further report be submitted by the Municipal Manager indicating the ages of the two children involved and also whether the basement can be considered and accepted as habitable."

#### (2) Claim - Rutledge.

The Manager submitted a report recommending that a claim of the above noted for damages resulting from a blockage in a Municipal sewer line on the lane at the rear of her property at 7490 Kingsway be settled in the amount of \$198.30, subject to the necessary releases being obtained.

## (3) <u>Civil Defence - Fire and Police Services.</u>

The Municipal Manager submitted a report embodying the contents of Order-in-Council No. 1200, which was passed by the Provincial Government on May 8, 1962 and which deals with the above captioned subject.

### (4) Fire Apparatus.

The Manager submitted a report advising that both the Provincial Fire Marshal and our Fire Chief have strongly urged that a quintuplet similar to the one already owned by the Corporation be procured and stationed at No. 1 Fire Hall. He explained that this type of apparatus comprises an aerial ladder, it carries hose, ground ladders, a booster tank, and is capable of pumping.

The Manager recommended that, in order to ensure good apparatus at a minimum cost, it be built in accordance with Specification B 89.3 of the Canadian Standards Association.

He further reported that specifications have been prepared for the supply of one quintuple fire truck to meet all the requirements laid down by the Canadian Standards Association Specification No. B89.3 plus special considerations required to supplement B89.3, adding that the apparatus would contain:

- (a) A 100 foot aerial ladder
- (b) An 840 I.G.P.M. Class "A" pump
- (c) A nest of ground ladders and roof ladders
- (d) A 150 I.G. Booster Tank; hose and reel
- (e) A hose body.

The Manager also recommended that permission be granted to call for tenders for the supply of one quintuple fire truck.

MOVED BY COUNCILLOR KALYK, SECONDED BY COUNCILLOR BLAIR:

"That the recommendations of the Municipal Manager be adopted."

# (5) <u>Trucking Tenders</u>.

The Manager submitted a tabulation of the tenders received for the supply of trucks for the period between June 1, 1962 and May 31, 1963, as follows:

The Manager pointed out that as a result of interviews with the low tenderer, Mr. Gordon Howard, the Municipal Engineer feels that if Mr. Howard meets the terms of the tender relative to insurance, a performance bond, etc., his Department has no objection to recommending that the contract be awarded to Mr. Howard.

The Manager recommended:

- (a) That the tender of Gordon Howard for hourly rates of \$4.65 for single axle trucks and \$7.65 for tandem axle trucks be accepted
- (b) That until Mr. Howard meets all the terms of the tender call and signs a contract, the Corporation arrange for an over-riding of the current contract with Johnson Trucking to meet the needs of the Corporation during the term of the over-ride.
- (c) That Mr. Howard be given one week to sign a contract, on the failure of which the Corporation approach the second lowest tenderer for a contract.

## (6) Application for Rest Home - Kalt (7488 Government Road).

The Manager submitted a report on an application from the above noted for a Rest Home advising that the Investigating Committee has indicated that the dwelling could be occupied by not more than five persons for the purpose requested provided the following items were complied with:

- (a) A double sink is installed in the kitchen.
- (b) All exit doors open out.
- (c) A fire alarm system is installed to service the ground floor.
- (d) A stair and landing are erected from the den exit at the rear.
- (e) All aged persons are housed on the main floor

and further, that if a septic tank nuisance develops, the licence may be withdrawn.

The Manager also advised that the Committee has drawn attention to the fact that the house is situated in a Residential Type III Single Family zone and surrounding homes are for the most part better class residential. The Manager mentioned that the Planning Department concurs with this comment and expresses concern that the proposed use could devaluate property.

The Manager further reported that the Lozells and District Civic Betterment Association has written protesting the use of the subject building as a Rest Home.

MOVED BY COUNCILLOR HICKS, SECONDED BY COUNCILLOR HARPER:

"That the application of Mr. A. Kalt for a Rest Home at 7468 Government Street be rejected for the reason that the establishment of a Rest Home might tend to devaluate surrounding properties."

#### (12) Smoke Nuisance Complaint - Killip.

The Manager reported that the above noted has written complaining of indiscriminate burning of rubbish by their immediate neighbours and also from other persons in the same area.

He advised that the complaint was investigated on two occasions and that as a result of the second investigation, the permit which had been issued to the offender has been revoked and an order issued that there is to be no further burning in the incinerator which was being used.

The Manager added that the offender was also notified that if a further contravention of burning regulations occurred, he would be liable to prosection.

The Manager also reported that the Fire Department feels the matter is now under control and that no further action is necessary unless a violation of the burning regulations occurs.

#### (17) Verbal Item

Municipal Manager reported verbally on the matter of compensation payable to Mrs. Gray for expropriating portions of Lots 17 and 18, D. L. 135, Plan 3234 reiterating the remarks expressed at the meeting on May 28th.

The Municipal Solicitor elaborated on the proposal that the Corporation offer the sum of \$14,500.00 as settlement in full for taking the lands in question for road purposes.

MOVED BY COUNCILLOR BLAIR, SECONDED BY COUNCILLOR KALYK:

"That an offer of \$14,500.00 as settlement in full be made to the Solicitor for Mrs. Gray for expropriating the lands in question for road purposes."

#### (16) Verbal Item.

Municipal Manager reported verbally on the matter of the legal fees payable by the Corporation to the Legal Firm of Guild, Yule and Company for work performed by the Company in preparing a defense on our behalf against the City of Vancouver in connection with its attempt to use lands owned by the City for Cemetery purposes.

A letter was received from the Company in question elaborating on the work performed by it in regard to the subject matter.

The Municipal Solicitor also provided information as to the services rendered by Guild, Yule and Company on the matter at hand.

It was felt by Council that more positive data as to the criteria on which the fee is based should be furnished.

The Municipal Solicitor was directed to obtain this information for Council.

#### (1) Verbal Item.

Municipal Manager submitted an account from Nemetz, Austin, Christie & Bruk in the amount of \$6,984.50 for services rendered by that firm in connection with 1962 Labour negotiations.

He recommended that this account be paid.

COUNCILLOR PRITTIE LEFT THE MEETING.

Municipal Manager also presented an account from Clark, Wilson, White, Clark & Maguire, in the amount of \$500.00 for services rendered by Mr. R. C. Bray (a member of the firm) as our representative on the Conciliation Board established in connection with a dispute between the Corporation and the Burnaby Firefighters' Association.

He recommended that this account be paid.

MOVED BY COUNCILLOR HARPER, SECONDED BY COUNCILLOR MacSORLEY:

"That both the account from Nemetz, Austin, et al and Clark, Wilson, et al be authorized for payment."
