JANUARY 8, 1962

The 1962 Inaugural Meeting of the Municipal Council was held in the Council Chambers, Municipal Hall, 4545 East Grandview-Douglas Highway on Monday, January 8, 1962 at 8:00 P.M.

Reverend L. D. Ritchie opened the meeting with a Prayer.

Magistrate C. C. Bell officiated at the Swearing-in Ceremonies.

The following took the Oath of Allegiance and were duly sworn in by Magistrate Bell:

Reeve-Elect A. H. Emmott Councillors-Elect Mrs. H. Kalyk, Messrs. Clark, Blair and Harper School Trustees-Elect Mrs. McKee-Wilson and Mr. J. Daly

Reeve A. H. Emmott then delivered his !naugural Address in which he reviewed the progress made by Council during the past year, as follows:

- (a) Continued extensive Local Improvement Paving and Sidewalk Construction;
- (b) Mercury Vapour street lighting;
- (c) Continued storm drainage installations;
- (d) Continued sanitary sewer installations
- (e) Continued extension and renewal of the water distribution system;
- (f) Provision of transit landings and bays:
- (g) Construction of a Branch Library in North Burnaby to replace an old one;
- (h) The addition of two floors to the Municipal Hall;
- (i) The letting of a contract for the reconstruction of the Library Headquarters;
- (j) The letting of a contract for an indoor swimming pool;
- (k) The construction of two major schools
- The passage of the Parks Development By-Law which will thus enable the Municipality to undertake a number of highly desirable recreational improvements;

(m) The widening of portions of Hastings Street.

The Reeve added that, in the field of private endeavour, an event worthy of note was the construction of the Brentwood Shopping Centre.

The Reeve outlined the programme of development, which is proposed for the coming year, as follows:

- (a) A continuation of Local Improvement works;
- (b) A continuation of ornamental street lighting installations;
- (c) A continuation of the trunk sewer and lateral sewer system installations;
- (d) Continued attention to the matter of providing major roads and connecting road links;
- (e) A possible acceleration in the development of Municipal lands;
- (f) The possible purchase of a major piece of fire fighting equipment and discussion on the matter of providing a new Fire Hall;
- (g) A continuation of the Hastings Street widening project;
- (h) The possible construction of a central Cenotaph;
- (i) The completion of the Library Headquarters;
- (j) The completion of the indoor swimming pool;
- (k) The possible provision of an Armoury;
- A start on those projects outlined in the Parks Development By-Law.

The Reeve submitted the following recommendations:

- (1) That the Parks Commission By-Law be amended to formalize the relationship between the Commission and the Municipal Manager.
- (2) That the Chairmanship of the said Commission be restricted to two consecutive terms of one year.
- (3) That Council Representation on the Commission be increased to two members and, in this regard, that Councillors Blair and Harper be appointed to the Commission.
- (4) That the following be appointed to the Parks and Recreation Commission to fill the vacancies created by the retirement of Commissioner D. Herd and the election of Commissioner Blair to Council:

to consider and report on various

Membership - Councillors Edwards
and Hicks

(4) Policy Committee to examine and report on various Policy matters:
Chairman - Reeve Emmott Membership - Full Council

(5) Publicity Committee

to consider ways and means of publicizing the Municipality and its activities:
Chairman - Councillor Edwards
Membership - Councillors Harper and Blair

(6) Public Utilities to deal with matters pertaining to Power, Transportation and Communication:
Chairman - Councillor Hicks Membership - Councillors Kalyk and Clark

(7) Traffic Safety
Committee

to consider and report on matters concerning Traffic Control and Safety:
Chairman - Councillor MacSorley
Membership - Councillors Kalyk and Blair

He further recommended that the following "ad hoc" committees continue their work:

(2) Indoor Swimming Pool
Chairman - Councillor Edwards
Membership - Councillors Hicks
and MacSorley

The Reeve further recommended that the first Regular meeting of Council be held on Monday, January 15, 1962, and on alternate Mondays thereafter. He added that it is also proposed that the Policy Committee meet every Tuesday at 3:30 p.m.

The Reeve concluded his Address by making reference to a recent Amendment to the Assessment Equalization Act which has caused an increase in land assessments throughout the Province. He also set forth his views with respect to the matter of taxation and the responsibilities of all levels of Government in this field.

"That all of the recommendations contained in the Inaugural Address of the Reeve be adopted."

"That the Budget be received and tabled until the meeting to be held January 15, 1962."
