MARCH 8, 1965

A regular meeting of the Municipal Council was held in the Council Chambers, Municipal Hall, 4545 East Grandview-Douglas Highway, on Monday, March 8, 1965, at 7:30 p.m.

PRESENT:

Reeve Emmott in the Chair; Councillors Blair, Cafferky, Corsbie, Dailly, Drummond, Edwards, Herd and Hicks

Reverend W. J. Bishop led in Opening Prayer.

A Public Hearing was held in connection with "Burnaby Highway Exchange By-Law 1965", which provides for an exchange of a portion of a lane allowance in Block 12, D.L. 121, Plan 1024 for land adjacent Lot "B" in the same block.

No one appeared on this proposed exchange.

MOVED BY COUNCILLOR HICKS, SECONDED BY COUNCILLOR BLAIR:
"That the Minutes of the meeting held February 22, 1965 and the
Public Hearing held on March 2, 1965 be adopted as written and confirmed."

Executive Director, Canadian Federation of Mayors and Municipalities, submitted a circular letter drawing attention to the fact that all resolutions intended for the consideration of the 1965 Annual Conference of the Federation must be in his hands by March 30, 1965.

It was understood by Council that any member who wished a resolution presented to the Conference in question would so indicate as soon as possible.

Assistant Secretary, the Imperial Daughters of the Empire and Children of the Empire (Junior Branch) wrote inviting a member of Council and his Wife to attend the Annual Meeting and Dinner of the Order in the Vancouver Heights United Church Hall on March 24th at 6:15 p.m.

It was understood that Councillor Cafferky would attend the function mentioned on behalf of Council.

President, The Burnaby Striders Athletic Club, submitted a copy of a letter addressed to the Minister of Recreation and Conservation for the Province in which it was indicated that the Club supported a proposal to locate a Sports Stadium and Coliseum in this Municipality.

President, Fraser Valley Mosquito Control Board, submitted a circular notice advising that the Annual Meeting of the Board will be held on March 11th at 8:00 p.m. in the Maple Ridge Municipal Hall.

It was understood that Councillor Dailly would ensure that one of the members of Council would attend the meeting in question.

Executive Director, Union of B.C. Municipalities, wrote advising that the Executive of the Union would appreciate Council and others supporting the efforts now being made by School Boards throughout the Province to secure suitable changes in the present school finance formula.

^ letter from Shell Canada Limited, dated February 22nd, was read and it was noted that the Company was seeking \$7,500.00 compensation for the land the Municipality desires for the eventual widening of North Road.

The letter also contained references to the other stipulations established by Council in connection with the rezoning proposal.

During discussion, it was felt that the amount being requested by the Company was disproportionate to the market value of land in the area where the subject property is located.
