NOVEMBER 9, 1965

A regular meeting of the Municipal Council was held in the Council Chambers, Municipal Hall, 1545 East Grandview-Douglas Highway, Burnaby 2, B.C., on Tuesday, November 9, 1965, at 7:30 p.m.

PRESENT:

Reverend J. E. Sitler led in Opening Prayer.

MOVED BY COUNCILLOR EDWARDS, SECONDED BY COUNCILLOR HICKS: "That the Minutes of the meetings held October 4th and 12, 1965, he adopted as written and confirmed."

CARRIED UNANIMOUSLY

Finance Chairman, B.C. Division, Canadian Paraplegic Association, wrote requesting an opportunity to address Council in connection with a grant.

Mr. A. S. Gregson submitted a letter requesting an opportunity to address Council on the question of servicing costs associated with a proposed subdivision of Lot 78, D.L. 35, Plan 27645.

MOVED BY COUNCILLOR HERD, SECONDED BY COUNCILLOR EDWARDS: "That these two delegations be heard."

CARRIED UNANIHOUSLY

Mr. Flinn appeared and presented a Brief outlining the activities of the Canadian Paraplegic Association. He lucidly explained the objects of the Association and its need for a grant. In this latter regard, he asked that Council be kind enough to make a financial contribution of \$500.00 to the Association for the purpose of enabling it to pursue its activities.

During the course of his oral presentation, Mr. Flinn mentioned that the work of the Association is often instrumental in relieving municipalities of welfare costs that would likely be paid paraplegics and quadriplegics who would find difficulty obtaining employment.

MOVED BY COUNCILLOR HERD, SECONDED BY COUNCILLOR CORSBIE:
"That the request of the Association be referred to the Grants Committee
for consideration and recommendation."

CARRIED UNANIMOUSLY

MOVED BY COUNCILLOR CAFFERKY, SECONDED BY COUNCILLOR CORSBIE:
"That the Social Service Administrator be asked to indicate his views on the statement made by Mr. Flinn regarding the municipality being relieved of welfare costs as a result of the work of the Association in order that Council can determine the value of the service being performed by the Association."

CARRIED UNANIHOUSLY

Mr. A. S. Gregson then appeared and advised that, as agent for the owner of Lot 78, D.L. 35, Pian 27645, he applied for approval to subdivide this parcel and received preliminary approval subject to services in the amount of \$23,680.00 being paid. He pointed out that, in subsequent discussions with both the Planning and Engineering Departments, this figure was reduced to \$22,720.00.

Mr. Gregson mentioned that he had examined the Minutes of a Policy Committee meeting on August 17, 1964, in addition to the Subdivision Control By-Law, and had concluded that these documents permit the Approving Officer to exercise some discretion in relaxing servicing costs when application is made to subdivide property.

Mr. Gregson also made reference to certain sections of the Subdivision Control By-Law and the Municipal Act plus excerpts from the aforementioned Policy Committee Minutes and contended that the policies and/or directions emanating from these references should be followed by the responsible representatives of the municipality in dealing with a matter such as the one of concern to him. He further claimed that the action taken by the Policy Committee on August 17, 1964, is not the same as a Council decision and therefore is of no force and effect.

Municipal Manager stated that the degree of servicing required by the Approving Officer when considering subdivision applications was contained in a resolution and not in a by-law of the Corporation.

Mr. Gregson concluded by asking Council to have the Approving Officer follow the provisions of the Subdivision Control By-Law and other pertinent legislation when processing the subject application to subdivide the property described above.

He also pointed out that one of the prerequisites to the subdivision was the piping of the creek which runs through the land. Mr. Gregson suggested that this creek should be left in its natural state in order to leave the property more attractive.

Municipal Clerk explained that the cards were mailed just after the middle of October, as has been the practice for some years. He pointed out that the purpose in mailing these cards is to allow those receiving them to make representations to the Court of Revision for changes in the list of electors for the forthcoming election. The Clerk also stated that this voting card indicates the polling station at which the elector must vote and that this assists people a great deal on election day.

He expressed the comment that it was perhaps unfortunate the Federal Election was held so soon after the voting cards were mailed but that, in future, any possible confliction that could arise as a result of either of the two senior governments holding an election around the time the voting cards are mailed would be recognized and an adjustment made, if possible.

Item 1 of Report No. 76, 1965, of the Municipal Manager, was brought forward.

A letter from the Company applying for the rezoning of the subject property, Fresh Pak Limited, was read.

In this letter, the Company pointed out that since it opened in 1951 at what was then 2812 McKay Avenue, the Company has endeavoured to be good citizens and operate a progressive efficient business. The Company added that its premises were always well maintained and are now frequently viewed by instructors from the Institute of Technology to further the practical training of their students.

Fresh Pak Limited explained that, in 1958 and during the following two years, it searched for other land with suitable facilities because of the need for greater space to accommodate its expanding business. In this regard, the Company mentioned that, in 1960, it chose the present location at 6205 Willingdon Avenue and, in 1963, an addition to the building was made.

The Company pointed out that the property used was then zoned Light Industrial and it felt, because of the rail facilities, that the zoning would remain. It added that, now there is a further need to enlarge its premises, the Company purchased the five lots that are the subject of the rezoning application at hand.

Fresh Pak Limited concluded by requesting that Council approve the rezoning proposal.

Attached to its letter was a publication issued by the Company containing a general explanation of its business operation and an invitation to inspect its premises.

A. and A. Noyes submitted a letter suggesting that, if Council considers the rezoning of the subject properties, their application and others for Multiple Family zoning in the Kathleen-Willingdon area be given precedence because they were made prior to the one from Fresh Pak Limited.

Mr. and Mrs. Noyes also reminded Council of the objections expressed at the Public Hearing on the rezoning proposal.

In order that Council could recall these objections precisely, the petition presented at the Public Hearing, plus the Minutes of the Hearing were read.

It was directed by Council that, before the By-Law at hand is reconsidered, those points relating to implementation of the expansion plans of Fresh Pak Limited to which reference is made in a report from the Planning Department dated October 8, 1965, be resolved to the mutual satisfaction of the Corporation and the Company in such a way as to not detrimentally affect adjacent properties and so as to allow for the ultimate closing of access to Willingdon Avenue.

Patricia M. Fahlman, Barrister and Solicitor, submitted a letter on behalf of Richard and Mary Lee requesting that their property, described as Lot "A" N_2^1 except Plan 16862, Block 8, D.L. 80S, Plan 4954, not be rezoned to Residential Two (R2).

Miss Fahlman pointed out that Mr. and Mrs. Lee wish the present zoning retained until an East-West road is extended to the Eastern boundary of their property, in which case access to it would then be provided. She added that there was absolutely no benefit for Mr. and Mrs. Lee until this road is built and that, in the meantime, the Lees wish the opportunity to conduct their present enterprize on the property in question without it being placed in a non-conforming position.
