# NOVEMBER 7, 1966

An adjourned meeting of the Municipal Council was held in the Council Chambers, Municipal Hall, 4545 East Grandview-Douglas Highway, Burnaby 2, B.C., on Monday, November 7, 1966, at 7:30 p.m.

PRESENT: Reeve Emmott in the Chair; Councillors Blair, Corsbie (7:32 p.m.), Dailly, Drummond, Herd, Hicks and McLean

ADSENT: Councillor Cafferky

MOVED BY COUNCILLOR HICKS, SECONDED BY COUNCILLOR BLAIR: "That the Minutes of the meeting held October 24, 1966, be adopted as written and confirmed."

#### CARRIED UNANIMOUSLY

MOVED BY COUNCILLOR BLAIR, SECONDED BY COUNCILLOR DAILLY: "That the Council now resolve itself into Committee of the Whole."

#### CARRIED UNANIMOUSLY

COUNCILLOR CORSDIE ARRIVED AT THE MEETING.

COUNCILLOR DAILLY spoke and made reference to the unfortunate death of a six-year old boy who fell from the cliff on the North face of Burnaby Mountain on the weekend.

He enquired as to whether, and what, steps were being taken by the Municipality as a result of the incident.

His Worship, Reeve Emmott, advised that both he and the Assistant Municipal Manager had visited the area to inspect the devices which had been provided to protect the public from an incident of the sort which befell the boy.

He indicated that the conclusion was reached that the chain-link fence seemed adequate but the page fence could be improved.

His Worship reported that he had instructed the Assistant Municipal Manager to approach both the Parks and Recreation Commission and Simon Fraser University to implement measures designed to provide proper protection for the public and minimize the danger to it when walking in the subject area.

During the discussion which took place on the subject matter, a suggestion was made in Council that possibly some consideration should be given to providing lighting in the area as an added means of protection.

No direction was issued by Council in view of His Worship's statement that he had instructed the Assistant Municipal Manager in the fashion indicated above.

It was indicated, however, that Council should receive a report indicating the action that is taken as a result of the overtures to the Parks and Recreation Commission and Simon Fraser University.

The following matter was then lifted from the table:

Detector Check Valves

(Item No. 4 of Report No. 63, 1966 of the Municipal Manager, which deals with the above subject, was brought forward.

A copy of this report will be found attached to, and will form part of, these Minutes).

Municipal Engineer recommended verbally that, in addition to that contained in the report before Council this evening, the use of detector check valves be discontinued for those systems having only fire sprinklers without hydrants.

MOVED BY COUNCILLOR CORSBIE, SECONDED BY COUNCILLOR BLAIR: "That:

- (i) on future fire connections which serve fire hydrants or stand-pipes on private property, the installation of detector check valves be required as before;
- (ii) for those systems having only a sprinkler system without hydrants, the use of detector check valves be discontinued."

CARRIED UNANIMOUSLY

HIS WORSHIP, REEVE EMMOTT, drew attention to the death of the late Mr. Murdo Frazer, the Reeve of North Vancouver District.

He mentioned that the obituary for Mr. Frazer indicated that any contributions made in his memory be to the Canadian Cancer Society.

His Worship recommended that Council authorize a contribution of \$100.00 to the Canadian Cancer Society in memory of the late Mr. Murdo Frazer.

MOVED BY COUNCILLOR HERD, SECONDED BY COUNCILLOR CORSBIE: "That the recommendation of the Reeve be adopted."

### (7) <u>Willingdon Avenue and Grange Street</u>

The Council felt that, before the installation described in the report of the Committee could be considered, the following should be ascertained:

- (a) What will be the result in traffic patterns on Willingdon Avenue at Grange Street after the traffic signal is installed on Willingdon Avenue at Moscrop Street? It is expected that this latter installation, coupled with the widening of Willingdon Avenue between Bond Street and Grange Street plus the provision of a left-turn slot for the Southbound traffic movement on Willingdon Avenue at Grange Street, will produce a change in the traffic patterns.
- (b) What is the cost of acquiring the necessary land for the extension of Grange Street Easterly from Sussex Avenue to Nelson Avenue? The view is held that the creation of this Street will allow Eastbound Grange Street traffic to continue past Sussex Avenue until it reaches Nelson Avenue and will thereby not cause the problem which the Traffic Safety Committee anticipates will occur on Sussex Avenue between Grange Street and Kingsway that is described in its report.

MOVED BY COUNCILLOR McLEAN, SECONDED BY COUNCILLOR BLAIR: "That the subject matter of the report from the Traffic Safety Committee be tabled pending submission of answers to the above two questions."

The view was expressed that there is a sufficient volume of traffic on both streets to justify the regular traffic signal remaining operative until 1:00 a.m.

The Municipal Engineer was asked to contact the Department of Highways to determine whether it would be prepared to extend the regular signal phasing at Grandview-Douglas Highway and Willingdon Avenue until 1:00 a.m.

HIS WORSHIP, REEVE EMMOTT, pursuant to the power vested in him under Section 180 of the Municipal Act, returned for reconsideration a decision rendered by Council on October 28th to purchase miscellaneous articles in buildings on the Centennial Project site for the sum of \$3,000.00.

Municipal Manager stated that, since he returned from vacation, he had had an opportunity to examine the subject covered by the Reeve. He explained that one of the representatives of the Universal Life Foundation had expressed deep concern regarding the limitation of \$3,000.00 placed on the purchase of the articles in question. The Manager pointed out that this representative had contended that a commitment had been made by officials of the Corporation to purchase the articles for \$3,500.00

The Manager pointed out that the Universal Life Foundation had originally ~ asked \$6,000.00 for the articles whereas the estimate of the Corporation was \$3,000.00. He added that, when other items (two large kilns) were added to the inventory of articles, the Manager was satisfied that Universal Life Foundation should be paid \$3,500.00 for everything.

The Manager stated he had written to His Worship, Reeve Emmott, as Chairman of the Centennial Committee, and indicated he was prepared to recommend the purchase of the articles plus the two kilns for \$3,500.00. He hastened to add that he was concerned about the option which the Corporation had on the subject property expiring and this accounted for his expeditious action.

The Manager advised that the representatives of the Universal Life Foundation had been given to understand that they had in fact been offered \$3,500.00 for the articles and that this had been duly authorized.

MOVED BY COUNCILLOR BLAIR, SECONDED BY COUNCILLOR HICKS: "That the resolution passed by Council on October 28th respecting the purchase of miscellaneous fixtures and furnishings in buildings on the Centennial Project site for the sum of \$3,000.00 be rescinded and, in its place, authority be granted to purchase these articles for \$3,500.00."

HIS WORSHIP, REEVE EMMOTT, stated that it may be necessary for both he and the Municipal Manager to visit officials of the Canadian National Railways in Ottawa to discus the details in connection with the proposed construction of an overpass on Willingdon Avenue by the Railway Company.

# PART 1

Review of Local Improvement Policy re charges applicable to different classes of property

His Worship, Reeve Emmott, drew attention to the fact that Council, in 1959, had considered whether non-residential properties should be required to pay a greater portion of the cost of Local Improvements than residential properties.

He stated that the Nunicipal Solicitor had indicated Council could not do this because such action would be discriminatory.

The Municipal Manager pointed out that, in presenting a Local Improvement Programme to Council, he only recommends the construction of Local Improvements on streets occupied by industrial and/or commercial properties where the owners have consented to pay for the full frontage of their lots (e.g. Underhill Avenue, Willingdon Avenue, Beta Avenue, and Madison Avenue).

The Manager also mentioned that reference is made in the cost analysis report which accompanies the Local Improvement one to those streets which have properties abutting that have frontages in excess of 66 feet.

HOVED BY COUNCILLOR HERD, SECONDED BY COUNCILLOR CORSBIE: "That no change be made at this time in that part of the Local Improvement policy relating to the levying of charges for Local Improvements against differenct classes of property."
