THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 4669

A BY-LAW to regulate and prohibit the discharge of firearms within the Municipality.

The Council of The Corporation of the District of Burnaby ENACTS as follows:

- 1. This by-law may be cited as "BURNABY FIREARM REGULA-TION BY-LAW 1964".
- (1) This by-law shall be construed subject to the Game
 Act and the regulations thereunder.
- (2) Words used in this by-law shall have the same meaning as in the Game Act and regulations thereunder unless defined in this by-law.
- 3. In this by-law "firearms" includes air guns, air rifles, air pistols and spring guns.
- 4. No person shall discharge firearms within the Municipality.
- 5. (1) Notwithstanding anything contained in section 4 of this by-law --
- (a) any person holding a valid licence issued under the Game Act and the regulations thereunder may, during any period authorized by the said Act and regulations for the purpose of hunting game, discharge firearms in that area of the Municipality more particularly defined as: Commencing at a point on Greenall Avenue 100 yards south of Marine Drive, thence easterly on a line 100 yards south of and parallel to Marine Drive to Royal Oak Avenue, thence south along the road allowance of Royal Oak Avenue to the B. C. Hydro and Power Authority railway right-of-way, thence easterly along the said right-of-way to 10th Avenue, thence southerly along 10th Avenue and Marshaland Avenue to Wiggins Street, thence southerly

along Wiggins Street to the Canadian National Railway right-of-way, thence westerly along the said right-of-Way to the west property line of Lot 2 Except Plan 25676, Blocks "A" and "B", D.L. 167, Plan 18016, thence southerly along the west property line of the said Lot 2 to the North Arm of the Fraser River, thence westerly along the north shore of the said North Arm to Greenall Avenue projected, thence north along Greenall Avenue projected and Greenall Avenue to the point of commencement,

- (b) peace officers acting in the execution of their duties may discharge firearms anywhere in the Municipality,
- (c) any person may discharge firearms on a range approved for that purpose by Council,
- (d) The Officer Commanding, Burnaby Detachment R.C.M. Police, may by permit in writing authorize any person properly licenced and qualified to discharge firearms anywhere in the Municipality for the purpose of destroying animals or birds which may or have become a nuisance.
- (2) Every person authorized by this by-law or by the Game Act and regulations thereunder to discharge firearms shall do so with caution and shall not thereby cause injury or damage to persons or property.
- Every person who violates any of the provisions of this by-law shall be guilty of an offence punishable on summary conviction and liable to a fine not exceeding One Hundred (\$100.00) Dollars or in default of payment to imprisonment for a term not exceeding thirty days.
- By-law No. 4067 is repealed.
