Re: Sanitary Sewers and Storm Drainage Bainbridge Avenue

We are pleased to submit, in accordance with the Amalgamated Construction Association's Construction Tendering Procedures, Sections 6.17 Award of Contract, 6.18 Changes, 6.19 Rebidding (copy herein enclosed) as endorsed by The Royal Architectural Institute of Canada, The Association of Consulting Engineers of Canada, The Canadian Construction Association, The Engineering Institute of Canada as prepared in consultation with The Specification Writers Association of Canada and as presented to the Council of the Corporation of the District of Burnaby at their Council Meeting of September 21, 1970, a revised tender incorporating the changes negotiated between yourself as the owner's authority and myself as the representative for the low tenderer.

We will reduce the footage of manholes in the schedule of quantities from 122 lineal feet to 88 lineal feet to produce a credit to you of seventeen hundred and eleven dollars and ninety cents (\$1,711.90).

It has been agreed that we will reduce the price of the storm lines by eighty cents (\$0.80) over the scheduled length of 1,935 lineal feet to produce a credit to you of fifteen hundred and forty-eight dollars (\$1,548.00).

We will increase the price for the manholes by four dollars and eighty cents (\$4.80) over a revised schedule of quantities of 88 lineal feet to produce a debit to you of four hundred and four dollars and eighty cents (\$404.80).

The net effect of these changes would be to reduce our original tender from forty-eight thousand, eight hundred and thirty-four dollars and twenty-eight cents (\$48,834.28) to a revised tender of forty-five thousand, nine hundred and seventy-nine dollars and eighteen cents (\$45,979.18).

We trust you will find these changes favourable and you will recommend the acceptance of our proposal.
