REMARKS:

The Toronto Dominion Bank at Lougheed & Willingdon was victim of a holdup by three armed men on 18 OCT 71. Our investigators pursued the culprits into a bush area and recovered the loot which was dropped during the chase. The trio made good their escape, but the matter is still being investigated.

Fire, suspected to be arson, caused approximately \$60,000 damage at the New Haven Correctional Institute on 23 OCT 71. Our investigators and Fire Marshal personnel are continuing to investigate this occurrence.

Two charges of Welfare Fraud are worthy of note. One involved \$6,700.50 and the other 32,100.00. Both cases are presently before the Court.
