In your letter of transmittal of the Provisional Budget you reported to Council that application had been made to Victoria for a loan of \$3,992,000 under which is now termed as "Federal - Provincial Special Development Loans Program". This sum is made up of \$2,000,000 for local improvements, \$1,000,000 for storm sewers, \$500,000 for parks, \$351,000 for Winston Avenue construction and \$141,000 for sanitary sewers.

At this point in time we cannot determine whether or not the full sum will be approved or if not approved in full which of the projects will be acceptable.

Irrespective of whether or not local improvements qualify for loans under this program, your Capital Improvement Committee recommends that a local improvement program for 1971 be undertaken. Statements showing the works involved are attached. If they qualify for a loan under the above mentioned program, \$285,000 will come from the storm sewer allocation and \$1,235,200 from the local improvement allocation.

If approval is not forthcoming the money will be borrowed through the Regional District.

In any event so that construction may take place during the good weather of the summer months, it is important that Council give approval to all or part of the program as submitted so that the many administrative tasks of initiating the program may take place. Time is of the essence.

No matter how the projects are to be financed we require approval of the Inspector of Municipalities for the borrowing. We propose deferring request for this approval until after the results of our application for loan under the Federal - Provincial Special Development Loans Program becomes known.

A further program totalling \$764,800 is being readied for submission to Council in the event approval of the full \$2,000,000 is received from Victoria.
