1. Re: Sidewalk Cost Sharing Policy
S.D. Reference #157/70 - Cardinal Drive
Owner: J.W. Hendriks, 3150 Bainbridge Avenue.

The Engineer has been approached by the contractor installing the services for this subdivision (Northurn Construction Ltd.) regarding the Municipality sharing the costs of constructing 5' curb sidewalks in this subdivision rather than curbs and gutters. This is in keeping with the sidewalks that have been installed on the already constructed portion of Cardinal Drive.

The approximate length of sidewalk required is 202' and the Municipality's contribution at the quoted rate of \$1.72 per foot will be \$347.44; however, final payment would be based on actual footage.

This is in accordance with our sidewalk cost sharing policy.

#### RECOMMENDATION:

THAT the Municipality contribute to sharing in the cost of constructing curb sidewalks in accordance with our policy; and THAT the Municipality's share be \$1.72 per foot for the actual footage installed, and for which the total cost is estimated to be \$347.44.
