MOVED BY ALDERMAN LADNER, SECONDED BY ALDERMAN CLARK: "That the Minutes of the meeting held on February I, 1971 be adopted as written and confirmed."

CARRIED UNANIMOUSLY

MOVED BY ALDERMAN CLARK, SECONDED BY ALDERMAN DRUMMOND: "That Alderman Dailly be granted leave of absence from this meeting."

CARRIED UNANIMOUSLY

MAYOR PRITTIE announced that Brotherhood Week was between February 14th and 21, 1971.

He explained the objectives of Brotherhood Week and proclaimed the event for the municipality.

MOVED BY ALDERMAN LADNER, SECONDED BY ALDERMAN MERCIER: "That all of the below listed Original Communications be received."

the 1971 Budget of the Corporation is discussed but, in the

QUESTION AND ANSWER PERIOD

When <u>Alderman Mercier</u> enquired as to what was being done in regard to scheduling meetings to discuss the 1971 Budget, Mayor Prittle replied that:

- (a) Council would be meeting the Library Board tomorrow to discuss its budget.
- (b) It is hoped a meeting with the Parks and Recreation Commission on the matter will be held shortly.
- (c) The Acting Municipal Manager was making arrangements with Department heads for discussions between them and Council on the Budget.

Alderman Mercier stated that he had distributed a report on Data Processing which would be placed on the Agenda for the February 15th meeting for the consideration of Council.

Alderman Emmott enquired as to whether the Parks and Recreation Commission had given any consideration to the use of inflatable covers for outdoor swimming pools.

He mentioned that the P.N.E. was in possession of certain information pertaining to the use of such covers and that this might possibly be of interest to the Commission.

<u>Alderman McLean</u> replied that the Commission had studied the matter but had concluded that, on the basis of information which has been obtained, the type of covering in question would be quite costly.

it was understood by Council that Alderman Emmott would arrange for the Commission to receive the data in the hands of the P.N.E. on the subject of inflatable covers for outdoor swimming pools.

When Alderman McLean enquired as to when a meeting would be held with the Department of Highways on the major highways issue, the Acting Municipal Manager replied that this would be one of the first things to be discussed with the Manager when he returns.

Alderman Drummond served notice that he would be introducing a motion that Council consider the matter of appointing some of its members to investigate the question of whether or not the business tax should be increased.

REPORTS

TRAFFIC SAFETY COMMITTEE submitted reports on the matters listed below as Items (I) to (II) recommending the courses of action indicated for the reasons given:

(I) Lougheed Highway and Keswick Avenue

It was being recommended that no action be taken on a request for a crosswalk at the above location because the present requirement whereby children must walk along the South side of Lougheed Highway to the signalized intersection at Austin Avenue is considered the safest method for those in the area South of Lougheed Highway who travel to and from Cameron School.

(2) Lane Adjacent to Sumas Drive and Parkcrest Park

It was being recommended that no action be taken on a request for additional street lights in the above lane because the existing lighting is adequate in terms of Council policy.

(3) 3000 Block Douglas Road

It was being recommended that no action be taken on proposals advanced by a Coroner's Jury in regard to additional street lighting on Douglas Road and a sidewalk on the East side of the Road because the current street lights are adequate and a sidewalk exists on the West side of the Street.

As regards a recommendation of the Jury that a pedestrian safety programme be introduced into all schools, a joint programme of instruction is being carried out in elementary schools by the R.C.M.P. and teaching staff.

(4) Access Routes to Municipal Rink and C. G. Brown Memorial Swimming Pool

It was being recommended that no action be taken on a request to install speed bumps on the above routes because the Solicitor has indicated that, even with warning signs, a Court could find the municipality responsible for any claims arising from damages attributed to the existence of such bumps.

(5) Capitol Drive and Empire Drive

It was being recommended that no action be taken to reverse stop signs at the above intersection because there is no justification in that there is no traffic problem at the intersection.

The Municipal Engineer will be investigating the intersection again to determine whether advancing the stop line will help alleviate a sight distance problem there.

(6) Right-Turn Lanes

The Municipal Engineer will be submitting a report on the question of the action that should be taken to ensure that right-turn only lanes are used to that specific purpose.

Notwithstanding, the Engineer has arranged for the erection of overhead signs at Willingdon Avenue and Lougheed Highway to clearly indicate that traffic in the curb lane must turn right.

(7) Imperial Street and Sperling Avenue

It was being recommended that no additional controls, such as a traffic signal or four-way stop signs, be provided at the above intersection because it is felt little benefit would accrue.

(8) Gilmore Avenue and Pender Street

It was being recommended that no action be taken to install four-way stop signs at the above intersection, other than to increase the size of the signs in place on Pender Street, because warrants do not exist to justify such action.

(9) Gilmore Avenue and Albert Street

A request was received for an extension of the one-hour parking limit on Gilmore Avenue North of Hastings Street to two hours.

As a result of investigation, it was being recommended that a two hour parking limit between 9:00 a.m. and 6:00 p.m. be instituted on the South side of Albert Street from Gilmore Avenue to a point 200 feet East.

To increase the parking restriction on Gilmore Avenue, as was requested, would only compound the problem of a shortage of parking spaces on the Street.

(10) Moscrop Street and Smith Avenue

It was being recommended that:

- (a) No traffic signal be installed at the above intersection because of the lack of warrants.
- (b) No action be taken to remove a hedge at the South-East corner because circumstances are such that there is not enough evidence to demand the removal.
- (c) A standard advance warning stop sign be installed for the Westbound Moscrop Street traffic approaching Smith Avenue.

(II) Arcola Street and Griffiths Avenue

It was being recommended that, as Griffiths Avenue is proposed as a through route, stop signs be placed on Arcola Street, Balmoral Street and Elwell Street at Griffiths Avenue.

MOVED BY ALDERMAN LADNER, SECONDED BY ALDERMAN BLAIR: "That all of the recommendations of the Committee, except for those under items (4), (5), (7) and (10) of its report, be adopted."

CARRIED UNANIMOUSLY

MOVED BY ALDERMAN MERCIER, SECONDED BY ALDERMAN LADNER: "That the recommendation of the Committee covering Item (4) be adopted."

MUNICIPAL MANAGER submitted Report No. 9, 1971 on the matters listed below as Items (1) to (18) either providing the information shown or recommending the courses of action indicated for the reasons given:

(1) Temporary Financing

It was being recommended that Council approve the borrowing of approximately seven million dollars during the period between March 15th and June 15, 1971 to meet current operating needs by passing Burnaby Temporary Borrowing By-law 1971.

MOVED BY ALDERMAN MERCIER, SECONDED BY ALDERMAN BLAIR: "That the report of the Manager be received."

CARRIED UNANIMOUSLY

(2) Proposed Amendments to Zoning By-law involving Residential Development

The Planning Department has submitted a report on the captioned matter.

MOVED BY ALDERMAN MERCIER, SECONDED BY ALDERMAN LADNER:
"That the report of the Planning Department be referred to the
Advisory Planning Commission for comment."

CARRIED UNANIMOUSLY

(3) Burnaby Horsemen's Association

As Council is aware, the above Association leases a barn and part of the site on which the Central Headquarters Fire Hall is located.

The Fire Hall, which is located at Canada Way and Sperling Avenue, will soon become operational and therefore emergency vehicles sounding sirens will be using the premises frequently.

This noise from the sirens may cause the horses on the property occupied by the Association to panic when the sirens sound and perhaps inflict injury to both the animals and their riders or anyone else in the area.

It was being recommended that the Association be given an appropriate warning and that the Corporation disclaim any responsibility for any injury or damage that may occur in the event the horses act in the manner indicated above as a result of emergency vehicles from the Fire Hall operating to and from the site.

MOVED BY ALDERMAN CLARK, SECONDED BY ALDERMAN MERCIER: "That the recommendation of the Manager be adopted."

CARRIED UNANIMOUSLY

(4) Servicing of Municipal Subdivision in D.L. 86

Tenders were invited for engineering, designing & the installation of all services (including underground electric power and telephone distribution systems) to the above area, except for inspection fees, the cost of materials required by the B. C. Hydro and Power Authority for the underground electric power distribution and double gas mains.

The bidders were asked to submit quotations for the removal of debris from the site and for the burning of this debris on the site.

The low tender, based on burning on the site, was submitted by H. J. Rai Limited, while the low tender the removal of the debris was submitted by Jack Cewe Limited.

The Fire Chief will not issue a special permit for the burning of debris on the site.

It was therefore being recommended that the tender of Jack Cewe Limited, which amount to \$160,904.18, for the provision of the services in question be accepted on the basis that debris will be cleared from the locations to be served.

MOVED BY ALDERMAN McLEAN, SECONDED BY ALDERMAN MERCIER: "That the recommendation of the Manager be adopted."

CARRIED UNANIMOUSLY

A brief discussion took place regarding the practice of the municipality constructing concrete sidewalks, without the provision of driveways, adjacent to land on which there are no homes.

Municipal Engineer explained that experience has shown that trying to anticipate where crossings will be required when homes are built on the properties has not proven very accurate in a lot of cases, with the result it becomes necessary to reconstruct a crossing at the time homes are to be built on the lots.

Alderman Emmott suggested that possibly signs could be erected by the municipality where sidewalks are built without provision for crossings advising why they are being constructed that way because this would minimize the criticism that is often leveled at the municipality for having to return to areas where sidewalks were built to reconstruct portions of them to accommodate driveways.

The Council was given to understand that the Municipal Engineer would take this proposal under advisement.

As a result of Alderman Blair enquiring as to whether there are any areas in the municipality where the Fire Chief would be prepared to permit the outdoor burning of stumps and similar debris, it was understood that the Chief would furnish Alderman Blair with an indication of the areas where the Chief feels such burning could be allowed.

- (5) Easement Lot 78, D.L. 35, Plan 37645 SUBDIVISION REFERENCE NO. 169/70
- It was being recommended that Council authorize the:
 - (a) acquisition of an easement over the above described property, for drainage purposes, at no cost to the Corporation in order to finalize a subdivision.
 - (b) execution of the documents attending the matter.

MOVED BY ALDERMAN LADNER, SECONDED BY ALDERMAN MERCIER: "That the recommendations of the Manager be adopted."

CARRIED UNANIMOUSLY

(6) Lease - Blocks 4 to 7 inclusive, D.L. 212, Plan 3080 (Bestwood Industries Limited)

The Parks and Recreation Commission has indicated that it still wishes to use the above property for park purposes and has instructed its staff to begin work on development plans.

The Commission is also of the opinion that the lease enjoyed by Bestwood Industries for the property should not be renewed after December 31, 1974.

Alderman McLean stated that members of the Parks and Recreation Commission were going to inspect the subject site to determine first hand its development potential.

A suggestion was made in Council that Bestwood Industries Limited should be provided with an indication as to when the Parks and Recreation Commission wishes to develop the site so that the Company can prepare for its removal in a planned manner. The view was expressed that, if the Commission did not require the site until some time after Devember 31, 1974, the property could be leased on an annual basis until the site was actually needed for park development.

MOVED BY ALDERMAN MERCIER, SECONDED BY ALDERMAN LADNER:
"That further consideration of the question of Bestwood Industries
Limited continuing its occupancy of Blocks 4 to 7 inclusive, D.L.
212, Plan 3083 after December 31, 1974 be deferred until the
Parks and Recreation Commission reports its conclusions:

(a) Following the inspection that is to be made of the site by the Commission. (b) On the matter of determining precisely when the site will be required for park development, as more particularly explained above."

Contracts must be let by October 1st this year and the last claims by the municipality must be in the hands of the Federal Authorities in sufficient time to be honoured by March 31, 1972.

The works must be additional to what has been previously contemplated or planned through to the end of March, 1972, and are to lead to the rapid creation of additional jobs. Accelerated construction of projects already planned or under way may be eligible, providing such acceleration creates substantial employment in 1971.

The Parks and Recreation Commission is currently developing a submission for Council dealing with the projects it wishes to undertake from the allocation of \$500,000.00 that Council has specified for parks development.

It was being recommended that the Municipal Treasurer be designated as the signing officer for the submission of applications for funds from the subject programme with which to undertake the following classes of projects, and that he also be instructed to forward the applications as soon as sufficient engineering data becomes available:
