He pointed out that an agreement between the Company and the municipality provides for the termination of occupancy by Inter-City Trucking six months after the conveyance is registered.

The following is the substance of that report from the Manager:

(18) Ledger Avenue (Olsen)

The Planning Department has reported as follows **on** the letter from Mrs. Olsen;

- (a) Three unsuccessful attempts were made by the Planning Department to contact Mrs. Olsen before her letter was received.
- (b) Her property is located on the West side of Ledger Avenue near the Freeway.
- (c) The enclave in which her property is located is slated for Administration.^{Office} and Assembly use and forms a part of the Central Complex which extends from Deer Lake to the Freeway. As the intensity of use in this area increases and the overall road pattern is subsequently altered to reflect the long-term objectives of Council, a road connection will become necessary between Ledger and Norland Avenues. This link will be provided as the overall character of the area changes and traffic dictates the need for the facility.
- (d) As the use of the land for office purposes involves the displacement of the existing residential uses and can only take place after the dwellings are removed and since the increased use of the land for the same purposes dictates the need for the road, the road will be built only when a substantial portion of the area is committed for non-residential uses. The only effect of the road on the adjoining residents will be an interim one during the transition period when only a few dwellings remain.

It was recommended that a copy of the above report be sent to Mrs. Olsen.

MOVED BY ALDERMAN LADNER, SECONDED BY ALDERMAN BLAIR: "That the recommendation of the Manager be adopted."

ALDERMAN DAILLY RETURNED TO THE MEETING.

ALDERMAN CLARK ARRIVED AT THE MEETING.

The following is the substance of that report from the Manager:

(19) Parcel "B", Ref. Pian 17411, Bik. 12, D.L. 10, Pian 3054 (8720 Government Road - Love)

The Planning Department has reported as follows on the matter concerning Mr. and Mrs. Love:

- (a) The parcel in question has been involved in a number of recent actions by the Parks and Recreation Commission, the Burnaby Lake Development Committee and the Council.
- (b) Members of the Commission and municipal staff toured the property with Mr. Love on March 23, 1972 with a view to assessing its suitability for park development. The Parcel was subsequently proposed as part of the Central Valley Park System in the area surrounding Burnaby Lake.
- (c) The Burnaby Lake Development Committee approved the overall boundaries proposed for the park system, which included Parcel "B", on March 29, 1972. These park boundaries were approved by Council on April 24, 1972.
- (d) This was followed by the submission of a draft Park Acquisition Programme to the Parks and Recreation Commission in which-Parcel "B" was given a category "B" designation within the proposed first priority programme. The Capital Committee of the Commission reviewed the draft and recommended certain changes, which included the advancing of Parcel "B" to Category "A", the highest group in the scheduling of park land acquisitions.

(f) The Land Department approached Mr. Love to open negotiations for the purchase of his property in August, 1972.

MOVED BY ALDERMAN LADNER, SECONDED BY ALDERMAN BLAIR: "That the report of the Manager be received and a copy of it be sent to Mr. and Mrs. Love."

- (a) What cost-sharing arrangement could be expected from the Provincial Government if the proposal embodied by the resolution is implemented.
- (b) Where community care facilities are most needed in the municipality. "

MOTION LOST

MOVED BY ALDERMAN LADNER, SECONDED BY ALDERMAN BLAIR: "That the Motion advanced above by Alderman Dowding be amended by changing the Resolution to read "That the Provincial Government be approached for financial assistance to allow municipalities to provide and operate community care facilities on a 24-hour basis."

CARRIED

AGAINST -- ALDERMAN CLARK

A vote was then taken on the Original Motion, as amended, and it was Carried with Alderman Clark against.

MOVED BY ALDERMAN LADNER, SECONDED BY ALDERMAN BLAIR: "That the Municipal Manager submit a report to Council indicating the need for, and cost of, community care facilities in the municipality."

CARRIED UNANIMOUSLY

<u>Acting Mayor Constable</u> recommended that Alderman Drummond be appointed as Chairman of the Special Committee investigating procedures relating to contracts for various road works, and that Acting Mayor Constable be appointed as a member in place of Mayor Prittie. MOVED BY ALDERMAN BLAIR, SECONDED BY ALDERMAN LADNER: "That the recommendation of the Acting Mayor be adopted."

CARRIED UNANIMOUSLY

ENQUIRIES

As a result of <u>Acting Mayor Constable</u> enquiring about the level crossings of the railroad on Douglas Road and on Sperling Avenue, the Municipal Engieeer stated that some problem was being encountered in obtaining material required to repair the crossings.

<u>Alderman Dailly</u> drew attention to the latest news letter of the Greater Vancouver Regional District in which the Stratford Gardens Project in Burnaby was shown.

MOVED BY ALDERMAN LADNER, SECONDED BY ALDERMAN CLARK: "That the Council now resolve itself into a Committee of the Whole."

MUNICIPAL CLERK submitted Certificates of Sufficiency covering the construction and paving of the lanes:

(1) Xerox Machine - Clerk's Office

It was recommended that Council authorize the relocation of the Xerox Machine in the Clerk's Office to the space which is adjacent to the Council Loungeand Council Office area, as shown more particularly on an attached sketch.

The cost of moving the Machine, and doing other things mentioned in the report, will be approximately \$400.00.

MOVED BY ALDERMAN CLARK, SECONDED BY ALDERMAN DAILLY: "That the recommendation of the Manager be adopted."

CARRIED UNANIMOUSLY

(2) Kingsway - Barker - Grange Area (Farrington)

Both the Traffic Safety Committee and the Planning Department reviewed the matter mentioned by Mr. T. Farrington in a letter he submitteed to Council on May 8, 1972 concerning the construction of a high-rise complex at the captioned location and the effect this would have on pedestrian traffic.

They advised that the pedestrian plaza concept in the area will establish the necessary future pedestrian separation and freedom from the automobile, and is envisioned to eventually link both sides of Kingsway on the separate level. The Planning Department believes the initial project could extend into a high density town centre development which will meet Mr. Farrington's expectations that Kingsway will be one of the greatest business sections in the Lower Mainland.

The Planning Department believes the apprehensions expressed by Mr. Farrington will be allayed. Should Mr. Farrington need more details about landscaping materials or any other aspect of the development, he can view the complete set of plans which are on file in the Building Department. A schematic sketch showing the general site layout of buildings, the pedestrian plaza level as related to the street, curb locations and landscape plans, is too large to be attached to the report now at hand but could be made available to Mr. Farrington if Council wishes.

It was recommended that a copy of the foregoing report and accompanying schematic sketch be sent to Mr. Farrington.

MOVED BY ALDERMAN DRUMMOND, SECONDED BY ALDERMAN DAILLY: "That the recommendation of the Manager be adopted."

CARRIED UNANIMOUSLY

(3) North side of Sanders Street from Royal Oak Avenue to Marlborough Avenue

The Burnaby School Board has requested that a sidewalk be built at the above location.

Such a facility would be 700 feet long and $5\frac{1}{2}$ feet wide, and would abut the curb. The estimated cost is \$4,900.00 and this sum would need to be appropriated from the Capital Budget Roads Contingency Account, since the only benefitting property owner is the School Board.

Because the sidewalk would primarily serve School Board property, the municipality would require the Board to perform all boulevard reseeding and maintenance tasks at its own expense. The Board may wish to fund and construct its own retaining wall since the back slope would be steeply graded and therefore difficult to maintain.

it was recommended that:

- (a) The sidewalk requested be built.
- (b) The cost of it be charged against the Capital Budget Roads Contingency Account.
- (c) The School Board be required to assume total financial responsibility for boulevard reseeding and maintenance tasks, and a retaining wall if required.

MOVED BY ALDERMAN DOWDING, SECONDED BY ALDERMAN DAILLY: "That the recommendations of the Manager be adopted."

CARRIED UNANIMOUSLY

(4) Easement - Lot 7, Blk. 4, D.L. 91, Plan 17673 (7645 Elwell Street - McDonald)

It was recommended that Council authorize the acquisition of a ten foot wide easement over a portion of the above described property, which is required for a storm sewer connection to 7631 Eiwell Street, for a consideration of \$1.00 and agree to pay the cost of restoring the fence and lawn which will be disturbed by the installation.

(5) Lot "A", Block 36, D.L. 121, Plan 18623 (1045/47 Willingdon Avenue - Hurd)

It was recommended that Council authorize the acquisition of the 12.5 square foot truncation at the South-East corner of the above described property shown on an attached sketch, which is required for the construction of a sidewalk at the intersection of Parker Street and Willingdon Avenue, for a consideration of \$1.00 and agree to pay the cost of relocating existing plant material there.

MOVED BY ALDERMAN CLARK, SECONDED BY ALDERMAN DRUMMOND: "That the recommendations of the Manager covering items (4) and (5) be adopted."

CARRIED UNANIMOUSLY

(6) Lane East of Gamma Avenue between Penzance and Bessborough Drives

To construct the above lane, which is what a number of persons requested of Council on March 20, 1972, would cost approximately \$18,000.00 and would involve difficult clearing and construction problems.

The lane has a grade of 6 to 7%. During periods of snow, it is not the policy to clear lanes.

If the lane was extended, municipal land which is designated for park development would be required for a switchback for the lane to minimize the gradient.

In view of the foregoing, it was recommended that:

- (a) The lane East of Gamma Avenue not be opened and connected with Penzance Drive.
- (b) The petitioners be so advised.

MOVED BY ALDERMAN LADNER, SECONDED BY ALDERMAN BLAIR: "That the recommendations of the Manager be adopted."

CARRIED UNANIMOUSLY

(7) Nos. I and 2 Supplementary Business Tax Assessment Rolls (1972)

The above Assessment Rolls were being submitted herewith for the Information of Council.

MOVED BY ALDERMAN LADNER, SECONDED BY ALDERMAN CLARK: "That the report of the Manager be received."

CARRIED UNANIMOUSLY

(8) Lougheed Highway and Holdom Avenue

The Department of Highways has advised that a traffic light will not be installed at the above intersection until the Spring of 1973 because of a heavy backlog of work.

MOVED BY ALDERMAN DOWDING, SECONDED BY ALDEMAAN LADNER: "That the report of the Manager be received."

CARRIED UNANIMOUSLY

(9) Kingsway and Sperling Avenue

The Engineering Department has placed "Parallel Parking Only" signs at the North-East corner of Kingsway and Sperling Avenue.

The long-term solution to the parking problem there is to construct a finished road with curbs and/or sidewalks that would effectively preclude all hazardous right angle parking in the area. The earliest this could occur would be 1974.

The Municipal Engineer was directed by Council to ensure that the police know the signs which and the subject of the above report are in place and intregulation thereon is to be enforced.

MOVED BY ALDERMAN LADNER, SECONDED BY ALDERMAN DOWDING: "That the report of the Manager be received."

(10) Protection from Excavations

The Municipal Engineer has instituted the following policy in regard to protecting the public from excavations:

- (a) All contractors are being advised to take whatever action is deemed necessary to see that the protection of excavations is above criticism and that the responsibility for such protection is clearly that of the contractor.
- (b) Municipal inspectors will follow up whenever it comes to their attention that excavations could be better protected.
- (c) General Conditions relating to the protection of the public now contain a provision for the inclusion of fencing around an excavation.
- (d) A General Information Sheet has been prepared and is included with all contracts. This Sheet points out certain prime areas of concern and a general comment will be added concerning protection of excavations.

MOVED BY ALDERMAN CLARK, SECONDED BY ALDERMAN LADNER: "That the report of the Manager be received."

CARRIED UNANIMOUSLY

(11) Allowances (Section 411 of the Municipal Act)

It was recommended that the applications for rebates of percentage addition charges shown on an attachment be approved.

MOVED BY ALDERMAN LADNER, SECONDED BY ALDERMAN CLARK: "That the recommendation of the Manager be adopted."

CARRIED UNANIMOUSLY

(12) <u>S.P.C.A.</u>

Two additional S.P.C.A. Inspectors have been hired, which increases the total to six. These new employees will have completed their training by October 15, 1972. Patrol and investigation by them will have been expanded to the extended hours provided under the new Contract with the S.P.C.A.

A fifth permanent vehicle has been ordered and a temporary one that is presently in use will remain in operation until the permanent vehicle is delivered.

The Pound is expected to operate from summer to winter hours during the latter part of October. The exact date of conversion will be determined by prevailing weather conditions and the level of canine activity which is observed throughout the municipality.

MOVED BY ALDERMAN DOWDING, SECONDED BY ALDERMAN DRUMMOND: "That the report of the Manager be received."

(13) Easements - Lots 97 and 98, D.L. 42, SUBDIVISION REFERENCE NO. 44/71

It was recommended that Council authorize the:

- (a) acquisition of easements, for sewerage and drainage purposes, over portions of the above described properties at no cost to the Corporation;
- (b) execution of the documents relating to the matter.

MOVED BY ALDERMAN LADNER, SECONDED BY ALDERMAN CLARK: "That the recommendations of the Manager be adopted."

CARRIED UNANIMOUSLY

(14) Contract #16 - Asphaltic Concrete Supply

The above Contract allowed for the addition or deletion of streets and lanes. The Contract was designed in the initial instance to provide a one-year supply of the required material on streets and lanes, some of which were specifically known at the time of the tender call and others were not because there is no way of knowing how many lanes would be approved by the abutting property owners.

The Engineer considered the feasibility of removing the first three projects from the then current contract with Columbia Bitulithic and decided that better prices would prevail under the new contract. By removing them from the other contract and adding them to the new one, the municipality saved approximately \$11,800.00.

A copy of a report relating to Contract No. 16 with J. Cewe Ltd. was being supplied herewith.

It was recommended that Council ratify the action taken by the Municipal Engineer, as detailed above.

MOVED BY ALDERMAN LADNER, SECONDED BY ALDERMAN BLAIR: "That the recommendation of the Manager be adopted."

CARRIED UNANIMOUSLY

(15) Estimates

It was recommended that the Special Estimates of Work of the Municipal Engineer, which total \$21,460.00, be approved.

MOVED BY ALDERMAN CLARK, SECONDED BY ALDERMAN LADNER: "That the recommendation of the Manager be adopted."

CARRIED UNANIMOUSLY

(16) <u>Street Exchange - Sussex Avenue and Bond Street</u>

The Planning Department has received an application to subdivide Lot 44 $N_{\rm 2}^1$, D.L. 33, Plan 944, which is located at the South-West corner of Bond Street and Sussex Avenue.

It is neither desirable nor essential that Sussex Avenue be constructed from Bond Street to Buxton Street so it was therefore being proposed that the Southerly portion of Sussex Avenue be closed. Pedestrian access and services will be protected by retaining the Easterly 20 feet of the allowance. All servicing costs will be obtained as a part of the subdivision application.

It was recommended that Council authorize the preparation of a Street Exchange By-law to achieve the foregoing.

MOVED BY ALDERMAN CLARK, SECONDED BY ALDERMAN DOWDING: "That the recommendation of the Manager be adopted."

(17) Lot 2, Except Parcel "A", Expl. Pl. 10015, Block 1E¹/₂, D.L. 162, Plan 5452

It was alleged, at the Public Hearing on September 26th in connection with the land use proposals for the Big Bend Area, that the above described municipal property was in an unsightly condition.

The Planning Department made a field check and feels the claim was unfounded. The Sanitation Department has been asked for a more qualified opinion on the situation. The property, which encompasses some 8.7 acres, is largely filled with hog fuel material which has been levelled over the major portion of the parcel. Except for the presence of an abandoned lorry box and an automobile bood directly behind the hog fuel, the property is free from any accumulation of discarded materials or other rubbish.

The property immediately to the East is, however, in a different condition. It is possible that the allegation was really directed to that property.

It was recommended that:

- (a) The municipality arrange for the removal of the two abandoned items from its property that are mentioned above.
- (b) The Sanitation Department inspect the property immediately to the East of the municipal property to determine whether it conforms to the Unsightly Premises By-law.
- (c) The person who complained at the Public Hearing, Mr. L. J. Sigurdson, be sent a copy of the report at hand.
