12. Re: Canada Summer Games
Contract for Architectural Services
Burnaby Lake Public Facility

In Item 11, Report No. 21, March 27, 1972, the Municipal Manager advised that the firm of Carlberg Jackson Partners had been engaged by the Society to act as the prime consultant on the Burnaby Lake Facilities project.

The <u>attached</u> letter dated March 27, 1972, from the Architect addressed to the Municipal Manager outlines the arrangements that have been made for the provision of the services required.

In order to have material to use in future presentations for additional funds for this facility, and in order to ensure proper planning for the ultimate development, it will be necessary to do some overall planning prior to the development of working drawings for the first stage of the facility which is the minimum required for the Games. The Architect has asked for a \$2,000.00 flat fee for his services to prepare line drawings and sketches showing area layout for the ultimate or conceptual overall plan of the recreational and competitive rowing and canoeing facility at Burnaby Lake.

The Management Committee of the Canada Summer Games Society, at its meeting of March 30, 1972, authorized this \$2,000.00 expenditure as part of the architectural agreement that will be executed by the Society in due course. This work will be charged against the budget for the Facility.

The Architect advises that he should have his first draft of the conceptual plan and preliminary cost estimates within one month.



ARCHITECTURAL FEE:

6% OF THE COST OF THE WORK "

IN ADDITION THE BASIC ARCHITECTURAL FEE SHALL BE INCREASED BY THE FOLLOWING SPECIAL ENGINEERING FEES:-

STRUCTURAL:

2% OF THE COST OF THE STRUCTURAL WORK

MECHANICAL:

TO OF THE COST OF THE MECHANICAL WORK

ELECTRICAL:

3% OF THE COST OF THE ELECTRICAL WORK

ROWING RESOURCE CONSULTANT:

4% OF THE COST OF THE WORK CONNECTED DIRECTLY WITH ROWING UP TO A MAXIMUM

of \$100,000.00

3% OF THE COST OF THE WORK CONNECTED DIRECTLY WITH ROWING ON THE NEXT \$100,000.00

IT IS AGREED, HOWEVER, THAT THE TOTAL FEES AS OUTLINED ABOVE SHALL NOT EXCEED 10% OF THE "COST OF THE WORK" (AS DESCRIBED IN ARTICLE IV (A) OF THE STANDARD FORM OF AGREEMENT BETWEEN CLIENT AND ARCHITECT).

IN ADDITION TO THE PLANNING OF THE FACILITIES REQUIRED IN CONNECTION WITH THE CANADA SUMMER GAMES 1973 (PHASE 1) AN ULTIMATE PLANNING CONCEPT FOR RECREATIONAL FACILITIES AT THE BURNABY LAKE AREA WILL BE ESTABLISHED.

THE ARCHITECTURAL SERVICES IN CONNECTION WITH THIS ULTIMATE DEVELOPMENT WILL INCLUDE A CONCEPTUAL OVERALL PLAN WITH DESCRIPTIVE SKETCHES FOR PROMOTIONAL PURPOSES. THE FEE FOR THESE SERVICES WILL BE A FLAT AMOUNT OF \$2,000.00.
