## 23. Re: Canada Summer Games Rowing Course Television Requirements

In order for the CBC to televise the rowing events or Burnaby Lake, it is necessary to string a messenger cable along the south side of the Course from the Burnaby Lake Pavilion to the 1000 meter Piling has been driven in order to support the messenger cable and the television cable will be simply hung on to the messenger cable for the duration of the Games. The television cable will be removed after the Games are over and it can be replaced if it is necessary for any future television requirements on the Rowing Course.

B.C. Telephone Company has been asked to string the messenger cable on the piling and the Company has asked the Municipality to absolve it from any responsibility due to damage caused to anyone (airplanes, vessels, etc.) as a result of collision with the cable placed on the piling and sagging down to the Lake level at the mid span points. The Municipality is arranging for insurance to cover itself for the future as the messenger cable will be left in place and could present some problems. In the meantime, we should be prepared to "save harmless" the Telephone Company.

## RECOMMENDATIONS:

THAT the Municipal Signing Officers be authorized to execute an agreement with B.C. Telephone Company in a form satisfactory to the Municipal Solicitor; and

THAT a copy of this report item be sent to the Parks and Recreation Commission.
