Following is a report from the Engineer regarding a request for approval to engage an engineering consulting firm for services pertaining to the subject sanitary sewer projects.

The Engineer is proposing payment on a "payroll cost plus percentage" basis rather than a "percentage of the cost of work" basis as the former is in our best interests.

## RECOMMENDATION:

THAT authority be given to enter into an agreement with the firm of Web Engineering Limited for contract preparation, tender call assistance, resident supervision and inspection services that are required for the subject sanitary sewer projects, with payment to be based on Section III, Scale 1, of minimum fees as published by the Professional Engineers of B.C., with total payment for services to cover a period of two months not to exceed \$25,580, and total payment for any additional month not to exceed \$11,340, with the exception of specified out-of-pocket expenses, all as outlined in the letters of June 1 and 4 from Web Engineering Limited to the Engineer.

## Re: 1973 Sanitary Sewer Construction Program

Our schedules require calling tenders for the subject work, which consists of Areas 6 and 7, Phases I and II, in about three weeks' time. The design of this program was completed by Web Engineering Ltd. some months'ago who were retained under an engineering agreement for design service only.

The subject sewer design calls for construction of force mains and gravity sewers and a pump station all on piled foundations in peat. Such construction would call for considerable work input by our staff in office supervision, on-site inspection and surveying. The general construction program in the coming months is very heavy and will require engineering services beyond the capabilities of our staff. For these reasons, we consider it advisable to retain engineering consultant services for this work. Inasmuch as the design was executed by Web Engineering Ltd. whose principals have had considerable experience in design and construction of this nature, we requested a proposal from them for additional engineering services as set out in the attachment to our letter dated 11 May, 1973. Web has offered to undertake the work as set out in their letters dated 1 and 4 June, 1973, attached.

Web's fee (based on the two-month construction period specified) has a maximum totalling \$25,580; this is 3.83% of the estimated construction cost of \$668,000, which is reasonable and we recommend its acceptance.

IT IS RECOMMENDED that an engineering agreement be entered into for the services of Web Engineering Ltd. in accordance with the terms of reference attached to our letter to the consultant dated 11 May, 1973, and the fee tructure stipulated in letters by Web Engineering Ltd. to us dated 1 and 4 June, 1973.

We would be pleased to provide engineering services as outlined in your letter dated May 11th, 1973.

The cost of services as outlined below is based on the following criteria:

We have numbered the required services as outlined in your letter and attach a copy of this.

The engineering services are based on minimum fees as suggested by the Association of Professional Engineers of the Province of British Columbia, under Section III, Scale 1 (Payroll Cost Plus Percentage) Sub-Item No. 3 (Payroll cost plus 100%). The construction time is estimated to be two months and we propose to use the following personnel:

2 Inspectors and 3 Instrument Men

It is immaterial whether the program is split into two contracts or if it is covered by one contract only. We feel that these men are required to do layout work, supervising the Contractors, providing information leading to asbuilt drawings.

Also included in the price is a car allowance based on a flat rate of \$6.50 per day per car used.

Not included is the provision for a field office and telephone. Our experience shows that field office facilities are best supplied by the Contractor as part of his contract obligation.

Dear Sirs:

On June 12th a public hearing was held in connection with the B. C. Telephone building at Delta & Parker and due to the system of notifying citizens I did not find out the date until the 13th.

You will note that I reside on Parker, a close distance from the building in question. My interest in the changes is probably the type of interest more citizens would have shown if they had been made aware and that is the traffic problems at Delta and Parker. The number of accidents at this intersection over the past three to four years has been numerous and some fatal. During the day a good number of our children (the young ones 6 - 13 must cross Parker to attend Brentwood School) and the cars on Parker do not have a school crossing light or anything so the children are on their own. I hope we don't have to have someone killed in order to make yourself and City Council aware of this. The Delta bus run, both in the moring and evening rush, must cross both Parker and Union and sometimes at Parker, the driver almost has to force his way across. To add to the problems of crossing Parker, those cars approaching from the south are on an uphill grade which is the side the B. C. Telephone is on.

The proposed changes to the B. C. Telephone building will of course make this corner still worse and create more traffic problems in the future.

I personally feel that traffic on Dalta should be kept under control in order that it will not create another main street which is unnecessary in this residential district.


