Re: Proposed Adjustments to Building, Plumbing and Gas Permit Fees

The following report from the Chief Building Inspector contains proposed revisions to fees for building, plumbing and gas permits. Increases for electrical permits were approved by Council on February 25, 1974.

The current fee schedules for the subject permits are attached.

RECOMMENDATIONS:

THAT the Building Department be authorized to distribute the revised fees for electrical permits, which Council approved on February 25, 1974, to electrical contractors so that they may have time to notify their customers of the changes; and

THAT if Council approves the proposed revisions to the fees for building, plumbing and gas permits, that the Building Department be authorized to distribute the revised fees to contractors for the convenience of their customers; and

THAT the subject fee schedules for the Building, Plumbing, Gas and Electrical Bylaws be adopted and the Municipal Solicitor be asked to bring down the required amending bylaws for Council readings in order that rate changes might become effective on April 1, 1974.

SUBJECT: Proposed Adjustment of Permit Fees

An analysis has been made of the 1974 Provisional Budget of the Building Department and the components thereof have been allocated to the respective inspection divisions and office support staff divisions. From this allocation 75 percent of the various budget costs have been taken and apportioned against revenue areas of building, electrical, plumbing and gas permit fees. This apportionment has determined target revenues from the respective fee areas for the year 1974. A summary of the foregoing is shown in the following Table 1.



- (B) For each inspection exceeding two in number made on any commercial or industrial installation there shall be a reinspection permit fee payable of \$15.00.
- (iii)For inspections outside normal working hours, \$30.00 plus regular permit fee.
- (iv) For vent and (or) furnace plenum (no appliance) \$5.00.
- (v) For piping (no appliance), first 200 feet or part thereof, \$5.00; every 100 feet or part thereof in excess of 200 feet, \$1.00.

ELECTRICAL BY-LAW NO. 761 AND AMENDMENT BY-LAW NO. 3875

Council at its meeting of February 25, 1974, has dealt with adjustment of permit fees authorized in the above By-law. The amending By-law is now in preparation by the Municipal Solicitor for presentation to Council so that the fee changes may become effective April 1, 1974.

A BY-LAW to amend By-law No. 2298, being the Burnaby Cas Fittings By-law 19531.

THE MUNICIPAL COUNCIL of The Corporation of the District of Burnaby ENACTS as follows:

1. Subsoction (2) of Section 7 of By-law No. 3293 is repealed and the following substituted therefor "(2) If such application is approved by the Inspector, shall issue a permit for such installetion, alteration repair upon payment of a fee as hereinafter fixed: or one (1) appliance - two dollars (\$2.00); For each appliance in excess of one (1) up to and including twenty (20) oppliances - one collar (31.00); For each spolinnee in excess of twesty (20) - fifty cents (Sup)."
