The Municipal Engineer has provided the following comments in connection with Mayor Tonn's correspondence with regard to the installation of additional left turn lanes at the subject intersections:

" In replying to Mayor Tonn's letter of November 21, 1974 we would advise that his suggestion of two left turn lanes eastbound Austin to northbound North Road would in our opinion give very little relief to the present area congestion and in fact may only compound it. First, let's look at the intersection. The eastbound approach on Austin Avenue is comprised of four lanes. The left lane is designated for left turns only, the two centre lanes which line up with the only two lanes on the Coquitlam side of North Road are for the through movement while the curb lane which has no complementary lane in Coquitlam is for right turns only.

If we were to designate the left hand lane of the two through lanes for left turns only or fir through and left turns under the present signal timing we would be creating the following conditions that could lead to further congestion and also increase the accident haszard.

- You would be designating two left turn lanes to handle 800 vehicles 1. in the 4 - 6 p.m. period while leaving a single through lane to handle 1500 vehicles in the same period.
- 2. Even if the additional left turn lane was designated to handle through traffic the delay encountered by the left turn vehicle would effectively block its use to the through movement thus putting us into positon #1. . - .

- 3. It is our opinion that to designate two left turn lanes would create an extremely haszardous position for the pedestrian in the north leg crosswalk. Under a two left lane condition this crosswalk should be closed to the pedestrian.
- 4. The conditions of item #1 or #2 would encourage weaving from the new left turn lane to the through lane and from the curb lane to the through lane. The latter movement would be extremely dangerous to pedestrians on the southeast corner as 4t would be attempted across the intersection.

If the Coquitlam people feel that special consideration should be given to the eastbound left turn movement, it has been our experience that the southbound left turn suffers more delay, then it should be done with an advance flashing arrow indication controlling a single left turn lane.

As we have pointed out many times in the rast there is probably no limit to the number of special or added phases we can put into a traffic signal controller, however, they all take up additional signal time and some other movement is going to suffer.

At the present time the total maximum signal cycle is 89 seconds with 38 seconds green to North Road and 41 seconds to Austin Avenue, with 10 seconds to amber periods. If we were to give 15 seconds of advance flash left to the existing <u>single</u> eastbound left turn Austin movement plus 4 seconds of clearance, we would only have 22 seconds of green time left for the westbound Austin movement under the present maximum signal timing. This would not be sufficient to handle the A.M. westbound Austin movement. As North Road cannot afford to lose any green time we can only increase the total signal cycle, thus increasing the total number of vehicles stored for each phase. It should also be borne in mind that by providing a special phase for left turns we can expect a sharp increase in the number of vehicles that will be wanting to make this movement. Over the past three years this movement has remained stable while all other movements have greatly increased.

While we cannot see any great improvement to the total congestion problem with the suggested left turn phasing, we feel that if Coquitlam is anxious to cater to this particular movement then we should give it a try and install a special advance phase for the existing eastbound single left turn lane on Austin Avenue at North Road.

The cost of this revision to the present signal is roughly estimated at between \$1,000.00 and \$1,500.00, and will be cost shareable between the Department of Highways, Coquitlam and Burnaby. The split will be 25%, 37½% and 37½% respectively.

In Mayor Tonn's submission he has made reference to two turning bays on the Lougheed at Austin and two turning bays on Austin at North Road. The Department of Highways have stated by letter that they would be prepared to provide the two bays on the Lougheed if Burnaby would provide two left turn bays on Austin. While we are not prepared to recommend accepting these terms and provide two left turn bays on Austin at North Road we have no objection to the Department of Highways providing two left turn lanes off the Lougheed Highway at Austin.

It was recommended that if the cost sharing is agreeable to all three parties that the present single eastbound Austin Avenue left turn lane at North Road be given a priority by means of an advance flashing left turn signal indication.
