## Re: Fees for Building, Plumbing, Gas and Electrical Permits

On March 11, 1974, Council adopted revised fees for building, plumbing and gas permits. A revised fee schedule for electrical permits was adopted by Council on February 25, 1974. Amending bylaws for all four schedules will become effective on April 1, 1974.


During discussion of the fee schedules, a request was made in Council for comparative information on existing and proposed fees that would be required for the construction of a typical single-family dwelling.

The requested information has been obtained for two typical residential dwellings: a detached single-family dwelling of modest size and a semi-detached two-family dwelling. Percentage increases for the four major types of permits required for these types of construction are shown on the <u>attached</u> tabulation, as well as the percentage increase of the total fee package from existing to proposed rates.

In the overall building cost in this type of residential construction, fees have never exceeded one percent of the cost. In the case of the single-family dwelling taken in this example, the total fee cost at the proposed new rates is 0.65 percent of the overall building cost. In the case of the semi-detached two-family dwelling taken in the example, the total fee cost at the proposed new rates is 0.64 percent of the overall building cost.
