ENQUIRIES

Alderman Gunn mentioned that a notice had appeared in a recent edition of the Vancouver Sun that the Trans Mountain Oil Pipeline Company would be discharging effluent from a ballast water treatment plant to Burrard Inlet. He also stated he had been informed pollutants in a concentration of more parts per million that/this would produce a total volume of than was being allowed to be discharged to Burrard Inlet as a part of the Chevron Refinery's Expansion Program.

MOVED BY ALDERMAN GUNN, SECONDED BY ALDERMAN STUSIAK:
"That the Municipal Manager submit a report to Council on April 29, 1974:

- (a) indicating precisely the difference in the amount of/water which the will be discharged by Chevron as compared to the Trans Mountain proposal mentioned above;
- (b) advising whether the Trans Mountain proposal will adversely affect the intended recreational use of the land abutting Burrard Inlet."

CARRIED UNANTMOUSLY

When Alderman Lewarne enquired about the experiment with the asphalt surface on Royal Oak Avenue north of Gilpin Street, the Municipal Engineer replied that he had already reported to Council on that matter. He explained that the results of the test pointed to the fact that the type of surfacing used was not desirable for permanent use. He added that the material was given a three-year trial before being analyzed.

When Alderman Lawson asked when a report would be submitted on the major road study that has been mentioned at many Council meetings in the past, the Planning Director stated that his report on the matter would be submitted to Council at its meeting on April 29, 1974.

Alderman Lawson enquired as to why a letter from the City of North Vancouver regarding Oil Refineries had not appeared on the Agenda for a Council meeting.

Spokesmen for the Offices of the Municipal Clerk and the Municipal Manager stated that they had not seen such a letter.

It was understood that the Mayor would investigate the situation and, if the letter can be found and it is determined that it should be directed to the Council, then he would arrange with the Office of the Municipal Clerk to place the submission on an Agenda for a Council meeting.

MOVED BY ALDERMAN STUSIAK, SECONDED BY ALDERMAN MERCIER: "That the Council now resolve itself into a Committee of the Whole."

Report of Fire Department

A report of the Fire Chief covering the activities of his Department during the months of January, February and March 1974 was submitted.

MOVED BY ALDERMAN LAWSON, SECONDED BY ALDERMAN STUSIAK: "That the report be received."

CARRIED UNANIMOUSLY

(2) National Roadside Survey 1974

The Traffic and Safety Branch of the Department of Transport has commissioned the Foundation of Canada Engineering Corporation Limited to undertake a survey of drivers across Canada, the principle objective being to obtain a breath sample in order to establish the level of blood alcohol content of drivers in Canada.

The survey will be conducted in Burnaby on April 27, 1974, between 10.00 p.m. and 3.00 a.m. and on May 1, 1974, during the same hours.

The method assigned has been approved by the Engineering Department and the R.C.M.P. will be in attendance during the survey.

Those stopped will be asked a series of questions and, with their consent, will be given a breath test to determine the content of alcohol in their blood.

The purpose of the survey is to obtain information; no charges are to be laid against drivers, including those unable to successfully pass the breath analysing test.

MOVED BY ALDERMAN MERCIER, SECONDED BY ALDERMAN LAWSON: "That the report of the Manager be received."

CARRIED UNANIMOUSLY

MOVED BY ALDERMAN STUSIAK, SECONDED BY ALDERMAN GUNN:

"That Council request the Traffic and Safety Branch of the Department of Transport, through the aegis of Foundation of Canada Engineering Corporation Limited, to ensure that, when stopping motorists, the purpose of the survey be first made abundantly clear and, at the same time, mention the fact the provision of the information to be elicited in the survey is strictly voluntary; and further, that those conducting the tests not be allowed to exercise discretion as to whether a driver has a blood alcohol reading of greater than 8% because it is felt the Police should be the ones who should ascertain this situation and, in the course of explaining the purpose of the survey to motorists who are stopped,

perhaps questions relating to alcohol consumption should be asked before the other ones shown on the survey form accompanying the report the Manager submitted this evening."

CARRIED UNANIMOUSLY

(3) Burnaby Noise or Sound Abatement By-Law 1972

As a result of a study by the Health Department following implementation of the above By-Law, it was recommended that the By-Law not be amended at this time but that the Technical Sub-Committee involved with the By-Law submit a progress report on June 2, 1975, or sooner if considered appropriate, on the subject of the By-Law.

It was also recommended that a copy of the report at hand be sent to the Greater Vancouver Regional District.

MOVED BY ALDERMAN STUSIAK, SECONDED BY ALDERMAN MERCIER: "That the recommendations of the Manager be adopted."

CARRIED UNANIMOUSLY

MOVED BY ALDERMAN GUNN, SECONDED BY ALDERMAN LAWSON:

"That the Sub-Committee submit a report on the merits of monitoring noises at the height they are emitted and at the property lines of the site on which the noises are being made."

The Council noted from the report at hand that one of the three against whom charges were laid under the By-Law did not appear at his trial and it is doubtful the case will come to trial because it is understood the person charged has left the Province.

The Council asked that an explanation be provided as to whether the course of action followed in that instance is the normal one and, if so, why this is done.

(4) Shopping Carts

The problem of shopping carts being abandoned on streets and in other places is fairly widespread. Stores do have a pickup service for the recovery of abandoned shopping carts but it is not entirely satisfactory because there is still a great deal of littering of streets with such carts.

The Health Department is contacting four major shopping outlets to ask that a discussion take place on the subject matter.

It was recommended that a copy of the report at hand be sent to Beverley J. Gilpin, who wrote to Alderman Lawson about the matter.

MOVED BY ALDERMAN STUSIAK, SECONDED BY ALDERMAN LAWSON: "That the recommendation of the Manager be adopted."

(5) Burnaby Family Court Committee

REZONING REFERENCE NO. 8/74

It was recommended that Council approve for further consideration a proposal to rezone the above described properties to COMPREHENSIVE DEVELOPMENT DISTRICT (CD) and establish the following prerequisites to the rezoning:

- (a) The submission of a suitable plan of development for the site.
- (b) The completion of the lane exchange By-Law referred to in the report.
- (c) The consolidation of the properties into one site.
- (d) The granting, to the Corporation, of any easements deemed necessary over the site, and the maintenance or relocation of any easements which currently exist on the site.
- (e) The deposit of sufficient funds to guarantee the provision of all necessary municipal services to the site.
- (f) The provision, underground, of all electrical servicing, telephone and cable installations throughout the development.
- (g) The granting, to the Corporation, of a public walkway easement to the site from the public plaza area to Pender Street.

It was also recommended that the proposal be advanced to a Public Hearing to be held on May 20, 1974, prior to the Council meeting scheduled for that date.

It was further recommended that:

- (a) Council approve the reformation of the Public Urban Plaza area integrally within the project proposed on the site according to either of the two alternative solutions indicated in Sections 3.2.1 and 3.2.2 of the report.
- (b) A Lane Exchange By-Law be prepared in accordance with the points outlined in Section 3.1 of the report.

As the result of a brief discussion, it was understood by Council that the Planning Department would submit a report indicating the extent of any vandalism or thefts involving the site which is the subject of the report from the Manager.

MOVED BY ALDERMAN LEWARNE, SECONDED BY ALDERMAN MERCIER: "That the recommendations of the Manager be adopted."

(11) Still Creek between Boundary Road and Lougheed Highway

As a result of considering the matter of enclosing the above portion of Still Creek, it was recommended that:

- (a) The Greater Vancouver Sewerage and Drainage District be advised that Council does not approve the enclosing of that portion of the north branch of Still Creek between Boundary Road and Lougheed Highway at this time and that the matter will be reviewed upon completion of the two studies mentioned in the report at hand.
- (b) A copy of the said report be sent to both the Greater Vancouver Sewerage and Drainage District and to the B.C. Hydro and Power Authority.

MOVED BY ALDERMAN STUSIAK, SECONDED BY ALDERMAN MERCIER: "That the recommendations of the Manager be adopted."

CARRIED UNANIMOUSLY

(12) Summer_Hours:

It was recommended that the hours of work at the Municipal Hall and at the Parks and Recreation Offices be changed to 8.30 a.m. to 4.30 p.m. during the period between May 21st and September 2, 1974 inclusive.

(13) Municipal Capital Improvement Work

It was recommended that Council retain the services of McElhanney Surveying and Engineering Limited for inspection of the 1974 Municipal Capital Improvement Works, as detailed in the report at hand and in a letter dated March 15, 1974, from the Company.

MOVED BY ALDERMAN STUSIAK, SECONDED BY ALDERMAN MERCIER:

"That action on the recommendation of the Manager be deferred until a decision is made by Council on the 1974 Budget of the Engineering Department."

(14) Greentree Village

As a result of considering a request from the developer of Greentree Village concerning site clearing, it was recommended that Council approve the commencement of selective site clearing operations in the Phase III area only, on the basis outlined in an April 4, 1974, letter from the developer (Daon Development Corporation) and in the report at hand following Second Reading of the amendment to the Zoning By-Law covering the rezoning of the area, subject to the prior completion of the following matters:

- (a) The submission of a suitable letter of undertaking from the Developer agreeing to the specific terms under which the operation will proceed.
- (b) Written verification from both the developer and the Landscape Architect as to the entire operation being conducted under the direct supervision and to the satisfaction of the Landscape Architect.
- (c) Acknowledgment by the developer that the approval of Council relating to the site clearing does not necessarily mean that the amendment to the Zoning By-Law mentioned will be passed and that therefore the developer is proceeding at his own risk.

MOVED BY ALDERMAN LAWSON, SECONDED BY ALDERMAN GUNN: "That the recommendation of the Manager be adopted."

MOVED BY ALDERMAN STUSIAK, SECONDED BY ALDERMAN LEWARNE:

"That the above Motion be tabled until the April 29, 1974 Council meeting and the Planning Department submit a report at that time on the question of whether the developer of the subject project can combine all or part of Phase IV of his project with Phase III."

(17) SWEEP 74

The Provincial Government is offering to pay students in the employ of Municipalities working on environmental enhancement projects the sum of \$400.00 per month for the two month period commencing July 2, 1974. Municipalities are asked to assume the cost of employee benefits and administration.

As a result of considering this proposal, it was recommended that the Municipality of Burnaby not participate in the SWEEP 74 Program because of the costs which would need to be incurred by the Municipality, as more particularly detailed in the report.

Alderman Stusiak suggested that the Provincial Government should further subsidize the cost of the SWEEP 74 Program by paying the difference between the mandatory minimum wage and the union rates which apply in Municipalities.

He also suggested that the Civic Employees Union should waive its interest in the Program as it affects the employment of persons.

MOVED BY ALDERMAN GUNN, SECONDED BY ALDERMAN AST:

"That the subject of the report from the Manager be referred to the Mayor and to the Manager for a further report on the merits of discussing the Program with appropriate Cabinet Ministers of the Provincial Government and ascertaining from the Civic Employees Union if that body can offer any projects it feels would be suitable for implementation under the Program."

"That the previous Motion be amended by adding 'and further, that the Minister of Labour for the Provincial Government be apprised of the fact Council is in sympathy with the objectives of the SWEEP 74 Program and therefore regrets it is unable to participate for the reasons provided in the report at hand but would suggest that the Provincial Government give consideration to alternative methods of implementing the objectives of the Program."

CARRIED UNANIMOUSLY

A vote was then taken on the original Motion, as amended, and it was carried unanimously.

AT 9:25 P.M. THE MEETING RECONVENED WITH MAYOR T. W. CONSTABLE AND ALDERNEN G. D. AST, A. H. EMOTT, B. M. GUNN, D. A. LAWSON, W. A. LEWARNE, J. L. MERCIER AND V. V. STUSIAK IN ATTENDANCE.

Municipal Manager spoke to his report (Item #11) in reference to the survey of Still Creek and summarized the circumstances leading to the Municipality being assessed \$25,840.00 by the Greater Vancouver Severage and Drainage District as a share of the total cost involved in surveying Still Creek.

"That authority be given to pay Burnaby's share of the survey of Still Creek based on a drainage area assessment and in quarterly annual instalments."

The meeting then gave consideration to the proposed 1974 Annual Budget as prepared in accordance with the "Municipal Act". The Municipal Treasurer advised the meeting in reference to a number of questions raised at the Budget Meeting held on Wednesday, April 17, 1974.

Alderman Stusiak requested an explanation as to why some of the accounts shown on Page 27 of the proposed Annual Budget show increases and some show decreases. The Municipal Engineer advised that they had chosen 1974 with the Municipal Treasurer to realign various accounts to show a truer distribution of costs and this portion of the Budget reflects the Contracts Investigation Committee report.

AT 9:43 P.M. ALDERMAN MERCIER RETIRED FROM THE MEETING.

The discussion continued in reference to the proposed 1974 Annual Budget during which the Municipal Engineer advised that he was aiming to reduce his staff by three survey crews at a subsequent saving of \$100,000.00 per annum.

AT 9:53 P.M. ALDERMAN MERCIER RETURNED TO THE COUNCIL CHAMBER AND TOOK HIS PLACE AT THE COUNCIL TABLE.

A discussion ensued in reference to Page 28 and the matter of Consultants-Storm Drainage Account, Consultants-Local Improvements Account and Consultants-Inspection Supervision Account.

Dealing with Page 29, a discussion was held in reference to Garage, Carpenter Shop and Paint Shop Accounts and expenditures therefor with the 1973 Actual total for these three functions being \$412,789.00 and the 1974 Annual total being \$587,753.00. In response to a question as to why the cost had gone up some 40% over last year, the reply was forthcoming that more of the past costs were borrowed than should have been and that this year more will be expended out of the mill rate.

During the discussion in reference to Page 30, it was pointed out that there was an increase in the total budget for the Engineering Department of some 20% of which 12% was for salaries.

Alderman Lewarne drew to the attention of the meeting that Street Cleaning expenditures were proposed to be up some \$18,000.00 to which the Municipal Engineer advised that this was attributable to increasing of the service.

The Municipal Manager advised that there was no recovery from the Provincial Government for the Community Care Salaries as shown on Page 32 and that he had been working on this subject matter since last October.

During a discussion of the salary for the Nutritionist as provided for on Page 33, it was pointed out that this person will perform other functions in addition to also advising the operators of Community Care Facilities.

MOVED BY ALDERMAN STUSIAK, SECONDED BY ALDERMAN MERCIER:
"That the provision for the Nutritionist salary, Employee benefits, and Mileage,
as shown in the proposed 1974 Annual Budget in the amount of \$4,905 be deleted
therefrom."

Following a discussion the motion was then woted on and was LOST.

The meeting then considered Page 37 of the proposed 1974 Annual Budget following which it was:

MOVED BY ALDERMAN LEWARNE, SECONDED BY ALDERMAN STUSIAK:
"That provision for one Planner be deleted from the Planner's budget."

During the discussion that ensued, Alderman Lewarne expressed the opinion that he felt the budget for the Planning Director's Office was excessive and that one additional Planner can do a good job."

Alderman Mercier spoke in favour of retaining the additional Planner and felt that the Director of Planning had made an excellent presentation at the Budget Meeting held on Wednesday, April 17, 1974. The meeting was advised that the Council would have to accept delays in Planning matters if they did not concur with the employment of the additional Planner.

The motion was then voted on and $\overline{\text{LOST}}$.

MOVED BY ALDERMAN EMMOTT, SECONDED BY ALDERMAN LEWARNE:
"That the hiring of one additional Planner be held in abeyance until the submission of a report from the Manager."

Following a discussion the motion was then voted on and was CAPRIED UNANIMOUSLY.

The meeting confirmed, as requested by the Municipal Manager, that the decision as to what Planner is now hired is up to the Planning Director.

Alderman Stusiak enquired if the additional Public Health Inspectors and Mental Health Staff members as provided for on Page 32 of the 1974 proposed Annual Budget are required to which the Municipal Manager replied that it is the feeling that with more involvement in environmental matters by the Public Health Department additional staff members are required.

MOVED BY ALDERMAN STUSIAK, SECONDED BY ALDERMAN LAWSON: "That the meeting continue beyond the hour of 10:30 o'clock p.m."

MAYOR CONSTAPLE AND ALDERMAN GUMN VOTED CONTRARY TO THE MOTION

AT 10:48 P.M. ALDERMAN MERCIER RETIRED FROM THE COUNCIL CHAMBER.

In reply to a question from Alderman Lawson in connection with the Outdoor Programme as provided for on Page 40 and the cutback in expenditure from the 1974 Provisional Budget the meeting was adivsed that the Programme had been cut back.

In reference to Coffee Shop-Golf Course and Coffee Shop-Centennial Pavilion the question was raised as to why same is provided for in the Budget when both items are out for tender. The reply was that this is a cushion in case problems develop in connection with the tender submissions. It was noted that the refreshment booths located at Kensington Pool, Robert Burnaby and McPherson, as enumerated on Page 40, had been closed with this action being dictated by losses. The meeting was also advised that the grants for the McPherson Winter Club, Burnaby Winter Club, and the Barracuda Swim Club were under review.

Alderman Lewarne advised that he wished to express his views that he looks with concern at the Budget figures on Page 41 provided for the Library operation and Alderman Lawson was requested to convey the Council's expression of concern to the Burnaby Library Board.

During a review of the expenditures as provided for on Page 42, it was noted that the 1973 Actual expenditures for the Century Park Museum Association amounted to \$63,590.00 and there was a substantial increase for the 1974 Annual being a proposed \$82,000.00 total expenditure.

AT 11:05 P.M. ALDERMAN EMMOTT RETIRED FROM THE COUNCIL CHAMBER.

During consideration of Page 49 it was noted that the Account "Provision for new borrowing" in the amount of \$143,308.00 has been provided for a possible one half-year's interest on the Parks By-law.

During consideration of Page 56 it was noted that the cost of water provided for in the 1974 Annual Budget had been reduced from that provided for in the 1974 Provisional Budget with the explanation being that this was based on cost figures received from the Greater Vancouver Regional District.

Mayor Constable advised the meeting that the Capital Improvement Programme Budget will go to Council no later than next Monday.

When considering the Streets and Lane Rehabilitations as listed on Page 66, the meeting was advised that Britton Street from Kingsway to Stride Avenue was being recapped to make the pavement last longer.

Page 69 showed thereon the sum of \$30,000 as Consultants' fee for a Headquarters Library Building. Following a discussion in reference to this subject matter it was

MOVED BY ALDERMAN GUNN, SECONDED BY ALDERMAN LEWARNE:
"That the sum of \$30,000 as provided in the proposed 1974 Annual Budget for Consultants' fee - Headquarters Library be deleted therefrom."

Alderman Lawson advised the meeting that she would like to see the sum of \$30,000 remain in the Budget with a caution to the Burnaby Library Board that the Council is concerned in reference to pushing too far too fast.

Following a discussion the motion to delete the sum of \$30,000 from the proposed 1974 Annual Budget was then WITHDRAWN BY THE MOVER AND SECONDER.

MOVED BY ALDERMAN GUNN, SECONDED BY ALDERMAN LEWARNE:
"That the provision in the proposed 1974 Annual Budget for Consultants' fee Headquarters Library be reduced from \$30,000 to \$5,000."

The motion was then voted on and LOST.

MOVED BY ALDERMAN STUSIAK, SECONDED BY ALDERMAN LAWSON:
"That the Council of the Corporation of the District of Burnaby accept the 1974
Annual Budget as amended."
