Re: North Fraser Harbour Commission Placement of River Sand on Corporation Property at the Fraser River West of Byrne Road

Following is a report from the Engineer on an offer from the North Fraser Harbour Commission to make approximately 100,000 cubic yards of sand available to the Municipality for 25¢ per cubic yard.

RECOMMENDATION:

THAT the Municipality approve of the proposal of the North Fraser Harbour Commissioners to place approximately 100,000 cubic yards of dredged river sand on Corporation owned property west of Byrne Road as shown on the attached sketch at a cost of 25c per cubic yard, and that the sum of \$25,000 be provided in the 1974 budget for this purpose.

NORTH FRASER HARBOUR COMMISSION PLACEMENT OF RIVER SAND RE: ON CORPORATION PROPERTY AT THE FRASER RIVER WEST OF BYRNE ROAD

Approximately every five years we receive an application from the North Fraser Harbour Commission to dispose of river sand from their dredging operation on Corporation owned property in the vicinity of Byrne Road. On each occasion we have accepted the offer to receive the sand on the basis of a minimal royalty charge of 25¢ per cubic yard.

We have now received a similar application from the North Fraser Habour Commissioners dated 19 February, 1974 (copy <u>attached</u>) requesting permission to place approximately 100,000 cubic yards of river sand from their dredging operation on Corporation owned property west of Byrne Road as located on the attached sketch at a cost of 25c per cubic yard. This is a very nominal charge for river sand which can eventually be put to use as excellent fill for various purposes and, in particular, could be used for filling of Municipally owned property in the Big Bend Area.

RECOMMENDATION:

THAT the Municipality approve of the proposal of the North Fraser Harbour Commissioners to place approximately 100,000 cubic yards of dredged river sand on Corporation owned property west of Byrne Road as shown on the attached sketch at a cost of 25¢ per cubic yard, and that the sum of \$25,000 be provided in the 1974 budget, for this purpose.
