Appearing on the Agenda for the February 25, 1974 meeting of Council is a petition against a proposed Local Improvement Program on Hurst Street from Joffre to Mandy Avenue.

The Deputy Clerk advises that the subject petition is sufficient in all respects to defeat the proposed project.


The Clerk's office has received a petition indicating that the majority of property owners on Hurst Street from Joffre Avenue to Mandy Avenue are not in favour of proposed improvement to their street which was to be initiated by the Corporation soon.

The petition is the fourth that the Corporation has received objecting to the proposed program in the immediate area. The other three are from property owners on Dubois Street from Boundary to Mandy Avenue (2) and on Hurst Street from Boundary to Joffre (1) as shown on the attached sketch.

RECOMMENDATION:

As petitioned by the property owners and consistent with the decisions of Council of November 13, and November 19, 1973 on the 3700 - 3800 block Dubois Street and the 3700 block Hurst Street, we recommend that the 3800 block Hurst Street (Joffre Avenue to Mandy Avenue) be deleted from the 1974 proposed Local Improvement Program.

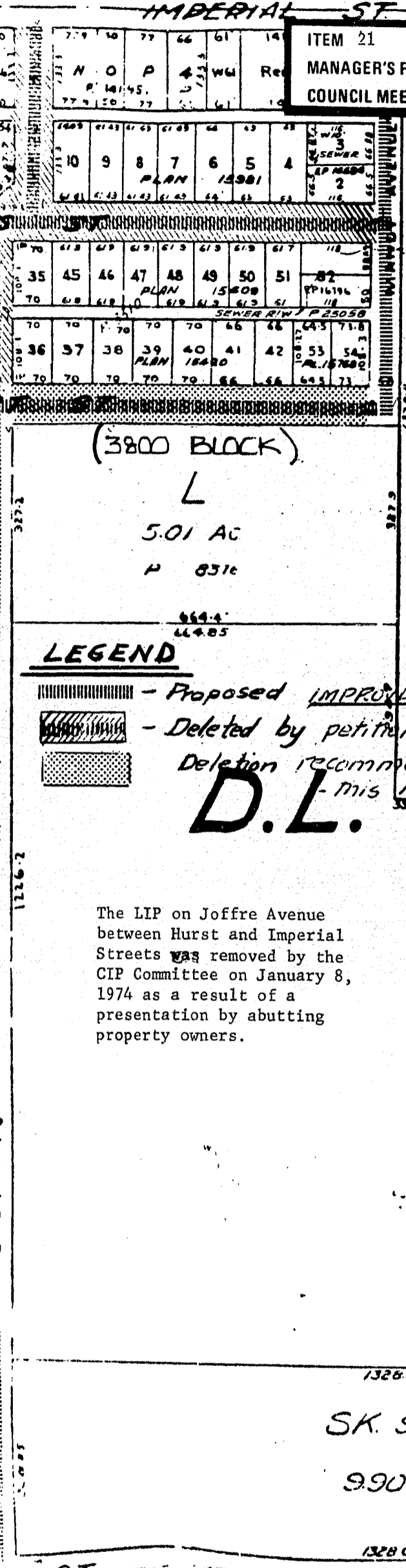
