Council, at its meeting of June 10, 1974, received the above-noted report and approved the recommendation that a by-law to control vehicle parking on Municipal Hall grounds (see attached Sketches "A" and "B") be prepared and brought forward for consideration.

Attached for Council consideration and adoption is By-Law 6525, "Burnaby Municipal Hall Parking Regulation By-Law 1974".


As Council is aware, construction of the Municipal Hall-West Building and alterations to the Municipal Hall and to the area between the two buildings will require reallocation of parking spaces, particularly with respect to parking areas "A", "C", "D" and "E" shown with Sketch "A". Although space allocation and signing will require considerable change, it is not anticipated, at this point in time, that major By-Law amendments, if any, will be required.

The proposed By-Law, as prepared by the Municipal Solicitor, meets with the approval of the Chief Building Inspector, the Municipal Engineer, and the Purchasing Agent.


RECOMMENDATION:

BY-LAW NO. 6525

A BY-LAW to regulate the use of a public place, being the Burnaby Municipal Hall grounds.

The Council of The Corporation of the District of Burnaby ENACTS as follows:

- This By-law may be cited as "BURNABY MUNICIPAL HALL PARKING REGULATION BY-LAW 1974".
- 2. The provisions of this By-law shall be in force and effect within the boundaries of the Burnaby Municipal Hall grounds, in the Municipality of Burnaby, in the Province of British Columbia, being described as Lot 80 of D.L. 79, Gp. 1, Plan 25720, New Westminster District, Parcel "H" (Explanatory Plan 30169) of D.L. 79, Gp. 1, New Westminster District, and Lots 1 to 10 both inclusive, Block 7, District Lot 79, Gp. 1, Plan 2547, New Westminster District.
- 3. No person except the Manager, Mayor and Aldermen shall park a vehicle in any parking space marked, Manager, Mayor or Alderman.
- 4. No person except the person entitled shall park a vehicle in any parking space marked "Staff Parking Only".
- 5. No person except a municipal employee shall park a vehicle in any area marked for Municipal Employee Parking Only.
- 6. No municipal employee shall park a vehicle not having affixed to the windshield thereof an approved decal in any area marked for Municipal Employee Parking Only.
- 7. No person shall park a vehicle
 - (a) in any area marked "No Parking", or
 - (b) not within a marked parking space.

- 8. No municipal employee shall park a vehicle in any parking space marked "Visitors".
- 9. Any vehicle parked in violation of any of the provisions of this By-law may be removed, detained or impounded and the owner of the said vehicle shall pay all of the costs of such removal, detention or impoundment before the said vehicle is returned to his possession.
- 10. Every person who violates any of the provisions of this By-law shall be guilty of an offence punishable on summary conviction and shall be liable to pay a fine not exceeding \$100.00 or to imprisonment for thirty days or both.
