A regular meeting of the Municipal Council was held in the Council Chamber, Municipal Hall, 4949 Canada Way, Burnaby 2, B. C. on Monday, May 6, 1974 at 7:00 p.m.

A Public Hearing was held to receive representations on Burnaby Highway Exchange By-Law No. 6, 1974, which involves the closure of the Hewitt Street Road Allowance at Duthie Avenue as a part of a subdivision under Reference No. 238/73.

Mr. S. Suessenbach, 890 Duthie Avenue, appeared and stated that he had just received the letter from the Office of the Municipal Clerk today and therefore had not had time to make enquiries about the proposed By-Law.

MOVED BY ALDERMAN STUSIAK, SECONDED BY ALDERMAN LEWARNE: "That the Public Hearing be adjourned until the May 13, 1974 Council meeting in view of the situation just mentioned regarding the mail delivery of letters about the matter and, in the meantime, the abutting owners who were notified of the Hearing be asked to contact the Planning Department for answers to any questions they may have."

CARRIED UNANIMOUSLY

The Minutes of the Council meetings on April 16th and April 22, 1974 plus a "Budget" meeting on April 17, 1974 came forward for adoption.

The following amendments were made to those Minutes as a result of a discussion by the members of Council:

- (1) The motion at the top of Page 2 in the April 22nd Minutes was amended by deleting the words "Big Bend Area of the" immediately before the word "Municipality".
- (2) The entry at the top of Page 5 of the April 16th Minutes recording a statement attributed to Alderman Lawson was changed to read "Alderman Lawson mentioned that the B. C. Telephone Company does not show that part of Burnaby East of Sperling Avenue on its brochures".
- (3) The motion at the bottom of Page 5 of the same Minutes was amended by deleting all the words after "comment".
- (4) The entry under "Enquiries" on Page 4 of the April 22nd Minutes relating to comments attributed to Alderman Gunn concerning the Trans Mountain Oil Pipeline Company was altered to read:

"Alderman Gunn mentioned that a notice had appeared in a recent edition of the Vancouver Sun that the Trans Mountain Oil Pipeline Company would be discharging effluent from a ballast water treatment plant to Burrard Inlet. He also stated that he had been informed this would produce a total volume of pollutants in a concentration of more parts per million than was being allowed to be discharged to Burrard Inlet as a part of the Chevron Refinery's Expansion Programme.

MOVED BY ALDERMAN GUNN, SECONDED BY ALDERMAN STUSIAK: "That the Municipal Manager submit a report to Council on April 29, 1974:

- (a) indicating precisely the difference in the amount of pollutants and concentration in parts per million in the water which will be discharged by Chevron as compared to the Trans Mountain proposal mentioned above;
- (b) advising whether the Trans Mountain proposal will adversely affect the intended recreational use of the land abutting Burrard Inlet."

CARRIED UNANIMOUSLY"

MOVED BY ALDERMAN LEWARNE, SECONDED BY ALDERMAN STUSIAK: "That the Minutes of the April 16th, 17th and 22, 1974 meetings, with the amendments itemized above, be approved."

CARRIED UNANIMOUSLY

PROCLAMATION

Mayor Constable then proclaimed the period between May 6th and May 12, 1974 as Anti-Litter Week.

DELEGATIONS

Mr. David Carter, Department Head, Social Studies, Burnaby North Senior Secondary School, submitted a letter requesting an opportunity for Miss Joan Fisher, a student at the School, to address Council on a grant she received.

Mr. M. I. J. Bhend wrote to request an opportunity to speak to Council about the rezoning of property known as 7619 Elwell Street to permit apartment development thereon.

MOVED BY ALDERMAN AST, SECONDED BY ALDERMAN LAWSON: "That the delegations be heard."

CARRIED UNANIMOUSLY

Miss Fisher then spoke and expressed her appreciation to Council for the grant she received that helped to defray expenses incurred by her in travelling to various locations in North America under the Programme called IPSUN '74.

Miss Fisher also presented a Brief outlining the highlights of her trip.

Mr. Bhend then spoke and made the following comments:

- (a) The Planning Department was being inflexible in not considering the rezoning of property known 7619 Elwell Street to permit the use he desires.
- (b) The property in question has an area of 17,000 square feet, 10,000 square feet of which would be wasted if not allowed to be developed in the manner he desires or something akin to it because the property is "land locked" and cannot be subdivided.

(c) It seems reasonable that, in view of the housing crisis facing the public today, special consideration should be given the matter of allowing the development of a fourplex on the site.

In response to a query, Mr. Bhend replied that he had read Item #12 of the Municipal Manager's Report No. 35, 1974, which deals with the subject of concern.

MOVED BY ALDERMAN LAWSON, SECONDED BY ALDERMAN STUSIAK: "That Item #12 of the Municipal Manager's Report No. 35, 1974 be brought forward for consideration at this time."

CARRIED UNANIMOUSLY

The following is the substance of that report:

(12) 7619 Elwell Street (Bhend)

As a result of considering the submission from Mr. Bhend, it was recommended that:

- (a) Council not grant his request for the reasons cited in the report.
- (b) Mr. Bhend be informed that the Planning Department is currently undertaking a study of the matter of raising densities in lowdensity residential districts of the Municipality and it be suggested to him that he should consider the development of the subject property in the context of the final decisions which are rendered by Council following consideration of the study mentioned.

MOVED BY ALDERMAN MERCIER, SECONDED BY ALDERMAN MCLEAN: "That the recommendation of the Manager be adopted."

CARRIED UNANIMOUSLY

ORIGINAL COMMUNICATIONS

MOVED BY ALDERMAN LAWSON, SECONDED BY ALDERMAN STUSIAK: "That all of the below listed original communications be received and those items of the Municipal Manager's Report No. 35, 1974 which relate thereto be brought forward for consideration at the appropriate times."

CARRIED UNANIMOUSLY

Mr. P. W. Gaskarth, Chairman, Carnation Day, Burnaby Host Lions Club, wrote to request permission to hold the Annual Carnation Tag Day in the Eastern part of the Municipality on May 10, 1974.

Mrs. Fred Jackson, Secretary, Sponsoring Committee, Air Cadet Squadron #637, submitted a letter requesting permission to hold a Tag Day in the Southern part of the Municipality on the evening of October 11th and all day/October 12, 1974.

MOVED BY ALDERMAN LAWSON, SECONDED BY ALDERMAN LEWARNE: "That permission be granted to both of the above organizations to conduct their campaigns at the times and in the areas indicated."

CARRIED UNANIMOUSLY

<u>Mrs. B. Murphy, Secretary, Sullivan Heights Ratepayers Association</u>, submitted a letter requesting that Council arrange with the B. C. Telephone Company to have Burnaby locations re-assigned from their present non-Burnaby telephone exchanges to a Burnaby exchange.

MOVED BY ALDERMAN MCLEAN, SECONDED BY ALDERMAN LAWSON: "That the B. C. Telephone Company be asked for its comments on the matter of concern to the Sullivan Heights Ratepayers Association."

<u>Mr. W. Gentleman</u> wrote to suggest that action be taken by the Municipality to clarify the type of parking which is allowed in front of Brentwood House on Rosser Avenue because of a situation in which he was involved recently.

Item #5 of the Municipal Manager's Report No. 35, 1974, which relates to the subject of the letter from Mr. Gentleman, was brought forward for consideration at this time. The following is the substance of that report:

(5) Brentwood House

From investigation, it would appear that the portion of Rosser Avenue of concern to Mr. Gentleman is that part lying between Halifax and Buchanan Streets.

As the parking offence mentioned by Mr. Gentleman was legitimate in that it is adequately covered by both Provincial and Municipal Statutes and since knowledge of such laws is the responsibility of all holders of a valid driver's licence, it is not felt necessary to erect signing to connote the prohibition of angle parking on any street.

It was recommended that no action be taken on the complaint of Mr. Gentleman and that he be sent a copy of the report at hand.

MOVED BY ALDERMAN LAWSON, SECONDED BY ALDERMAN LEWARNE: "That the recommendation of the Manager be adopted."

CARRIED UNANIMOUSLY

Mr. K. F. Fraser, Commissioner, North Fraser Harbour Commissioners, wrote to provide information concerning the adoption by the North Fraser Harbour Commissioners of the Harbour Commissions Act of 1964.

Mr. Fraser also sent a copy of a Brief detailing the situation concerning the matter.

MOVED BY ALDERMAN AST, SECONDED BY ALDERMAN GUNN: "That Council accept the offer of Mr. Fraser that Burnaby technical and elected persons go on a tour of the Fraser River to discuss plans of development of land abutting the River and he be asked to advise when such a tour can be held."

CARRIED UNANIMOUSLY

MOVED BY ALDERMAN STUSIAK, SECONDED BY ALDERMAN AST: "That Mr. Fraser also be requested to provide Council with details relating to Point 5 in his Brief concerning the appointment of municipal representatives."

CARRIED UNANIMOUSLY

TABLED ITEMS

MOVED BY ALDERMAN LAWSON, SECONDED BY ALDERMAN MERCIER: "That the following matters be lifted from the table:

- (a) Swangard Stadium;
- (b) Capital Improvement Programme."

CARRIED UNANIMOUSLY

The following points were made in Council during consideration of Item #30 of the Manicipal Manager's Report No. 33, 1974 relating to improvements to the playing field at Swangard Stadium:

- (i) The field should be playable some time this fall.
- (ii) The anticipated completion date for the improvements is July 23, 1974.

- (iii) The Council should have an overall look at the matter of providing artificial turf on the playing field because of the many advantages that would accrue. For example, artificial turf can be used at all times during the year and with this type of use the prices which are charged for every game that may be played on the field can possibly be reduced.
- (iv) The Council should obtain a report on the cost-benefit ratio relating to the playing field.
- (v) The Council has not received all of the pertinent information relating to problems at Swangard Stadium.
- (vi) The Parks and Recreation Commission does not wish artificial turf but, with regard to the suggestion concerning a report on the cost-benefit ratio, the Commission has studied this matter.
- (vii) From information that has been received, it would cost around \$1,000,000.00 to install artificial turf on the playing field at Swangard Stadium.

MUNICIPAL MANAGER read a memo he had received from the Parks and Recreation Administrator providing comments on the subject matter.

The Manager also remarked that Cellsystem Design was prepared to wait until it completes the reconstruction work before asking for payment for the work.

MOVED BY ALDERMAN STUSIAK, SECONDED BY ALDERMAN LEWARNE: "That the recommendations of the Manager in Item #30 of his Report No. 33, 1974 and in Item #27 of his Report No. 33, 1974 pertaining to the reconstruction of the playing field at Swangard Stadium be adopted."

CARRIED

AGAINST -- ALDERMEN GUNN AND MERCIER

It was understood by Council that the Canada Summer Games Society would be notified of the foregoing action.

MOVED BY ALDERMAN STUSIAK, SECONDED BY ALDERMAN MCLEAN: "That Council approve the 1974 portion of the Capital Improvement Programme (1974-1979) and do likewise with the remaining portion of the Programme, on the understanding that this latter authorization is for the planning only of the works involved in the years 1975-1979."

CARRIED UNANIMOUSLY

ENQUIRIES

When <u>Alderman Stusiak</u> raised the issue of Bill 47 (the proposed Public Disclosures Act), Mayor Constable suggested that Alderman Stusiak's remarks be construed as being a Notice of Motion about the subject.

<u>Alderman Stusiak</u> mentioned that the report of the Planning Department dealing with the Major Road Study would not be considered by the Advisory Planning Commission until its meeting next month. He suggested that Council should endeavour to have the Commission deal with the matter at its meeting this week. It was understood by Council that arrangements would be made to have the Advisory Planning Commission deal with the Major Roads Study report at its meeting this week, and that copies of the report would be distributed tomorrow to the members of the Commission so that they would have a chance to read the material before the meeting.

<u>Alderman Gunn</u> stated that his intention in the resolution Council passed on April 16th respecting the compilation of an inventory of all vacant land in the Municipality was to merely determine whether it was owned by private persons or the Municipality, or any other government agency, and was not intended to mean that the names of all owners was to be produced. It was also understood by Council, as a result of a discussion, that the initial report Council is expecting on the above matter is only supposed to indicate the desirability of having an inventory of the kind mentioned.

When <u>Alderman Gunn</u> enquired as to why a letter from Mr. Stuart Leggatt, M.P., concerning a proposed Federal Rail Relocation Bill was not on the Agenda, the Municipal Clerk replied that he had referred the item for consideration and report.

MOVED BY ALDERMAN GUNN, SECONDED BY ALDERMAN MERCIER:

"That the Planning Department submit a report to Council on any relocation problems for the railway along the South shore of Burrard Inlet, including costs and the inconvenience factor, if the aforementioned Rail Relocation Bill becomes law, with the Department to take into account the fact the Greater Vancouver Regional District has studied the matter in the past."

CARRIED UNANIMOUSLY

As a result of an enquiry by <u>Alderman Ast</u>, the Municipal Engineer indicated that he would submit a report on the matter of recycling waste paper that is presently carted away from the Municipal Hall.

As a result of an enquiry by <u>Alderman McLean</u>, the Municipal Engineer indicated he would determine why a number of unused power poles were still standing in the 4500 Block ^Barker Avenue.

When <u>Alderman Mercier</u> mentioned that the garbage collectors had refused to pick up a number of tree prunings from a home at Forglen Drive and Grafton Street, the Municipal Engineer stated that he would investigate the situation and take whatever action is deemed necessary.

<u>Alderman Mercier</u> gerved, a Notice that he would be introducing a Motion requesting the Lieutenant-Governor-in-Council to exempt the New Vista Society from the provisions of the Residential Premises Interim Rent Stabilization Act so that the Society can increase the rents on the dwellings it rents by more than 8%.

<u>Alderman Mercier</u> mentioned that some Cabinet Ministers for the Provincial Government had made certain statements concerning legislation that would exercise control over the development by Municipalities of its lands.

It was understood the situation would be checked and a report submitted on the matter.

Alderman Lewarne stated that he had received complaints concerning trucks and a crane parking at the Crest Shopping Centre overnight.

Municipal Engineer indicated he would investigate the situation and take whatever action is deemed necessary to rectify the matter.

When <u>Alderman Lewarne</u> enquired as to the situation in respect of the attempt by the Municipality to acquire Norm's Foodland property, the Manager replied that negotiations in that regard were still proceeding.

When <u>Alderman Ast</u> enquired about the progress in connection with the situation involving the Goodwin-Johnson site, the Planning Director replied that he was still waiting for the comments of the National Harbours Board on the matter.

Alderman McLean served a Notice that he would be introducing a Motion to Council relating to Outdoor Burning.

MOVED BY ALDERMAN STUSIAK, SECONDED BY ALDERMAN MERCIER: "That the Council now resolve itself into a Committee of the Whole."

CARRIED UNANIMOUSLY

REPORTS

MAYOR CONSTABLE submitted a report recommending that the four senior members of Council, of those who have indicated by May 12th their intention to attend the 1974 Convention of the Canadian Federation of Mayors and Municipalities, be appointed as the voting delegates from Burnaby and that their alternates also be appointed on the same basis. <u>Mayor Constable</u> stated that it was understood that the Mayor was always to be regarded as a voting delegate irrespective of his seniority with Council.

MOVED BY ALDERMAN STUSIAK, SECONDED BY ALDERMAN LAWSON: "That the recommendation of the Mayor be adopted."

CARRIED UNANIMOUSLY

CHAIRMAN, LANDLORD AND TENANT ADVISORY BUREAU submitted a report requesting that Council authorize an expenditure of approximately \$50.00 for the purpose of advertising the next meeting of the Bureau in the Vancouver Sun and in the Columbian.

MOVED BY ALDERMAN GUNN, SECONDED BY ALDERMAN LAWSON: "That the report be received."

CARRIED UNANIMOUSLY

MOVED BY ALDERMAN GUNN, SECONDED BY ALDERMAN STUSIAK: "That the request of the Landlord and Tenant Advisory Bureau be granted."

It was recommended that a letter of appreciation be sent to Mr. B. R. Wilkinson, Parks and Recreation Administrator, who is retiring on June 30, 1974, for his many years of loyal and dedicated service to the Municipality.

(4) Section 702(A) of the Municipal Act

The following was being offered as a result of a discussion with the Department of Municipal Affairs in connection with the captioned matter:

- (a) There must be an underlying zoning in place before the Section becomes operative.
- (b) The Section allows an overriding authority on zoning powers of , a Municipality.
- (c) The establishment of a development area is on the initiative of a developer but a Municipality can possibly approach a developer to ask for his plans and, at the same time, show him the plans the Municipality might have for the area.

- (d) The main purpose of the land use contract section of the Municipal Act is to handle complicated situations where
 it is not possible to accommodate every sort of use that is being proposed by developers for a zone.
- (e) Section 702A is intended to deal with individual development proposals that ordinarily could not be covered under existing zoning, and is also intended to cover a range of developments such as might be found in a large Comprehensive Development or mixed downtown commercial core, including high density residential, motels, commercial premises, etc.

The Section is not intended to deal with wholesale rezonings.

- (f) The designation of a development plan does not require a Public Hearing but a precise proposal does.
- (g) It was felt that there is no conflict with other sections of the Municipal Act in that nothing therein restricts the right of an owner to develop his land in accordance with the regulations of the Municipality applying to the zone in which the land is situate who does not enter into a land use contract with the Council.

MOVED BY ALDERMAN STUSIAK, SECONDED BY ALDERMAN MCLEAN: "That the report of the Manager be received."

CARRIED UNANIMOUSLY

(5) Brentwood House

(This item was dealt with previously in the meeting.)

(6) Contract #7405 - Asphaltic Concrete Supply

It was recommended that Council accept the tender of Columbia Bitulithic Limited for; the supply of asphaltic concrete for the amount indicated in the report, with final payment to be based on the actual quantities and the unit prices tendered and as may be adjusted to reflect the escalation of costs, as provided in the contract that is to be prepared to formalize the matter.
