CORRESPONDENCE AND PETITIONS

MOVED BY ALDERMAN STUSIAK:

Mr. R. A. Born, Deputy Municipal Clerk, The Corporation of the District of Maple Ridge, submitted a letter of challenge to the Mayor and Council of The Corporation of the District of Burnaby to compete against the Mayor and Council of the District of Maple Ridge in the Second Annual Raft Race down the Fraser River from Mission to Haney on Sunday, May 18, 1975. No action was taken on this correspondence.

Mr. Adrian Carrick, Executive Director, Canadian Cancer Society, British Columbia and Yukon Division, submitted a letter requesting Council's endorsation of the April Conquer Cancer Campaign. Mr. Carrick advised that the Society's volunteers will be canvassing during the week of April 14. The funds raised will be used to support cancer research, public education and help to needy cancer patients.

MOVED BY ALDERMAN AST:

SECONDED BY ALDERMAN LEWARNE:

"That this Council endorse the April Conquer Cancer Campaign of the Canadian Cancer Society, British Columbia and Yukon Division, as requested."

Mr. G. P. Woodside, 6808 Burns Street, submitted a letter complaining of the fact that on Tuesday, March 18, 1975, he had placed five heavy duty plastic bags of garbage out for pick up by Municipal forces. Only two of the bags had been picked up and the other three had been left. Mr. Woodside noted that he preferred the plastic bags to the "two handled" barbage cans which are referred to in the Garbage By-Law. On complaining to the Municipal Engineer, Mr. Woodside had been informed that the garbage crews were working to the "Two handled can" rule but he could not get an explanation as to why the garbage crews had taken only two of the five plastic bags which had been left for pick-up.

Mr. Woodside suggested that the "Burnaby Refuse By-Law 1967" be amended in keeping with more modern techniques and better sanitary conditions.

Item 8, Municipal Manager's Report No. 23, 1975, was brought forward for consideration at this time. The following is the substance of that report:

"The current 'Burnaby Refuse By-Law 1967' makes provision for the types of receptacles to be used by customers of the refuse service and is fairly restrictive in this regard. During the current labour situation some fairly strict interpretations were placed by the Union on what would constitute suitable receptacles and as a result plastic bags and cardboard boxes were not picked up in a number of areas, in spite of the fact that it has been Corporation policy for a number of years to pick up virtually anything set out on collection day.

The current problem has been resolved, at least for the time being, as a result of discussions with the Union Officials; they agreed and have the cooperation of their members to continue to pick up virtually all refuse at source according to customary practice.

With respect to the need of the revision of the by-law, there is noquestion of this. At the Council Meeting of 12 November, 1974 a number of points were put forth in Report No. 74, Item 21 wherein changes are required and warranted. One of the changes when the revised by-law is brought forth will certainly be to make allowance for picking up of plastic bags. The by-law will be revised and presented to Council as soon as discussions have been completed with Union Officials of Local 23."

It was recommended that a copy of this report be forwarded to Mr. G. P. Woodside.

- Mr. J. McRee Elrod, Minister, Westminster Unitarian Church, wrote to endorse Council's stand on the sale of Municipal property on Marine Drive to a Moslem Group for a religious centre.
- Mr. J. C. Rottluff, 8083 Gray Avenue, wrote to express adamant opposition to the sale of Municipal Land on Marine Drive to the Ismailia Community. Mr. Rottluff noted that a Public Meeting was being organized and that all members of Council would be receiving an invitation to attend this meeting to answer questions and to dispel many rumors and eliminate any fears about this project.
- Mrs. Maggie Burtinshaw, 2187 West 44th Avenue, Vancouver, B.C. wrote to request Council's endorsation of a resolution which she had prepared on the subject of gun control.
- Item 3, Municipal Manager's Report No. 23, 1975, was brought forward for consideration at this time. The following is the substance of that report:
- "Appearing on the Agenda for the April 1, 1975, Council Meeting is a letter dated March 10, 1975 from Mrs. Burtinshaw, 2187 West 44th Avenue, together with a copy of Senator Cameron's Bill S-15, being an Act to amend the Criminal Code (control of weapons and firearms), and a resolution that she asks that this Municipality adopt with respect to gun legislation.

She also asks in her letter for any statistical information that we might have in our Municipality as related to homicides for adults and juveniles. The Officer-in-Charge, Burnaby Detachment, Royal Canadian Mounted Police, submits the following statistics on gun usage in homicides in Burnaby during the past four years:

- *1971 Three homicides, only one involving a firearm. Victim was shot with a shotgun and subsequently burned.
- 1972 No homicides.
- 1973 No homicides.
- 1974 Four homicides. In one, a female was shot with a .303 rifle, apparently as a result of a domestic dispute.
- 1975 Two homicides to date. One involved shooting of a female with a handgun, apparently during a quarrel.

Each of these gun incidents related to adults with no known juvenile involvement.

The Solicitor General of Canada has had the matter of gun legislation under review for some time, and the matter is still under review by this department. We certainly favour controlling legislation but no one seems to have come up with a practical control program. Some aspects of the resolution proposed by Mrs. Burtinshaw are not in our opinion practical, whereas some of the other aspects are practical control measures. We are, therefore, reluctant to recommend that the resolution be adopted in its present form. We are, however, recommending that the principle of much improved gun control be supported and from that point we can support her resolution 'in principle'. This is obviously a very complex problem and we are not competent to go into the matter in greater depth."

It was recommended that:

- (a) We do not feel that all of the control measures covered by the resolution of Mrs. Burtinshaw are practical, but we do support "in principle" the resolution proposed by Mrs. Burtinshaw;
- (b) A copy of this report be forwarded to Mrs. Burtinshaw.

ENQUIRIES

Alderman Lewarne inquired as to whether completion of landscaping requirements was a condition to the issuance of an Occupancy Permit on a commercial or industrial building. Alderman Lewarne noted that during a recent visit to the Insurance Corporation of British Columbia Claim Centre on Wayburne Drive he had noticed that no steps had been taken to landscape the grounds surrounding the Claims Centre and, in fact, nothing had been done to clean the grounds up following construction. Alderman Lewarne was of the opinion that the Insurance Corporation of British Columbia should be reminded of the necessity for completing the landscaping without delay.

The Director of Planning advised that completion of landscaping requirements was not normally a condition of occupancy and cited the problems in reference to winter occupancy when it could not be possible to carry landscaping requirements.

(9) Letter dated March 12, 1975, from Mr. John H. Bradbury, 4118 Edinburgh Street -Dumping of Material in Montrose Park

The points brought out by Mr. Bradbury were noted, our Engineering staff visited the site, investigated the complaint with our Super-intendent, and we report as follows:

- (a) Mr. Bradbury was correct in his observation with regard to the truck and it was in fact from the Engineering Department.
- (b) Our sewer crew was not dumping the excavated material indiscriminately and not on the Park property, but on the road allowance. Only two small piles of material were dumped which have now been levelled out, totalling perhaps six or seven cubic yards; there is some broken asphalt, but no old pipe or splintered wood are in evidence.
- (c) The "No Dumping" sign was placed primarily because groups of automobile strippers were demolishing vehicles and dumping the left-over bodies. The Royal Canadian Mounted Police had difficulty apprehending these culprits because of poor access over the road allowance. They requested our Roads Foreman to dump and spread any surplus road material so that they could have access to block the escape of the gangs involved.
- (d) We appreciate Mr. Bradbury's concern and will take necessary steps to prevent indiscriminate dumping with special emphasis on deleterious material and refuse. We believe the area in question is currently in good enough condition generally for the Royal Canadian Mounted Police to gain access to the area and the Engineering Department has no intention of depositing further material in this area.

It was recommended that:

(a) The "No Dumping" signs remain at both the Boundary Road and Gilmore Avenue ends of Montrose Street and that no further dumping of any type, including Municipal, be permitted;

 - (d) A copy of this report be forwarded to Mr. L. Carlisle, Port Engineer, and Mr. George Ross.

The Director of Planning has submitted a report in some detail on an application received on March 6, 1975, to convert a gas station to self-service station. As all applications to convert would be handled through the Preliminary Plan Approval process, the Director of Planning is requesting direction of Council as to whether or not Council is interested in receiving reports, similar to the one in question, in future. The question is, with Council having defeated a motion to call for a report on self-service station, is it still necessary to report on any applications made for conversion. It may well be that when Council passed the motion on asking to be advised of all self-serve conversion applications, that it was intended to be an interim step only until the notice of motion in this respect had been dealt with.

It was recommended that the motion adopted by Council on March 17, 1975, regarding conversion of gas stations to self-serve stations be rescinded.
