Re: I.I.P. on Victory Street - Boundary Road to Joffre Avenue Letter from Mr. W.C. Downs which appeared on the February 10, 1975 Council Agenda

On February 10, 1975, Council received a letter from Mr. W.C. Downs regarding the proposed construction of a sidewalk on Joffre Avenue (the report on this proposed work was tabled until March when Council will convene in a special meeting for the purpose of reviewing the 1975 Local Improvement Programme). Also of concern to Mr. Downs and his neighbours is the proposal for construction of sidewalks on Victory Street from Boundary Road to Joffre Avenue (see attached petition). Following is a report from the Municipal Engineer on the latter matter.

## RECOMMENDATIONS:

- 1. THAT Victory Street between Boundary Road and Joffre Avenue be deleted from the 1975 Local Improvement Programme; and

The Municipal Clerk has received a petition containing the names of a large percentage of the residents on Victory Street between Boundary Road and Joffre Avenue. The petition is asking that this section of Victory Street be removed from the 1975 L.I. Programme.

With Council Initiatives, there is a certain attendant amount of administrative time and costs. The time and costs would be wasted if the residents are already opposed to the project. It appears to the Engineering Department, because of the preponderance of signatures on the petition, that a Council Initiative on Victory Street would be an exercise in futility.

## RECOMMENDATIONS:

- 1. THAT Victory Street between Boundary Road and Joffre Avenue be deleted from the 1975 L.I. Programme.
- 2. THAT a copy of Council's decision be forwarded to all residents within the project boundaries.
