THE CORPORATION OF THE DISTRICT OF BURNABY BYLAW NO 6689

The proposed bylaw relating to parking at Kingsway Branch Library was prepared by the Municipal Solicitor and has been approved by the Burnaby Public Library Board at its meeting held 17 July 1975. The number of parking spaces available to library users has been reduced by 22 spaces (from 58 to 36) as a result of the construction of a new apartment building behind the library. Although the number of parking facilities will be increased when construction is completed, the present situation has resulted in a number of complaints from readers who are unable to find space to park as both staff parking and public parking are being used by workmen on the construction site, by visitors to Edmonds House and by employees of local businesses as an all-day parking place. The proposed parking bylaw was drawn up after consultation with the Planning and Engineering Departments at the Municipal Hall.

The RCMP Burnaby Detachment, Traffic Section, have confirmed their willingness to enforce this proposed bylaw.

#### RECOMMENDATION:

THAT Council consider Bylaw No 6689 for adoption.

THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 6689

A BY-LAW to regulate the parking of vehicles within a public place, being the lands occupied by the Burnaby Kingsway Branch Public Library.

The Council of The Corporation of the District of Burnaby ENACTS as follows:

- 1. This By-law may be cited as "BURNABY KINGSWAY BRANCH PUBLIC LIBRARY PARKING REGULATION BY-LAW 1975".
- 2. In this By-law, unless the context otherwise requires
  - "library" shall mean the Burnaby Kingsway Branch Public Library situated at 7252 Kingsway;
  - "library patron" shall mean a person who parks his vehicle for the sole purpose of then entering the library and using its facilities;
  - "marked" shall include signed, posted or otherwise designated;
  - "parking space" shall mean that space between parallel painted lines where a vehicle may be parked.
- 3. The provisions of this by-law shall be in force and effect within the lands occupied by the Burnaby Kingsway Branch Public Library, 7252 Kingsway, shown outlined in red colour on the plan hereunto annexed.
- 4. No person except the person entitled shall park a vehicle in any parking space marked "Assigned Staff Parking Only".
- 5. No person, except a library patron, shall park a vehicle in any parking space marked "Library Patron Parking Only".
- Where a sign is erected limiting the time during which a vehicle may be parked in any parking space, no person shall park a vehicle in that parking space for a greater length of time than that limited by the said sign.


- 7. No person shall park a vehicle
  - (a) where parking is prohibited;
  - (b) adjacent to a yellow painted curb; or
  - (c) in such manner that the parked vehicle occupies more than one parking space.
- 8. Any vehicle parked in violation of any of the provisions of this by-law may be removed, detained or impounded by an authorized contractor and the owner of the said vehicle shall pay to the said contractor, before the said vehicle is returned to his possession, all of the costs of such removal, detention or impoundment which are authorized by this by-law and set out in Schedule "A" annexed hereto.
- 9. Every person who violates any of the provisions of this by-law shall be guilty of an offence and shall be liable to pay a fine of \$10.00.



### SCHEDULE "A"

(a) For the impounding and removal of a vehicle to a place of storage

\$ 7.00

(b) For attending to remove an impounded vehicle but before it is removed the owner or person in charge thereof requests that the vehicle be delivered to him

\$ 5.00

(c) For the storage of a vehicle

\$ 1.25 per day for the first three days and

\$ 2.50 per day thereafter.
