MARY A. DALLYN THAT APPEAR ON THE AGENDA FOR THE APRIL 12, 1976 MEETING OF COUNCIL BOUNDARY ROAD

Contained in the subject correspondence are expressions of concern from residents on Boundary Road regarding traffic and improvements that have been proposed for this route. Council will recall that this matter was the subject of a report that was received on March 29, 1976 (Item 20, Report No. 20), and that the following recommendation was adopted at that time:

- "1. THAT Vancouver City Council be requested to:
 - (a) Not proceed with the proposed intersection redesign
 - and construction at Boundary Road and S.E. Marine Drive.
 (b) Provide the Municipality of Burnaby with an estimate of additional truck traffic that is proposed for diversion to this route, together with a report on the likely environmental impact of this additional truck traffic on adjacent residential areas ...
 - with the understanding that discussions will be initiated with the City of Vancouver upon receipt of the requested information ... "

The nature of the proposed changes involving Boundary Road suggests that Council will continue to receive letters from concerned residents on this matter. Because Council will have nothing further to consider between now and the time that a report can be submitted on discussions that are expected with the City of Vancouver, it is recommended that all correspondence received during this period be placed on the agenda and then acknowledged with a copy of Item 20 and a letter advising that Mr. Basil D. Whitehead has addressed Council as the spokesman for residents in the area (so that Mr. Whitehead can be contacted by correspondents if they desire to do so).

RECOMMENDATIONS:

- 1. THAT all persons who write to Council on improvements and proposed traffic changes on Boundary Road between now and the time that a further report is submitted be:
 - (a) sent a copy of Item 20, Report No. 20, March 29, 1976;
 - (b) advised that Council will consider this matter again in connection with a future report from staff;
 - (c) advised that Mr. Basil D. Whitehead has appeared before Council as a spokesman for Boundary Road residents; and
- 2. THAT such an acknowledgement be sent to Ozzie and Lorie Hyland, the De Cosmos Village Housing Cooperative and Mary A. Dallyn; and
- 3. THAT copies of all future correspondence pertaining to Boundary Road be referred to the Planning Department for study, and if appropriate, inclusion in a subsequent report that will be submitted for the consideration of Council.
