Seven bids were received and opened in the presence of Messrs. Constable, Hagen and representatives of the firms bidding.

A tabulation of the tenders received is attached.

The sum of \$130,000.00 has been provided in the 1976 CIP budget account #35-01-105.

A thorough review of the tenders received indicates that tenders numbered 1, 2, 2A, 4B, 5, and 5A offering Mack, Ford and International trucks respectively, do not satisfy our specifications. The lowest priced vehicle to meet or exceed the specifications is the Kenworth Hustler II. We are offered three types of refuse bodies, Heil FEL 30 (\$22,780.00), EZ Pack FL60-B (\$22,500.00) and Dempster DP45-31C (\$22,800.00). In this regard members of the Engineering Department have viewed and discussed with representatives of large firms operating locally and in Seattle, where the large majority recommend Dempster DP45-31C bodies.

The Dempster body is also capable of compacting and carrying approximately one cubic yard more than their competitors' equipment. Operating cycles are also quicker. Two companies have offered to supply Kenworth Hustler II trucks complete with Dempster DP45-31C refuse bodies. They are tender number 4, Amalgamated Metal Industries Limited, local supplier for Dempster refuse bodies and tender number 7A, Inland Kenworth Sales Limited, local supplier of Kenworth trucks.

Their tender totals for two complete units are identical, \$118,671.56. There are no strong feelings between the two companies with respect to this order. The staff consider that with respect to warranty items the Municipality's interests would best be served by dealing with the refuse body supplier.

The Municipal Engineer concurs with the recommendation.

## RECOMMENDATION:

THAT a contract be awarded to Amalgamated Metal Industries Limited for the supply and delivery of two 1976 Model Kenworth Hustler II trucks complete with Dempster DP45-31C refuse bodies for the sum of \$118,671.56.
