Tenders for this project were received up to 3:00 p.m. local time, Tuesday, January 27, 1976.

The work includes the installation of approximately 11,700 lineal feet of storm sewer in pipe sizes ranging from 8 inch diameter to 24 inch diameter, as well as all necessary appurtenances, house connections and other related work.

On January 26, 1976 Council approved the award of Contract #7601 which was the first of a series of contracts being called to implement the construction of storm sewers approved under loan authorization Bylaw #6706. Contract #7602 is the second in the series. The streets to be sewered under Bylaw #6706 are listed below and those streets included in Contracts #7601 and 7602 are so marked.

Streets which are not marked above are scheduled for inclusion in Contract #7603 which will be tendered shortly.

A report recommending approval of a work order for Contract #7602 appears on this agenda under a separate item. The Engineer's estimate of the tendered amount was \$407,000; however, as in the case of Contract #7601 the high interest generated by this tender resulted in competitive bidding and the revised estimate for the overall cost of the work, including work by others, and overhead charges is \$415,800. Bylaw #6706 has \$1,538,000 available for construction purposes of which \$399,600 has been committed by Contract #7601. If the current price trend continues through tender #7603 the Bylaw funds should more than cover the cost of all the schedules projects. A more definite financial picture will be apparent after closure of the third tender following which a further report will be presented to Council.

This project is to be completed within eighty (80) consecutive working days after commencement of construction.

Twelve tenders were received and opened in the presence of Messrs. Constable, Hagen, and representatives of the firms bidding.

A tabulation of the tenders received is attached.

The Municipal Engineer and the Purchasing Agent recommend the following:
