The Municipal Engineer advises that based on the price which has been obtained for the work to be done under Contract #7601, all work to be done under By-law 6706 will be completed as scheduled.

1. THAT the lowest tender in the amount of \$321,463.90 submitted by Arthon Construction Ltd. be accepted with final payment to be based on actual quantities and the unit prices tendered.

BY-LAW 6706

Tenders for this project were received up to 3:00 p.m. local time, Tuesday, January 20, 1976.

The work includes the installation of approximately 10,600 lineal feet of storm sewer in pipe sizes ranging from 8 inch diameter to 18 inch diameter, as well as all necessary drainage appurtenances, house connections and other related work.

Contract #7601 is the first of a series of contracts being called to implement the construction of storm sewers approved under loan authorization By-law #6706. The By-law is drawn for \$1,580,000, which includes 3% for expenses on sale of bonds, which leaves \$1,538,000 for construction purposes. The streets to be sewered under By-law #6706 are listed below and those included in Contract #7601 are so marked.

In addition, Contract #7601 includes Humphries Street from 16th Avenue to 19th Avenue in order to provide a sewer outfall for 19th Avenue.

A report recommending approval of a work order for Contract #7601 appears on this agenda under a separate item. The Engineer's estimate of the tendered amount was \$430,000, however, the high interest generated by this tender resulted in competative bidding and the revised estimate for the overall cost of the work, including work by others, and overhead charges is \$399,600.00.

This project is to be completed within seventy (70) consecutive working days after commencement of construction.

Fourteen tenders were received and opened in the presence of Messrs. Constable, Hagen, Sinclair and representatives of the firms bidding.

A tabulation of the tenders received is attached.

The Municipal Engineer and the Purchasing Agent recommend the following:
