RE: KAYMAR RAVINE EROSION CONTROL PROJECT (REFERENCE LETTER FROM SAPPERTON FISH & GAME CLUB)

The Sapperton Fish & Game Club wrote to the Engineering Department by letter dated 17 September, 1976 with copies to the Parks & Recreation Commission and to the Municipal Council. We have been requested to report on this letter.

There is not a great deal to be said about the submission from the Sapperton Fish & Game Club inasmuch as the concerns expressed by the Club have been fully considered by the British Columbia Fish and Wildlife Branch and, in turn, their concerns have been transmitted to the Consulting Engineer and the Municipal Engineering staff (reference Municipal Manager's Report, Item No. 22, Supplementary, Report No. 58, Council Meeting of 20 September, 1976).

The Fish and Wildlife Branch has decided to accept the agreed upon measure to converting the outlet chamber into a sedimentation chamber. The conversion work has now been completed to the chamber and the work in the watercourse itself has been resumed. Through constant visual observation by the Contractor, the Consulting Engineer, and the representative from the Fish and Wildlife Branch, it is considered that there will be no further disruption in the work schedule.

RECOMMENDATION:

THAT the Sapperton Fish & Game Club be provided with a copy of this report and also of Item No. 22, Supplementary Manager's Report No. 58, Council Meeting of 20 September, 1976.
