### (b) Mr. V.J. Blancard

Mr. Blancard appeared before Council and advised that he moved into Burnaby this year after having been a resident of Vancouver for the past 45 years, and was surprised to find that the licensing fee for dogs charged in the Municipality was \$ 21.00 per annum substantially above other areas such as the City of Vancouver \$ 6.00, West Vancouver \$ 10.00, White Rock \$ 10.00. Mr. Blancard recognized the problems of dog control in the community and indicated that they kept their dog under control and recently fenced their yard and can see no reason for the fee of \$ 21.00 under these circumstances.

It was suggested that Council review the question of dog licensing fees. It was indicated that the dog was a pet to the family and that there probably were many more families in Burnaby in the same situation.

In summary it was suggested that the rates be reviewed by Council and that the fee for dog licenses be lowered and the fines for dogs running loose be increased.

(c) Conference of Local Area Councils
Re: Crosstown Bus Via Gilpin-Moscrop

Mr. Elgin J. Ruddell, Chairman, appeared before Council and spoke to the following brief:

"Your Worship and Members of Council:

On behalf of the Traffic and Transit Committee of the Conference of Local Area Councils, co-operating organizations and thousands of individual petitioners we are here to present our petition for a new crosstown transit service. The petition is as follows:

WHEREAS There is no East-West Bus service in Vancouver between Broadway and 41st Avenue., a distance of approximatley 2 1/4 miles; and there is no East-West Bus service in the West side of Burnaby between Lougheed and Kingsway, a distance of approximately 2 1/2 miles.

AND WHEREAS A Streetcar and a Bus service did exist on some parts of King Edward Ave., 25th until the middle 1950's.

AND WHEREAS In a 1971 report by the Greater Vancouver Regional District (G.V.R.D.) which was approved by the GVRD board of directors it stated "A... route is suggested along East 29th Ave. and Moscrop in Burnaby ... the installation of a crosstown route along King Edward Ave. would permit a finer grained transit service..."

AND WHEREAS The proposed Bus line would provide an integrated crosstown service for U.B.C., B.C.I.T. and many other educational institutions, as well as for Hospitals, Recreation centres, Churches Synagogues, Burnaby Municipal Hall, Heritage Village and Shopping Districts.

THEREFORE BE IT RESOLVED THAT we invite residents, students, and public and private organizations to add their names to this petition. And that this petition be presented to the Vancouver City Council and Burnaby Municipal Council.

At the outset it is gratifing indeed to note your Transportation Committee in its report to Council dated June of this year selected the Gilpin-Moscrop route as one of three for early implementation. In our opinion this becomes more meaningful when linked to the Vancouver portion of the proposed route.

It should also be noted the G.V.R.D. (Sullivan Report 1971) approved in principal the main segments of our proposal. We have merely linked them up with appropriate destinations to provide a logical and efficient route to serve more than 100,000 people in Burnaby and the metropolitan area who live or work near the proposed route.

This service would be of particular benefit to students. In the case of Burnaby Central and Moscrop Secondary Schools access will be much improved during the day with the important addition of evening service. Elementary Schools will also benefit. For BCIT students this route is essential as there is no viable public transit available to most of the student body. For UBC students especially those living in central Burnaby and eastern parts of Vancouver it would be a real boon for both credit courses and extension study programs.

Other people who will benefit are those living or working in areas served by the route. As well many people would make a greater use of the Community Institutional and Recreation facilities in the central Burnaby Administrative Area. This service will improve access and reduce travelling time to the Burnaby General Hospital and to the medical institutions in Vancouver (Shaughnessy Hospital etc.).

We have submitted our petitions for the inspection of the Municipal Clerk and we declare the number of signatures collected to date as follows:

Burnaby 1644 signatures Vancouver 9788 signatures Other 409 signatures

Total 11841 signatures

We will be presenting this petition to the City Council of Vancouver in the near future.

We would appreciate it very much for this Council to take appropriate actions to have this new bus service operational.

(d) Mrs. Virginia Stelp
Re: Sidewalk on Mary Avenue and Access to Property

Mr. T.B. Stelp appeared before Council and advised that his wife was unable to attend this evening. Mr. Stelp then reviewed their recent submission under date of August 26th concerning the sidewalk the municipality is putting in front of their residence and the difficulties encountered in attempting to move the driveway from where it is presently located.

It was indicated that a staff report would be available at the September 7th meeting of Council.

The Municipal Engineer indicated that in the interim both proposed driveway locations could be left as is with only the forms in place.

(e) Mr. H.G. Hrynyk
Re: Encroachment On Central Park

Mr. Hrynyk appeared before Council and spoke to the following brief:

"I am a citizen and taxpayer of Burnaby. Recently I was greatly disturbed by what seems to be an utter flagrent disregard for the law by someone or some department within our municipal administration. I am referring to the encroachment on Central Park on the south-west

It is hard for me to conceive that with the size of our legal department at your disposal, Council did not communicate with that department in order to find out if it had the right to send bulldozers within the boundaries of Central Park on August 19th. It should be a routine procedure. It is even harder for me to understand when it was brought to Council's attention on August 10th by a group of concerned citizens through a letter from Legal Aid Lawyer, David Mossop, that it would indeed be illegal to start any work within the park. This was later affirmed by the Minister of Environment, James Neilson, when he ordered Burnaby to restore the park to its original condition. As I understand it, if Burnaby does not comply to the Minister's order then the Provincial Government will send in a crew to repair the damage and send Burnaby the bill. The end result is that the taxpayer will pay twice, once for the ripping up of the park and then again for restoring it. The matter has reached the point where it would be funny if it were not so serious. I cannot see why the Municipal administration can violate the law when they expect their citizens to uphold the same law. As a taxpayer in Burnaby it does appear to me that my tax dollars are being spent in a very wanton and haphazard manner.

I attended last week's Council meeting at which was passed the intersection improvement for the north and south sides of Kingsway on Boundary Road. One of the members of Council stood up and assured the concerned citizens that this improvement did not represent in any way the thin edge of the blade in any future widening of Boundary

Road, Yet, in the Manager's Report #52, Item 31, page 210 to the Parks and Recreation Administrator from the Director of Planning, Section C asks the Question: Was the expanded intersection predicated on a six lane road?

The third line reads: The expanded intersection considered the possibility of an overall improvement Boundary Road facility with two travel lanes in each direction with parking. It appears to me and other concerned citizens that the intersection improvement is the thin edge of the blade, and there is no doubt about it.

Politicians are ruining our environment by their destroy and pave methods under the guise of progress. Burnaby Council appears to be no different.

Central Park is one example and the Nelson-Wayburne diversion thru Forest Glen Park in another. Count it be that our Parks are actually land bans for future roads and highways? Progress today is clean air? Less noise and more parks — not the destruction of our Parks to accommodate more noise and dirty air generated by Diesel Exhausts.

Lougheed Highway, Trans Canada, Canada Way and Kingsway all rip east-west thru Burnaby and have already made Burnaby a series of traffic islands. If you look at a map of the Lower Mainland you will see quite readily that all are support roads for the Port of Vancouver. Now the Vancouver Planners are quite skillfully it seems manoeuvering Burnaby Council to take their north-south traffic flow from Vancouver Streets. For this honour we are to throw in tax dollars and a piece of our park.

Mr. Chairman -- I can see it now -- the next election campaign slogan: "Support the Port of Vancouver - Pave Burnaby"

Why should more Burnaby land be used and tax dollars be spent to service the Port of Vancouver? Why should Burnaby Tax Dollars be used to subsidize trucking companies carrying international cargo from the Port by giving them free roadbeds thru our parks and residential areas? What financial relief do we taxpayers in Burnaby get for being so generous?

Central Park in our major park. If Vancouver wants another northsouth truck corridor, and their engineers tell us they are considering the use of every north-south street on the Lower Mainland then let them start at U.B.C. and work east from there. Is the land west of Angus Drive sacred?

The time has come to tell Vancouver that Burnaby tax dollars will not be spent anymore to service their Port. When will you Politicians realize that a serious study of the transportation of goods has to begin now.

The citizens coalition of Transportation has made considerable progress and will host a conference in Vancouver on this matter the last week in September. Federal Cabinet Ministers Barney Dansan, Minister of Urban Affairs and Otto Lang, Minister of Transport have been invited. I would like to see Council indicate a serious appreciation of the problem and send representatives to this conference.

In the minutes of the Vancouver City Council meeting on August 10th, Council moved that the City Engineer be instructed to defer indefinitely letting the contract on the widening of the south side of Boundary Road to provide Council an opportunity to discuss the whole question of Boundary Road with the Citizens, Burnaby Council and the Vancouver Parks Board. I now ask the Burnaby Council to afford the same consideration to its citizens on this issue.

I also understand that Burnaby Council has a commitment to B.C. Telephone dut, Mr. Chairman, what commitment is greater than the one that Council has to its citizens."

## (f) United Non-Smokers Society Re: Burnaby No-Smoking By-Law

Mr. Larry Wanjoff, President, United Non-Smokers Society appeared before Council and spoke to the following brief:

"As over 60% of the general population of Canada does not smoke, we feel that it is important that consideration be given to non-smokers rights so that they can live their lives without being affected by tobacco pollution.

According to information provided by the British Columbia T.B. & Christmas Seals Society, there are over 40,000 people in the Lower Mainland area whose personal health seriously suffers when exposed to tobacco and other smoke, even for a short time. Is it right for these people to be forced to stay out of theatres, shopping centres, hospitals, and even Doctors' waiting rooms because the interior air has been polluted by a small minority of smokers? Further, there are hundreds of thousands of people who intensely dislike the stink of tobacco pollution in the air, in their hair, and on the new clothing they just bought.

There is a groundswell of support for the banning of smoking in public areas for the comfort, health and safety of all people. We realize that in larger facilities, there should be areas set aside for the specific use of smokers and we fully support the establishment of these areas so long as they do not prevent the use of any facility by a nonsmoker. We would like you to act within your responsibility to assure the mose important right of life -- the Right to Breathe!

We have enclosed a copy of a draft by-law proposal in regards to this issue. It is not a firm stand by the Society but its purpose is to inform you of what we feel is needed. Also included is a digest of the existing legislation in the United States as compiled by the Action on Smoking and Health group. It should point out to you that strong legislation does exist to protect Non Smoker's rights. We hope that this may be of valuable use in drafting of Burnaby's Smoking Regulation By-law.

The next brief we have included is a copy of the summary of "The Report of the Task Force on Smoking and Health" which was prepared for the Government of the Province on Ontario. It is the only Canadian government report that has carried out an extensive effort to analyze the problems that smoking causes to our society. The cost of reproducing the report prevented its inclusion in this information brief but we will make it available to you if you contact the United Nonsmokers Society at 228-0525.

Finally, we have included letters of support from the major businesses in Burnaby which we hope have been brought to your attention previously. There is strong support from the business sector for a good No Smoking By-Law.

We ask that you use this information to the best of your ability to provide the people of Burnaby with the needed protection."

Considerable definitive cost data on the several alternatives using Royal Oak or realigning it should be developed so that we know what is involved before a decision is made to select one alternative on the Royal Oak alignment or realignment."

A letter under date of August 13, 1976 was received indicating the closure of these streets is not accomplishing the rerouting of the daily traffic and also during the weekend and evenings they get a steady movement of traffic which they never had before on Crestlawn. Also the lane between Crestlawn and Springer is used as a short cut.

The Municipal Manager reported that a further report would be submitted by staff following an evaluation of the results of traffic flows and related conditions being monitored for one month. It is anticipated that Council will receive this report on September 7, 1976. Further information is expected to be available for referral of all correspondence and petitioners who have written to Council on this matter.

It was recommended that a copy of this report be sent to Mr. F. Batscheider and persons whose signatures appear on the attached petition.

- 3. The rates applicable to the program be those shown on page 3 of this report, amended to reflect a 60% share of the cost to be borne by abutting owners and that Burnaby Local Improvement Charges By-law 1976 be amended accordingly; and
- 4. It be recommended to the 1977 Council that in the event the local improvement on Norland between Douglas and Laurel passes, the sum of \$166,000 be advanced from the Reserve for Capital Works and that the preloading of Norland between Laurel and Sprott be undertaken on the route shown on the attached sketch; and
- 5. As soon as the Engineer determines whether or not concrete curbs and gutters should form part of this work, a local improvement should be put to form part of the local improvement program for 1978; and
- 6. The money advanced from the Reserve for Capital Works be repaid upon passage of said local improvement; and
- 7. The \$185,000 required for storm drainage works on this project come from Burnaby Loan Authorization By-law No. 1, 1976, By-law No. 6861, subject to a further report.

The Municipal Manager provided a report on events to date relating to the above-noted subject wherein it was indicated that on May 27, 1976 the

Land Agent wrote the Director of Lands requesting transfer of the land required to the Municipality.

On 8 June 1976, a reply was received from W. A. Taylor, Acting Surveyor General, asking that a reference plan under Section 106(d) of the Land Registry Act be prepared. The last paragraph of the letter reads:

"The Surveyor General will sign the plan as an Official Plan and it will be deposited by this office in the usual way. One original linen plan is required."

This the Municipal Engineer took to be his authority to proceed. The work was included in a tender awarded to Jack Cewe Ltd. on 5 July 1976. The work was one of 14 projects. At the moment, excavation has taken place along the 580 foot tapering strip to a width into the park at its maximum point of approximately 7 feet. \$3,639.33 has been expended to 20 August.

On 20 August 1976, Mr. Jim Neilsen, Minister of the Department of the Environment advised Mr. V. J. Kennedy, Deputy Municipal Engineer, by telephone "that the Surveyor General did not have the authority to give us the indication that he did in his letter 3 June, 1976, that he would sign the plan required as an official plan for the widening of Imperial Street." Mr. Neilsen further advised "that his legal advisors were of the opinion that the approval could not be given for the widening of Imperial Street without an amendment to the Central Park Act, and furthermore that the reference in the Central Park Lease Agreement to the use of portions of the park for road purposes was invalid."

This was followed up by a telegram dated 20 August 1976 which reads:

"Approval to create a turning lane within Block A of Lot 2 of District Lot 151, Group 1, N.W.D., Plan 3443, has not been granted. Please refrain from any further construction work within the boundaries of Central Park and restore the land to its natural condition."

The work stopped forthwith.

It will cost about \$2,000 to replace the topsoil and seed grass within the Park area.

The Central Park Agreement provides that there is reserved to the lessor (the Province) the right to enter and take for highway improvements or relocation purposes certain park lands. For this we require permission from the Province.

If the Minister is correct, and the Province Cannot give permission, then we must prevail upon the Minister to seek the necessary enabling legislation.

Under the circumstances, an early meeting should be had with the Minister to ensure that he is in possession of all of the facts as we see them.

It was recommended that an early meeting with The Honourable J. Neilsen and his advisors be sought.

Trimble and Sons Ltd. have spared no expense nor the provision of manpower in the successful effort of completing this clean up.

22. Vibration Complaint / Transmountain Pipeline Co. Ltd. Westridge terminal.

The Municipal Manager provided a report from the Chief Public Health Inspector containing information on vibrations from the Westridge Terminal. It was indicated that the Invisaflare was in operation and apparently the cause of vibration to the immediate area. It was stated that the flare was in use due to a plant shut down. The shut down was necessary for general plant maintenance and specifically repairs to an aboveground pipeline located at the dock area. An attempt was made to eliminate the vibration by reducing the flare fan speed. This action resulted in an immediate reduction in the vibration to the area with no visible change in emissions. The Assistant Supervisor of Transmountain was advised not to increase the fan speed for the Invisaflare.
