3. THAT the bid in the amount of \$35,275.00 from Kamo Construction for Lot 162, Blk. 13 of Lot 13, Group 1, Plan 48380 - 9110 Wilberforce Street be accepted; and

4. THAT the bids from K.B. Williams in the amount of \$28,599.00, Khubis Chand in the amount of \$26,000 and Elizabeth Rye in the amount of \$39,600 be rejected and the deposits returned accordingly; and

5. THAT the Land Agent be authorized to negotiate the sale of the lots on which no bids were received, together with those lots on which bids were received but not deemed suitable with the understanding that the results of any negotiations in this regard will be referred back to Council for consideration and concurrence, and subject to the further understanding that these lots will be re-advertised when we advertise additional property for sale providing that these lots have not been sold by that time.
