### MINUTES

#### a) Mr. Charles H. Petrie

Mr. Petrie appeared before Council and spoke as follows:

"Being the owner of the above property, abutting the Keith Street Ravine Park, I respectfully request Council to institute a program to stabilize the banks of this ravine.

The Municipal drainage ditch from the back lane, north of our

property, discharges some 20 feet west of our eastern property line, and has undermined this entire north eastern area of our garden. Cracks have appeared in the retaining walls and also in the concrete patio surrounding the swimming pool. The concrete patio has settled approximately 8 inches, and our fence is slowly disappearing into the ravine.

It appears that the whole eastern slope of the ravine is gradually slipping, undermining our swimming pool area and also causing dangerous holes to appear in the north-eastern area of our lawn, as much as twenty feet within our property line.

We hold the municipality responsible for the drainage ditches, ravine, and the safeguarding of our property. We do not request a decrease in our assessments, but rather the assurance from the municipality that corrective measures will be undertaken to prevent further loss to our property.

We therefore request that remedial action be taken before any further damage occurs to our property."

### b) Mrs. Mary-Ellen Dale

Mrs. Dale appeared before Council and spoke as follows:

"I am Mary-Ellen Dale, I live in Burnaby, and I represent a group of concerned parents of Douglas Road School children. We protest that you are not taking effective action to make safe the potential death trap which exists at the junction of Canada Way-Douglas Road-Sprott Street. The great majority of our children must cross this extremely dangerous triangle intersection every day that they go to school.

Recent action to date is this: a somewhat larger sign denoting a school crossing has been erected, a different overhead sign has been put in bearing a traffic signal symbol and the words '600' ahead'. Both of these improvements have been installed on Canada Way for east-bound traffic approaching the Douglas Road cut-off. Two hoods were placed on the green arrow lights for west-bound traffic on Canada Way at the Douglas Road. Note that there is NO school sign for west-bound traffic and that this is the traffic most often involved in accidents at this corner. A new 'No Right Turn' sign was placed on Douglas Road for traffic approaching Canada Way. Note also, that this is the corner where 2 serious collisions occurred on Friday afternoon between 1:30 and 2:15. One car went through the fence and into the school yard. I have photos of the intersection taken after these collisions.

Our committee has been told in separate conversations with the RCMP Detachment in Burnaby - 1. That optic lenses have been ordered for the green arrow lights. These are to come from a firm in London, Ontario, and no dates were available for the order or for delivery; and 2. That flashing overhead lights were to be recommended for east-bound traffic on Canada Way, approaching the Douglas Road intersection. We are also informed by Engineering and by pamphlets supporting the recently defeated referendum that the only proposal for Sprott Street is that it be widened. AT NO TIME did the parents ask for these adjustments and revisions.

These solutions are totally unsatisfactory to our parent group on a long term basis; and acceptable only as interim measures until a pedestrian overpass can be designed and built.

At a meeting with Alderman Ast, Mr. Bacon of Engineering, Cpl. Bishop and Staff Sgt. Marchuk, our committee was told that statistics show that changes to the lights, such as those mentioned earlier, do not

help; in fact, in this particular intersection, the changes previously made have added to the existing confusion; also, that statistics show the flashing overhead lights warning motorists to prepare to stop, do, in fact induce them to increase speed in order to beat the light. Canada Way at Burris Street was given as an example.

If the widening of Sprott Street is effected here, the situation will immeasurably worsen. Already more than 30,000 cars a day pass through this junction. Three of our children have been injured this year. We insist that you recognize that the only possible solution is to get our children off the road and onto a pedestrian overpass. We have a copy of a letter to Mr. Bacon from ICBC stating that they are in favour of a pedestrian overpass here; we have a letter from a local trucking firm stating that they are in favour of this overpass; and we have more than 800 signatures on petitions in favour of an overpass here. Must a death occur before you take action? We further insist that you view these intersections for yourselves as pedestrians, and demand that an immediate date be set up with our committee this evening.

When we read the proposal for a pedestrian overpass to span Canada Way at Ledger Avenue, linking the Municipal Hall with the Marathon Realty complex, we were OUTRAGED! Why is the convenience of political administrators more important than the safety of our children?

Remember that this situation has existed for more than 20 years, and is progressively worsening. In view of this fact, we do not feel that you can move fast enough. We need positive action NOW.

In reply to a question raised at our last presentation to Council which was 'Where would we as a committee like this overpass to be located?' - We are not professionals, therefore we have been in contact with the firm of Arthur Erikson, Architect. Mr. Erikson was not personally available, however, his colleagues, Mr. Gardiner and Mr. Bowman, the structural engineer, have viewed our intersections today.

At this time we would like to invite you to call us on Pat Burns talk show on CJOR tomorrow night, December 7th, at 10:20. Mr. Burns would be delighted to introduce you by name, and hear your comments on this situation.

Mr. Jack Wasserman of the Vancouver Sun expressed interest in our campaign for a safe crossing.

I would be pleased to answer any questions you might have to the best of my ability."

### NOTICES OF MOTION

a) Alderman B.M. Gunn Re: Noise By-law Enforcement for Motor Vehicles

- 4) Staff report to Council by January 15, 1977 on a specific programme so that such programme can be considered in the 1977 Budget."

b) Alderman B.M. Gunn Re: Motor Vehicle Ticketing for Noise By-law Infractions
