On August 3, 1976, a report to Council advised that the Course on Burnaby Municipal Government which was offered to the public during the spring of this year was extremely successful. Students who attended the course felt that they had gained a practical knowledge of their local government and there is no doubt that members of staff who provided instruction found it to be a highly rewarding experience.

Council on August 3 adopted the following recommendation:

"THAT approval be given to have the course on Municipal Government offered again during the winter quarter, 1977, with the understanding that a further report will be submitted to Council when preparations have been completed."

We are now in the final stages of preparing for the next course. An outline has been developed and referred to the School District for use as a publicity item. The course will also be advertised in the Information Burnaby Newsletter and by the District in local newspapers. Registration is expected to commence in early January.

An outline showing the content and the dates on which sessions will be held is attached. Some students from the first class made several worthwhile suggestions for improvement and these are reflected in the outline. The content for the School District's sessions 5, 6 and 7 is tentative and subject to change. No changes are anticipated for the sessions that involve Municipal participation.
