USE OF AVALON AVENUE FOR PARKING IN CONNECTION WITH AN EQUESTRIAN EVENT

Appearing on the agenda for the September 7, 1976 meeting of Council is a request from Cathy Utley, Manager for the Burnaby Horsemen's Association, for permission to use Avalon Avenue for the parking of horse vans and trailers on Avalon Avenue in connection with a trophy show on September 17, 1976. Following is a report from the Municipal Engineer on this matter.

RE: REQUEST FROM THE BURNABY HORSEMAN'S ASSOCIATION TO PARK HORSE VANS AND TRAILERS AND TO USE HORSES ON AVALON AVENUE ON SEPTEMBER 12, 1976

Section 2A of the Burnaby Street and Traffic Bylaw #4299 states as follows.

"No person shall ride or walk a horse

(a) on any sidewalk, walkway or boulevard; and,

(b) on Avalon Avenue in the 9100 Block."

Item (b) of this Section of the Bylaw was introduced on the direction of Council in March of 1972 as a result of the Manager's Report to Council at its meeting on February 21, 1972 regarding horses on Avalon Avenue (copy attached).

Due to the existing design of the 9100 Block Avalon Avenue which is paved with a 20 foot interim capped pavement and literally no shoulder which will not provide for legal parking, and in view of the existing Bylaw, this request should be refused.

RECOMMENDATIONS:

- 1. THAT the Burnaby Horseman's Association be denied the request to park horse vans and trailers on the 9100 Block Avalon Avenue; and,
- THAT permission be granted to the Association to park horse vans and trailers on Avalon Avenue west of the west property line of 9105 Avalon Avenue; and,
- 3. THAT the R.C.M.P. be advised of this report; and,
- 4. THAT Cathy Utley, Manager Burnaby Horseman's Association, be advised accordingly.



16. Re: Restriction of Horses on Avalon Avenue Bylaw #5859
(Item 18, Report No. 11, February 14, 1972)

Municipal Bylaw #5859 prohibits the riding of horses on Avalon Avenue. This bylaw was enacted by Council at the request of the Burnaby Parks and Recreation Commission in order to reduce the possibility of conflict between the members of the Burnaby Horsemen's Association who operate a stable on municipal property at 9080 Avalon and the residents of the 9100 block Avalon.

Bylaw #5859 as it is presently worded prohibits the walking or riding of horses "on any part of Avalon Avenue". The only area where conflict with local residents can occur is in the 9100 block.

At its meeting of February 16, 1972, the Parks and Recreation Commission concurred with the Administrator's suggestion that the above Bylaw be amended so that Section 2A (b) apply only to the 9100 block Avalon Avenue.

RECOMMENDATION:

THAT the necessary bylaw amendment be brought forward.
