The results of these evaluations will be available shortly and we will advise Burnaby and request agreement for cost sharing on any new pedestrian signal installations which are proposed.

To avoid any misunderstanding I wish to advise that no overall study of the Kingsway signal system is being undertaken by this Ministry and we will not be making any major proposals. Our approach is to monitor operation of individual intersections and to take local action as necessary.

The first set of Hearings will be held in December and the remainder in the early months of 1978. The Union of British Columbia Municipalities Executive has advised the Committee that it will present a brief towards the end of the Hearings, probably in May 1978.

While the Union of British Columbia Municipalities' brief will be directed towards the evaluation of the concept of regional district government and will only consider the broad picture, it is recognized that individual regional Boards and municipal Councils will probably be submitting briefs of a more specific nature, relating to their knowledge of Municipal and regional matters.

It would greatly assist the Union of British Columbia Municipalities Executive in its considerations if copies of such individual submissions to the Committee could be forwarded to the Union of British Columbia Municipalities office. In addition, further comments on any aspect of regional district functions, responsibilities and operations would be of value and interest to the Union of British Columbia Municipalities even if particular municipalities or regional districts do not intend to make a formal submission to the Committee.

i) Union of British Columbia Municipalities, Executive Director, RE: Conflict of Interest Proposals

A letter dated November 29, 1977 was received enclosing a report on the matter of Conflict of Interest which has been adopted by the Union of British Columbia Municipalities Executive and submitted to the Minister of Municipal Affairs and Housing.

The Telecommunication Workers Union requested that Burnaby Council endorse their initiative to get 10,000 British Columbians back to work. The disruption to the communications, the loss to provincial and municipal coffers and to business has gone on long enough. Every day means a half a million dollars lost.

q) North Fraser Harbour Commission, Port Manager, RE: Proposed Channel Improvements - South Arm -Fraser River

A letter dated December 2, 1977 was received regarding proposed channel improvements in the South Arm of the Fraser River. The Port Manager advised that Council's inquiry had been referred to the Commissioners' Engineers, the Department of Public Works, Canada who had provided the following information:

'This Department certainly gives assurance that sufficient study is being undertaken to verify that flood levels, sedimentation, salt-wedge intrustion, discharges and water quality will not be adversely affected in the North Arm as a result of the proposal. Most of this work is completed through studies conducted for the Department at Western Canada Hydraulic Laboratories. However, all these factors will be covered in an Environmental Impact Statement which the Department is in the process of arranging at the present time. All interested parties will have ample opportunity to provide their input during the preparation of the Impact Statement and due notice will be given for this purpose.'

r) New Westminster and District Chamber of Commerce,
Manager, RE: North Road and E. Columbia Street widening

A letter dated December 1, 1977 was received concerning the proposed widening of North Road and East Columbia Street from Braid Street in the South to the #1 Freeway in the North.

A letter dated December 1, 1977 was received advising that the Minister was very concerned with the problems in connection with the establishment of Neighbourhood Public Houses and the operation of these premises after they had been completed. They have caused the local citizens, police departments, and this Ministry a lot of concern. It is the Minister's intention to review the regulations and guidelines surrounding the location and operation of these premises with the object in mind of reducing as much as possible the detrimental factors.

The Province is deeply concerned over the tremendous problem of alcoholism, drinking drivers and alcohol related crimes. These are factors which will also be considered when formulating any new regulations or policies on licensing.

t) New Vista Place Residents' Association, Secretary, RE: Traffic Light at the corner of Edmonds Street and Mary Avenue

A letter dated December 7, 1977 was received requesting the installation of a traffic signal at the corner of Edmonds Street and Mary Avenue. This is a very busy and dangerous crossing and the Association hoped that this will be worked on as soon as possible. There are over 400 seniors in two high rise apartments here as well as school children who use this crossing. This should not be put off until there is someone killed there.

"Parking tickets are not filed by area; therefore, to obtain accurate statistics, it would entail a physical check of each ticket. Because of the manhours involved, I am confident that Council does not wish us to go into that depth of research.

We did speak to the Municipal Patrolmen and they estimate that the tickets probably would average one per day since that period. Therefore, in round figures, we would be speaking in the vicinity of 500 tickets being issued for infractions on the Municipal Hall parking lots."

The Municipal Manager reported that 90% of the total tickets issued in the main lot are for violation involving visitors who park in stalls that are reserved for senior members of staff. As this is clearly an unacceptable situation, a relocation of the assigned stalls is now under review. This and other minor improvements that are being considered (such as signing) should enable visitors to clearly perceive where they are required to park immediately upon entry to the lot. We do not recommend the rescinding of the by-law.

The schedules shown in this report speak of a Burnaby share as being 35%, but we are looking forward to a 70-30 split if we can negotiate it. It may be, however, that the Province will want to relate our costs to that of a clerk typist, space rental and maintenance of equipment, in which case our share would turn out to be closer to 35%. If we can convince the Province to fund 70% of the total program, we will endeavour to do so.

There is no provision in the 1978 Provisional Budget for this program, so if it is approved, we have to provide for it at the time of the Annual Budget.

The Medical Health Officer reported that we have a group of citizens well known for their community spirit in Burnaby — the Burnaby Chapter of the Victorian Order of Nurses, who are prepared to fund up to \$30,000. for the sound proof room and special equipment required, in tribute to the services offered by them. They feel they would like to contribute this money to a programme which will carry on the tradition of service of the Victorian Order of Nurses, and have voted unanimously to do this. At this point they are in correspondence with the Registrar for Societies in Victoria to enable them to transfer the necessary funds for this purpose.

The Municipal Manager recommended:

- 1. THAT the proposal from the Minister of Health to develop a Hearing Conservation program on a preferable 70-30 total cost split be accepted.
- 2. THAT the Medical Health Officer be authorized to proceed with negotiations with the Ministry of Health to prepare for the introduction of this Program.
- 3. THAT Council express its sincere thanks to the Burnaby Chapter of the Victorian Order of Nurses for their most generous contribution to the proposed Hearing Conservation program in Burnaby.

#### 30. 1978 Provisional Capital Improvement Program

The Municipal Manager provided the 1978 Provisional Capital Improvement Program. This document will receive further scrutiny from the Manager prior to the submission to Council of the 1978 Annual General Budget.

Also included in the 1978 Provisional Capital Improvement Program is a list of Local Improvement Works which has been approved by Council, but which has yet to be initiated. The Assessment Authority is in the process of preparing the rolls for us, but they are very busy just now. The success or failure of the initiation process will have a significant bearing on the C.I.P., and the end result will be reflected in the 1978-1983 Capital Improvement Program when it is submitted in April or May of 1978.

The 1978 Provisional Capital Improvement Program is submitted for the study of Council, so that it can be reviewed at the same time that the 1978 Provisional Budget is considered. If adopted, it will form a guide for the staff which can be used for planning purposes. Specific authority will be requested from Council if it is necessary to advance any portion of the Program prior to its final adoption as part of the 1978-1983 Capital Improvement Program which by statute must be adopted by May 15, 1978.

The Municipal Manager recommended:

1. THAT the Council table the 1978 Provisional Capital Improvement Program and consider it immedately after it has adopted the 1978 Provisional Operating or General Budget, and vary it as deemed necessary to complement the 1978 Provisional General Budget as finally adopted by Council.
