ENQUIRIES

Alderman Ast

Alderman Ast raised the question of the dangers facing residential areas around oil refineries in Burnaby with regard to fire, explosions, etc.

Alderman Ast noted that a recent incident had occurred in Nanaimo and much smaller storage tanks were involved in that instance than is the case in Burnaby.

Alderman Ast suggested that staff review with oil refinery officials what they are doing regarding fire protection and surveillance.

His Worship, Mayor Constable advised that staff are already preparing a report on this subject which should be available to Council in the near future.

The Municipal Manager reported that staff had already completed a preliminary view of this question but that the report could be in greater depth if Council so directed.

Alderman Stusiak suggested that the staff report on this subject also look into the validity of the Municipality making a contribution to the Vancouver fire boat.

Alderman Lewarne

Alderman Lewarne requested that His Worship, Mayor Constable clarify comments attributed to him on local radio regarding possible legal action against the Provincial Government in connection with the Oakalla lands lease.

His Worship, Mayor Constable replied that last Wednesday or Thursday, the Honourable Minister of Highways and Public Works made a statement in the House that there was no legality to a commitment that is contained in a document that the Mayor had signed on behalf of the Municipality. The news media had contacted the Mayor on Friday morning and enquired what the Municipality's position was in this particular case. The Mayor stated that he had advised the media that if the Minister of Highways and Public Works had made a statement to the fact that he doubted the legality of the documents that the Municipality had, then the Municipality would have to look at its legal position and may have to take legal action.

The Mayor further advised that he had requested the Municipal Manager to have the Municipal Solicitor draw up a comment on that particular statement by the Minister of Highways and Public Works in order that Council will then be in a position to decide what course of action to follow.

Alderman Ast

Alderman Ast noted that a recent news report had indicated that the Surrey zoo was closing and animals would be available. Alderman Ast noted that in the Deer Lake Development proposal provision was made for a hobby farm or similar development on the upper portion of the Oakalla lands and suggested that His Worship, the Mayor investigate the possibilities of obtaining animals from the Surrey zoo to stock this farm.

The Director of Planning advised that he had received a letter from the Municipal Programs Engineer of the Department of Highways dated August 10, 1977 in which it was advised that it now appears that it may be another couple of months before that Department would be in a position to advise on the proposed crossing of the Fraser River at Annacis Island.

The Department of Highways advised that they appreciated the advice they had received from the Municipality regarding proposed changes in the vicinity of the projected alignments and would appreciate the Municipality continuing to advise of changes which might increase the cost of right-of-way acquisitions.

7. Neighbourhood Improvement Program Development Plan Mary Avenue Park

The Municipal Manager provided a report from the Parks and Recreation Administrator regarding improvements to Mary Avenue Park.

The Municipal Manager recommended:

- 1. THAT Council approve the proposed concept plan for Mary Avenue Park with the amendment that the word "bicycle" be removed from the "blocktop bicycle path" leaving this path open for use by pedestrians and/or bicycles.
- 2. THAT Council endorse the improvements outlined for Mary Avenue Park under the terms of the Neighbourhood Improvement Program at a cost not to exceed \$ 100,000.

8. The Richmond Park/Eastburn Recreation Centre
Development Plan
Eastburn Neighbourhood Improvement Program

The Municipal Manager reported that over the past two months the Parks and Recreation Commission and the Eastburn Neighbourhood Improvement Program Resident Planning Committee have worked together with Planning and Parks and Recreation Department staff to prepare an Eastburn Community Facility proposal which met the Community's slated Neighbourhood Improvement Program objectives and the Parks and Recreation Commission's plans for Richmond Park.

The Municipal Manager provided a report from the Parks and Recreation Administrator in this respect.

The Municipal Manager recommended:

- 1. THAT the proposed floor space requirements and program outlined in Attachment B be approved in principle.
- 2. THAT the phasing and cost of the recreation centre as outlined in Attachment C be approved in principle; and the staff be authorized to take the necessary steps to have the Parks 1971 By-law No. 6020 amended through an Order-in-Council to allow the expenditure of \$ 400,000. on the construction of the first phase of the recreation centre.
- 3. THAT the Land Agent be authorized to commence negotiations for the purchase of the properties required immediately, as shown on Attachment D.
- 4. THAT the Chief Building Inspector be appointed as Project Coordinator for the construction of the recreation centre.

MOVED BY ALDERMAN LAWSON: SECONDED BY ALDERMAN LEWARNE:

9. Burnaby Lake Sports Complex
Proposed Pedestrian Bridge over Kensington Avenue near Sprott Street

The Municipal Manager provided a report from the Director of Planning on the proposed construction of a pedestrian bridge over Kensington Avenue.

The Municipal Manager recommended:

- 1. THAT design and construction of the pedestrian bridge be a municipal responsibility.
- 2. THAT the Municipality share 1/5 of the costs for design and construction of the pedestrian bridge.
- 3. THAT 4/5 of the cost of providing the pedestrian bridge at this location be raised by a Development Levy for all new privately funded construction within the benefiting area and that the requisite contribution be based on 1980 costs at 12.40¢ per gross square foot of building area, with construction costs to be reassessed and adjusted upwards from time to time in accordance with existing estimated costs of construction.
- 4. THAT the Municipality include within its 5-year Capital Improvement Program funds to undertake construction of the pedestrian bridge.
