The 1977 Provisional Budget, as approved by the Parks and Recreation Commission, includes the following Grants:

Burnaby Art Gallery Association - \$62,700 Burnaby Arts Council - 9,900 Century Park Museum Association - 87,345

These grants are made to the Associations to assist them with the administration of the facilities and are the same amounts as granted in 1976. Any amendments will be made by the Commission at the time of the Annual Budget preparation and further payments to the Associations will be adjusted accordingly.

In addition to the above regular grants, the Commission at its meeting of May 19, 1976, approved an extraordinary grant to the Burnaby Art Gallery Association in the amount of \$5,000 to cover the salary of the Education and Extension Co-ordinator at the Art Gallery for the period January 1, 1977 to May 31, 1977. This was to enable the Gallery to continue with its education program. The Gallery is providing the salaries for two other employees from other sources.

It has been the practice in the past to advance a quarter of the grants prior to approval of the Annual Budget to cover the period January 1st to March 31st. The advances are made on the understanding that they are "advances" only and do not necessarily represent one-quarter of what the final grant may be.

At its meeting of January 12, 1977, the Parks and Recreation Commission approved payment of advance grants as follows:
