

THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 7014

A BY-LAW to amend By-Law No. 3325, being the "Burnaby Waterworks Regulation By-Law 1953".

The Council of The Corporation of the District of Burnaby ENACTS as follows:

1. This By-law may be cited as "BURNABY WATERWORKS REGULATION BY-LAW 1953, AMENDMENT BY-LAW NO. 2, 1977".

2. Section 15 of By-Law No. 3325 is repealed and the following substituted therefor:

"15. (1) Subject to section 16, all water service shall be metered except service to

(a) single-family residences whether detached or within a multiple-family building used exclusively for residential purposes,

(b) commercial premises comprising not more than three stores or offices without living quarters,

(c) commercial premises comprising not more than three stores or offices and living quarters for one family only.

(2) All meters shall be supplied and installed by the District. All costs of supplying and installing a meter shall be at the sole risk and expense of the owner of the land being or to be supplied with water and shall be paid to the District by the said owner upon demand."

3. Those parts of Schedule "A" of By-Law No. 3325 under the heading "Flat Rates" and "Monthly Meter Rates" are repealed

and the following substituted therefor:

"FLAT RATES

(1) A detached single-family residence shall pay an annual charge of \$42.00.

(2) A commercial premises comprising not more than three stores or offices and living quarters for one family only shall pay an annual charge of \$84.00.

(3) A commercial premises comprising not more than three stores or offices without living quarters shall pay an annual charge of \$42.00.

(4) A single-family residence within a duplex shall pay an annual charge of \$31.50.

(5) A single-family residence within a multiple-family building (not including a duplex) used exclusively for residential purposes shall pay an annual charge of \$19.00.

MONTHLY METER RATES

(1) For the first 10,000 cubic feet used, 36¢ per 100 cubic feet per month.

(2) For the next 20,000 cubic feet used, 25.2¢ per 100 cubic feet per month.

(3) For the next 50,000 cubic feet used, 19.7¢ per 100 cubic feet per month.

(4) For the next 420,000 cubic feet used, 17.3¢ per 100 cubic feet per month.

(5) For all water used in excess of 500,000 cubic feet, 15¢ per 100 cubic feet per month.

(6) The minimum monthly charge for water supplied shall be \$3.50."
