Re: PRODUCTIVITY MEASUREMENT AND IMPROVEMENT COURSE SAN FRANCISCO, CALIFORNIA - JUNE 20/22, 1977

The subject course, which was offered earlier this year in Seattle but then cancelled, is now being offered in San Francisco on June 20, 21 and 22, 1977. As this course is specifically designed for law enforcement personnel who are directly responsible for budgetary preparation, control and accountability of performance, it is particularly appropriate for the Officer-in-Charge, Burnaby Detachment, R.C.M.P. to attend. Attached is his request for authorization to do so.

Because of the timing involved, the Municipal Manager gave the Officer-in-Charge approval to attend the course which started to-day. Council is now being informed of this matter with a request to ratify the action that has been taken.

The agenda for the course includes workshops and talks by experts in the fields of law enforcement, criminal justice and evaluation design and measurement techniques. It will also provide the Officer-in-Charge with an opportunity to share information of a mutual interest and concern with officers from a number of other jurisdictions.

## RECOMMENDATION:

1. THAT the action taken by the Municipal Manager to have the Officer-in-Charge, Burnaby Detachment, R.C.M.P. attend the Productivity Measurement and Improvement course in San Francisco on June 20, 21 and 22, 1977 be ratified.
