"My request for the subject licence to operate a Boat Top repair and recovering business was rejected by the Licence Inspector for need of clarification. Upon going before the Board of Variance, clarification was given and the decision to allow a licence to be granted to me.

However, the Chief Licence Inspector has now rejected the issuance of the Licence, feeling that further clarification be given regarding the term 'stock-in-trade' on the premises.

I point out that because all recovering jobs and repair jobs that I would do to the boat top are of a strict custom nature, I am unable to produce a recovering job and hold in stock for sale. I submit to you that those materials I use in the business; i.e., zipper, dome fasteners, recovering material, etc. are in fact of no use to a customer until I have refashioned them to suit the customer's needs. As a result you will see I cannot have a finished product inventory. Thus I have no 'stock-intrade' on the premises.

I therefore request the Mayor and Council to rule a licence be granted and instruct the Chief Licence Inspector to issue same."

Alderman Lewarne noted correspondence received from the Burnaby School Board under date of April 18, 1977 wherein a request was made by the Board to the Municipality to have two additional lights installed on Municipal Property, one at each end of the Mall between Royal Oak and Marlborough Schools.

The Municipal Engineer advised that he would investigate the matter.

Since that time I have had at least one meeting and several telephone discussions with the Minister of State, Urban Affairs, Canada - The Honourable Andre Ouelett, and have also corresponded with him, copies attached.

In view of the contents of the letter dated April 12, 1977 from The Honourable Andre Ouelett, I would recommend to Council:

- a) that Item 4 of the Manager's Report No. 69, Council Meeting November 1, 1976 be lifted from the table;
- b) that Council concur in the recommendations from the Director of Planning on the George Derby lands."

"WHEREAS Section 72(3) of the Municipal Act provides:

'Every ballot paper shall contain a list of the full names of the candidates arranged alphabetically in the order of the surnames or, if there are two or more candidates with the same surnames, of their Christian or given names, and shall show the occupation of each candidate';

AND WHEREAS it is considered by those that stand for office that there is an advantage to be listed first on the ballot paper;

AND WHEREAS many of the States and Municipalities in the United States of America and many Municipalities in Canada provide for draws for position or for alphabetical rotating order on the ballot paper;

THEREFORE BE IT RESOLVED that the Union of British Columbia Municipalities petition the Provincial Government to amend the Municipal Act to allow for the option of position on the ballot paper by alphabetical order or by draw selection as desired by the municipality concerned."

It was recommended that Council re-endorse the subject resolution and forward it to the Minister of Municipal Affairs to request that the Municipal Act be amended accordingly.
