Re: B.C.I.T. STUDENT UNION BUILDING PUB NIGHTS - PARKING AND NOISE (Item 9, Report No. 11, February 14, 1977)

On February 14, 1977, Council received a letter from Mr. J. P. Daem of Conse-C Enterprises Ltd. regarding noise and other disturbances directly related to pub nights at the B.C.I.T. Student Union Building. The report that Council also received on that occasion advised that the matter was under investigation. Comments on the conclusion of that investigation are contained in the following report from the Chief Public Health Inspector.

Further to our progress report of February 14th, 1977, relating to the above-noted subject, we would submit the following as a final report.

Mr. Dickson Melville, Director of Public Relations, B.C.I.T., Miss Sharon McElroy, President, Student Council, B.C.I.T., and Mr. Philip Henderson, Business Manager, Student Association Centre, did fulfill their agreement to restrict vehicular parking to the areas adjacent to Willingdon Avenue. This action was successful in reducing noise level emissions in the area of the Student Union Building with the exception, according to Mr. J.P. Daem, President, Conse-C Enterprises Ltd., of the nights of March 17, 18 and 19, 1977. Mr. Daem sets forth the particulars in his letter of April 19th, 1977, which is attached for your information.

We were not aware of noise complaints on the nights of March 17, 18 and 19, 1977, but upon receiving the information from Mr. Daem, we checked with the officials of the British Columbia Institute of Technology and were advised that at this time "Open House" was being held at the Institute. As approximately 38,000 people attended this function, we would believe there was a considerable increase in noise level emission, during the occasion. It is our understanding that "Open House" is held once every two years and it is our intention to discuss, over a period of time, a noise control program for this or any other function which would result in a large congregation of motor vehicles. We would caution that any such gathering of motor vehicles, even with controls, will result in an increased noise level emission; fortunately in such cases, it will be of short duration.

In conclusion we would state that it is our opinion, based on discussion with officials of the British Columbia Institute of Technology and Mr. Daem, Conse-C Enterprises Ltd., that the noise level emission, through collective effort, has been greatly reduced with the exception of the nights of March 17, 18 and 19, 1977.
