Tenders were received at 3:00 p.m., September 20, 1977, and opened in the presence of tendering contractors by Messrs. R.J. Constable and J.R. Hagen of the Purchasing Department. Present also at the opening was John Currie of the Architect's office, and the undersigned.

A tabulation of the tenders has been prepared by the Purchasing Agent and is <u>attached</u> hereto. The low tender was submitted by Dogwood Construction Ltd. in the amount of \$168,250. This tender includes the costs of sewer and water services, but does not include the cost of B.C. Hydro gas or electric services on Nelson Avenue Diversion, since these costs have not yet become available from B.C. Hydro. The comparable estimate of costs made prior to the call for tenders, including sewer and water services but excluding Hydro services, was \$188,450, being the original total building estimate of \$208,450 less B.C. Hydro service allocation cost of \$20,000.

Dogwood Construction Ltd. have been in the general contracting business for a number of years and regularly tender on public construction projects, for example, school construction. This firm was recently successful in tendering on school construction in Surrey designed by Ronald B. Howard, Architect.



The architect's estimate for the project was \$186,710.00



The tender submitted by Dogwood Construction Ltd. on the above project has been reviewed by my office and consultants. The bid was also discussed with Dogwood Construction Ltd. who confirmed their satisfaction with their price. Dogwood Construction Ltd. is a small established contractor active in the institutional field and has completed a number of school projects for our firm with relative success. The tender appears in order and it is recommended that a contract be entered into with the low bidder.

A summary of the contract amounts and related works is as follows:

We suggest that a sizeable contingency sum be carried until the completion of the work because of the unusual nature of the site.

Please also note that the mechanical subtrade is unknown to our firm and D. W. Thomson Consultants and that no comment is available on their (Burns Mechanical) capability in the short period of time available. It is felt that as the Municipalities contract is with Dogwood Construction Ltd. and a Performance Bond is required that the matter is not of significant consequence.
