Further to the letter as received from Mrs. V. Johnson, 8030 Sussex Avenue, Burnaby, regarding, among other things, the above-noted subject we would advise as follows.

## (1) Ditch

Our investigation did not reveal anything in the way of odour or litter, but there was some weed growth; in our opinion not enough to obstruct the flow of water due to the gradient in this particular location. The ditch was dry at the time of inspection.

## (2) Easement

The pertinent easement is situated at a much lower level than the complainant's property and forms a portion of the adjacent property to the south, addressed as 8050 Sussex Avenue. This property is owned by Mr. and Mrs. K. Graham, who have resided here for 22 years. We have examined the condition of this easement, including the possibility of a rodent infestation, and have not encountered anything that would contravene the Unsightly Premises By-law or other Health Regulations to an extent that would necessitate action on the part of this Department. We have, however, discussed the situation with Mr. Graham and have asked for his co-operation in cutting a few weeds contained on the easement and a minor tidying of some automobile parts that belong to an Edsel car (collector's item) being restored by Mr. Graham's son.
