Re: Strongly Object to Government's Move in Putting
up 2.5 Million for the overpass of the Burlington
Northern and the Lougheed Highway

Correspondence under date of February 16, 1977 directed to Mr. Marke Raines, M.P. was received indicating their objection to the Government's move in putting up 2.5 million dollars for the overpass of the Burlington Northern and the Lougheed Highway, and further indicating that they were not satisfied with the location of this proposed overpass.

g) Mrs. Margaret Strand
Re: Grant to help build an overpass at Kensington Avenue
and the Burlington Northern Railway Tracks

A copy of correspondence directed to Mr. Marke Raines, M.P. was received indicating her astonishment on seeing an article in the Vancouver Sun on February 13th announcing a 2.5 million dollar grant to help build an overpass at Kensington Avenue and the Burlington Northern Railway Tracks in Burnaby and protesting the action of the Federal Government in this instance.

The Municipal Manager reported as follows:

"Appearing on the agenda for the February 28, 1977 meeting of Council is a letter from Mrs. Margaret Strand to Mr. Marke Raines, M.P. with a carbon copy to Council, regarding the grant that has been received by the municipality for construction of the Kensington overpass.

For the record, it should be pointed out that the municipality has never acted in a surreptitious manner with respect to the application for a grant which incidentally, was made in 1975, well before the formation of the Kensington Home Owners' Association. We are well aware of the concerns of the Kensington residents, and as a result, are maintaining a well established line of communication with the Kensington Home Owners' Association. In fact, we will be discussing the question of alignment and other matters with the Association in the very near future.

When the Municipality places a Money By-law before the electorate, it does so for the purpose of asking voters to approve the borrowing of funds so that a specific project or projects can be undertaken.

It would be appropriate to send Mrs. Strand a copy of the report on the overpass project that Council received last week."

## MOVED BY ALDERMAN LAWSON: SECONDED BY ALDERMAN STUSIAK:

"WHEREAS The Corporation of the District of Burnaby has had one of the most efficient Human Resources Departments in the Province of British Columbia for over twelve years;

AND WHEREAS Burnaby's Human Resources Department is one of the most effective in the Province of British Columbia in terms of service to people in need of assistance for finances, counselling or encouragement;

AND WHEREAS the staff of Burnaby's Human Resources Department has one of the highest morales in the Province of British Columba because of their efficiency, effectiveness and ability to provide service to people in need;

AND WHEREAS the Burnaby Human Resources Department operates from a centralized location with specifically designed office layout based on many years experience of the senior staff and is able to co-ordinate services within the governmental system such as family service, public health, parks and recreation, probation, child welfare and R.C.M.P. - these services are also located in our centrally located civic core area:

AND WHEREAS the Provincial Government Department of Human Resources intends to take this efficient and effective service and decentralize the system into three separates offices away from other supporting and co-ordinating services;

AND WHEREAS members of this Council and its management team have no record of specific complaints about the location of the office as it relates to its effectiveness in delivery of service;

AND WHEREAS the tax-payers of the Province of British Columbia will have to pay a higher tax bill for the three separate offices;

AND WHEREAS it is an injustice to the people of this municipality who require the services of the Human Resources Department to change an effective and efficient service that works so well for them;

AND WHEREAS Burnaby has had a decentralized delivery system twenty years ago that was changed to a centralized delivery system in order to give the people in need of that Department's assistance a much improved service;

### THEREFORE BE IT RESOLVED:

THAT the Premier of the Province of British Columbia be asked to delay implementation on the decision on what appears to be a Provincial policy on decentralization and specifically a decision by the Provincial Department of Human Resources to decentralize Burnaby's Department of Human Resources into three separate offices from the present central location with its efficient and effective delivery service and its ability to co-ordinate and co-operate with other centrally located services such as family service, public health, parks and recreation, probation, child welfare, and R.C.M.P., which are located in our central civic core area and with its reputation as one of the most effective and efficient departments with a high staff morale in the Province of British Columbia and to meet with representatives of the Council of Burnaby, with a copy of the foregoing resolution to be forwarded to the Minister of Human Resources".

#### CARRIED UNANIMOUSLY

Council also directed that a copy of the foregoing resolution be also forwarded to the three members of the Legislative Assembly for Burnaby.

On a question of Alderman Randall, the Municipal Manager advised that a reply would be forthcoming on the question of whether the Provincial legislation had been changed in regard to existing restriction upon beer parlour operators with respect to the serving of hard liquor.

This was in reference to correspondence received from the Alcohol-Drug Education Service.

On a further question of Alderman Randall, the Municipal Manager advised they would have to report on the question of the apparent 22% reduction in assessments to condominiums in the Burnaby area.

Alderman Lewarne enquired as to the current position of restitutional sentencing in Burnaby. Is it still in effect and how many times has it been used by the Courts.

It was requested that Mayor Constable look up a past resolution submitted to the U.B.C.M. on this particular subject matter for possible resubmission.
