COMMENTS ON CRIME TRENDS AND POLICING PROBLEMS:

Major incidents during the month included a charge being laid after an investigation into an attack by an adult male upon a friend. There was evidence of considerable drinking preceding incident.

After investigations into 5 separate reports of rape, 3 were classed as "unfounded". No charges have been laid to date.

Six juveniles were found responsible for a total of 38 Breaking & Entries, 23 of which were committed in 1976. A second group of 3 juveniles were found responsible for 19 B. & E.'s.

The six armed robberies being investigated included a taxi driver being robbed by his passenger. One armed robbery of a person resulted in the arrest of three subjects. Two attempted robberies remain unsolved.
