a) Mrs. Pixie McGeachie advised Council that she was the Chairman of a Special Committee within the Century Park Museum Association consisting of herself, Mr. Fraser Wilson and Una Carlson. Mrs. McGeachie drew to the attention of Council the fact that the year 1978 is the 150th Anniversary of Robert Burnaby's birth and the 100th Anniversary of his death.

In view of this, the Special Committee would like to ask for Council's aid and co-operation in the forming of a broad community committee with representation from Council to promote the marking of this dual anniversary.

In appreciation of Burnaby's heritage, the special committee considered that this is an opportune time to bring to the attention of all our citizens the history of our municipality. The Committee also felt that the students of all levels of education in Burnaby would benefit from participation in this historical event.

Mrs. McGeachie presented a broad outline of the activities which the special committee considered would be appropriate to the marking of this dual anniversary. One of the suggestions provided was that a commemorative pamphlet be provided to all students in Burnaby schools in 1978 which would contain a digest of the research materials available on Robert Burnaby's career.

Mrs. McGeachie noted that the Committee had not given any consideration to a budget for the planned observation of the birth and death of Robert Burnaby. Mrs. McGeachie considered that, with the Special Committees limited membership, no further detailed planning could take place at this time.

The Committee envisioned a "Robert Burnaby Week" when many Burnaby organizations such as the Burnaby Chamber of Commerce, Girl Guides and Boy Scouts and service organizations and businesses would participate in any way they might choose to do so.

However, the present volunteer committee of three members cannot possibly carry through the planning and execution of the type of community celebration which the Committee envisages. A larger Committee such as the 1971 Centennial Committee with representation from Council and Community organizations and enthusiastic individuals is needed and Mrs McGeachie requested that Council be instrumental in forming such a Committee as soon as possible so that plans to mark this particular historical event can take a definite form.

c) British Columbia Hydro and Power Authority, General Manager, Transportation RE: All Changes Planned For Transit Services Within Burnaby During The Forthcoming Months.

A letter dated September 22, 1977 was received outlining all changes planned for transit services within Burnaby during the forthcoming months. It was pointed out that the three Vancouver City services which directly impact the Municipality of Burnaby (9-Broadway, 14-Hastings and 19-Kingsway) have not been altered with this program. Service on these lines will continue to operate until the 3:10 a.m. departure from Downtown Vancouver.

It was advised that the 41-Forty-First Service was extended east of Joyce Loop to Burnaby on October 29, 1976. Since that time we have had almost a full year of operational experience with this route and, in keeping with our policy on all new services, adjustments will be made at the end of the one year period in reaction to demonstrated public usage. Generally, ridership usage on this extension has been considerably below our expectations, especially during the evenings after store closing time. No change in daytime service frequencies is planned for this route. However, three evening weekday trips from Burnaby are slated for discontinuation. These trips are the 10:13 p.m., 10:43 p.m., and 11:13 p.m. trips leaving Kingsway and Nelson Avenue. On Saturdays the last trip will leave Kingsway and Nelson at 5:33 p.m. instead of 11:13 p.m.

Item 9, Municipal Manager's Report No. 67, 1977 pertaining to this subject was brought forward for consideration at this time.

The Municipal Manager recommended:

That the Finally developed plan will contain the essential elements and good concept presented in Action '78.

THEREFORE BE IT RESOLVED that The Corporation of the District of Burnaby shall provide ONE MILLION DOLLARS (\$1,000,000.) toward the funding of developments at the P.N.E. as generally laid out in Action '78; and
