In reply to your recent petition for "resident parking only" signing, we would advise that such signing is not installed in Burnaby.

While you may have seen such signing in Vancouver and in New Westminster and would question why it cannot be installed in Burnaby we would point out that both of these cities hold title to their street rights of way. In Burnaby and in other cities and municipalities in British Columbia the street rights of way are in the name of the Crown. In other words they are truly public rights of way and are for the use of the general public and as such we do not have the authority to designate the public street for private use.

As Bumper's Disco has just opened we have not had time to evaluate the traffic problems that may have developed. In this regard we will be checking into the concerns of those who signed your petition to see if there is some way to assist you.
